This is case of Prior Environment Clearance for Common Bio-Medical Waste Treatment Facility for treatment of 100 kg per hour Static Kiln based bio medical incineration project at Village - Pindrai, Tehsil - Barghat, Dist. Seoni (MP). Earlier ToR letter issued vide letter No. 742 dated 06.10.2020. ToR Valid up to 05/10/2024. PP has submitted the Ammended ToR application vide letter dated 21/06/2021 which was sent to SEAC vide letter no. 1372 dated 06.07.2021.

The case was presented by PP and their consultant on 505th SEAC meeting dated 24/07/2021 for amended in issued ToR to carryout EIA studies with changing some technology pattern. PP has submitted Form-3 including all supporting documents and study report by proposing static kiln technology instead of rotary technology for incineration of bio- medical waste as per guidelines of CPCB

Committee accepted the request made by PP and recommended the case for amendment in ToR in 505th SEAC meeting dtd. 24.07.21 for installation of static kiln with dry ceramic system. Other details such as site, configuration of autoclave, shredder, ETP etc. and also directed the project proponent that all the contents mentioned in TOR dated 06.10.2020 shall remain the same.

After the recommendation the case was discussed in 682nd SEIAA meeting dtd. 26.08.2021 and accept the recommendation of 505th SEAC meeting held on dated 24.07.2021 and decided to issue ammended ToR for conducting the EIA. The conditions for ToR shall remain same as issued in letter dated 06.10.2020 and following additional information should be incorporated during preparation of EIA report.

- Details of unit located within the coverage area of the project site.
- Route chart of the districts by showing collection of Bio medical wastes for treatment by the propsed unit.
- Health Département guidelines for establishment of such units.


