"...During presentation it was observed that as per Google image inhabited area is very near to the lease area on SW side. Moreover, in the Tehsildar letter vide no. 2127 dated 11.08.21 mentioned that some kachha houses/huts are existed in the south & western side of the lease which are on Govt. Land. Considering 200 m left set back as safety zone as per NGT order in O.A. 304/2019 dated 21.7.20, the lease become non- workable. Thus considering above facts committee after deliberation recommends that under such circumstances this case cannot be considered for grant of EC and case file may be sent to SEIAA for onward necessary action..."
