The case was discussed in 104th SEIAA meeting dtd 04.09.12 and it has been recorded that

- With the permission of the Chairman the recommendation of 98th SEAC meeting dtd 23.07.2012 was considered for delisting 10 cases of biomass power plant using auxiliary fuels such as coal etc. up to 15% in view of amendment of EIA Notification dtd 01.12.2009 and no response from PP. Further the validity period of ToR for 6 cases has expired. Hence total 16 cases are summarily closed on the recommendation of SEAC.
- Letter should be sent to PP by registered post and concerned agencies for information for summarily closure of these cases. This status should be shown in SEIAA website relating to the status of these cases."

In view of above-mentioned facts, you are hereby informed that your case is summarily closed because Biomass based Power plants up to 15 MW using auxiliary fuel such as coal etc up to 15% have been exempted as per Amended EIA Notification dated 01/12/09 & no response has been received from the PP
