- (i). It is noted that as per the amendment of EIA Notification 01.12.2009 Para V (iv) (ii) it is mention that  
"In case of secondary metallurgical processing industrial units, those projects involving operation of furnaces only such as induction and electric arc furnace, submerged arc furnace, and cupola with capacity more than 30,000 tonnes per annum (TPA) would require environmental clearance."

In view of above, following **two cases** of 3 (a) category having production capacity less than 30,000 TPA are exempted from prior EC hence it is decided to **summarily close** these cases. :-
