Hence, Prior Environmental Clearance is granted for Stone Quarry in an area of 1.424 ha. (75,978 cum per annum) (Khasra No. 1084), Village - Badaura Kalan, Tehsil - Gaurihar, Dist. Chhatarpur (MP) for the lease period to Shri Nitin Agrawal S/o Shri Shyam Kishore Agrawal, R/o Mahal Road, Dist. Chhatarpur, (MP) "

Vide letter dated 19.08.2021 PP has requested to correct the lease area as mentioned in the EC letter 1.425 ha instead of 1.425 ha. PP has also submitted supporting documents including mining plan. After examined the records it was found that due to typographical error the lease area was mentioned 1.424 ha in place of 1.425 ha.
