
The Prior Environmental Clearance under EIA Notification, 2006 has been issued for the building construction project "District Court Indore of District & Sessions Court" at Village Pipliyahana Tehsil & District Indore, MP. vide letter no. 2125 dtd 01.02.19.

As per order of Hon'ble NGT dtd. 18.03.2016 "However, before parting we would call upon those concerned to consider as to whether the set back of 30 m area stipulated under clause iii(a) of the specific conditions of the EC, can be increased to at least 50meter considering the undeniable fact that during the rainy season water from the lake spreads over the allotted land. This would also be in the interest of stability of proposed Court Complex".

In compliance of the above stated directions of the Hon'ble Tribunal the matter regarding clarification of specific condition no.8 imposed by SEIAA in Environmental clearance letter dtd. 01.02.19 was discussed in 585th SEIAA meeting dtd 04.12.2019 and it is decided to issue a corrigendum as follows:

"No construction is permitted within 50 meters of FRL of catchment area of lake "should be substituted with "**No construction is permitted within 50 meters of FRL of the lake.**

The corrigendum should be read along with the original EC issued vide letter dtd 01.02.19. All the conditions mentioned in the prior EC (dtd 01.02.19) shall remain the same.


