
The case was discussed in 538th SEIAA meeting dtd 11.04.2019 and it has been recorded that.....

Earlier PP was also absent in 343rd SEAC meeting dated 19/02/2019. Committee decided that since sufficient opportunities has been given to the PP for appraisal of their case but PP remains absent thus committee decided that case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project."

As per above recommendation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.

As per above decision, the case is hereby delisted and shall be liable for relisting if PP intends to present the case in SEIAA.


