
The case was discussed in 581<sup>st</sup> SEIAA meeting dtd 14.11.2019 and it has been recorded that .....

"After discussion it was observed by the authority, PP has proposed the maximum height of the building is 45m. However layout plan submitted for 18m height. High-rise committee approval along with T & CP approval not submitted by PP. It is decided that PP should submit the building permission obtained from Indore Municipal Corporation".

In response to above it is decided to ask to submit the above information vide letter dated 11.07.2019. But PP has not submitted the desired information till date even after passing more than 3 months and therefore it has been decided to delist the case which is liable for relisting once the PP submits the information. Copy to PP and all concerned."

As per above decision, you are hereby informed that your case is delisted and liable for relisting if you intends to present the case in SEIAA.


