Committee decided that since sufficient opportunities has been given to the PP for appraisal of their case but PP remains absent thus committee decided that case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

As above decision, the case was relisted and PP called for clarification. Since sufficient time has been given to the PP for clarification but PP remains absent thus it has been decided to delist the case on the condition that if PP intends to present the case, it will then be relisted for appraisal.
