- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 2.0 ha. for production capacity of 6000 cum per annum at Khasra No. 163 at Village -Dhimroli, Tehsil -Sironj, Dist. Vidisha (MP) by Sarpanch Gram Panchyat Hargnakhedi, Janpat Panchyat Sironj Dist. Vidisha MP.
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 132/Khanii/DEIAA/18 dtd. 24.1.2018 in the name of " Sarpanch Gram Panchyat Hargnakhedi, Janpat Panchyat Sironj Dist.Vidisha MP
- (3) It is noted that PP has requested vide no Nil dtd.16.3.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " Shri Vivek Patel, R/o Patel Ward, Bakhar Kandeli, Dlst. Narsinghpur, MP - 487001." in place of Sarpanch Gram Panchyat Hargnakhedi, Janpat Panchyat Sironj Dist. Vidisha MP. "
- (4) It is noted that in support of his request the PP has submitted the following documents
 - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Shri Vivek Patel, R/o Patel Ward, Bakhar Kandeli, Dist. Narsinghpur, MP - 487001.
 - Notarised affidavit of CEO, Janpad Panchayat Sironj Dist. Vidisha MP".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC
 - Copy of Prior EC issued by DEIAA vide letter No. 132/Khanij/DEIAA/18 dtd.24.1.2018. III.
 - Copy of Environmental Management Plan of Shri Vivek Patel, R/o Patel Ward, Bakhar Kandeli, DIst. Narsinghpur, MP - 487001.
 - Copy of Approved Mining Plan with Replenishment Plan of Shri Vivek Patel, R/o Patel Ward, Bakhar Kandeli, Dlst. Narsinghpur, MP - 487001.
 - Lease transfer order issued by Mineral Resource Department order to Shri Vivek vi. Patel, R/o Patel Ward, Bakhar Kandeli, Dlst. Narsinghpur, MP- 487001.vide letter No. 723/132/2020/12/1 dated 11.2.2020.
- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
 - Para-11: A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA Vidisha on 24.1.2018 in the name of " Sarpanch Gram Panchyat Hargnakhedi, Janpat Panchyat Sironj Dist. Vidisha MP." is hereby transferred to Shri Vivek Patel, R/o Patel Ward, Bakhar Kandeli, Dlst. Narsinghpur, MP -487001.for Sand Quarry in an area of 2.0 ha. for production capacity of 6000 cum per annum at Khasra No. 163 at Village -Dhimroli, Tehsil - Sironj, Dist. Vidisha (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Vidisha (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
