- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 4.80 ha. for 72,270 cum per annum at Khasra No. 91 at Village- Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol (MP) by **Sarpanch Gram Panchyat** Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol, MP.
- (2) The Prior Environmental Clearance letter was issued **SEIAA vide L.No. 276/SEIAA/19 dtd. 18.4.2019** in the name of "**Sarpanch Gram Panchyat** Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol MP.
- (3) It is noted that PP has requested vide no Nil dtd.7.3.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely "**Vanshika Constrution, Ramlal Jhariya R/o Devri Rajmarg Dist-Narsinghpur MP-487661.**" in place of **Sarpanch Gram Panchyat** Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol MP. "
- (4) It is noted that in support of his request the PP has submitted the following documents
 - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of **Vanshika Constrution, Ramlal Jhariya R/o Devri Rajmarg Dist-Narsinghpur MP-487661.**
 - ii. Notarised affidavit of **CEO, Janpad Panchayat** Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol MP".mentioning that **no legal action/ credible action** has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA vide letter No. **276/SEIAA/19 dtd. 18.4.2019.**
 - iv. Copy of Environmental Management Plan of **Vanshika Constrution, Ramlal Jhariya R/o Devri Rajmarg Dist-Narsinghpur MP-487661.**
 - v. Copy of **Approved Mining Plan with Replenishment Plan** of **Vanshika Constrution, Ramlal Jhariya R/o Devri Rajmarg Dist-Narsinghpur MP-487661.**
 - vi. Lease transfer order issued by **Mineral Resource Department** order to of **Vanshika Constrution, Ramlal Jhariya R/o Devri Rajmarg, Dist-Narsinghpur MP-487661.**vide letter No. **1003/132/2020/12/1** dated 20.2.2020.
- (5) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 18.4.2019 in the name of " **Sarpanch Gram Panchyat** Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol MP." is hereby transferred to **Vanshika Constrution,Ramlal Jhariya R/o Devri Rajmarg Dist-Narsinghpur MP-487661.for Sand Quarry in an area of 4.80 ha. for production capacity of 72,270 cum per annum** at Khasra No. 91 at Village- Bhatgawan Khurd, Tehsil - Jaisingh Nagar, Dist. Shahdol (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**
