The case was discussed in 683rd SEIAA meeting dtd.27.08.2021 and it was recorded that...

- 1. It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 2.0 ha. for production capacity of 21822.60 cum per annum at Khasra No. 1116, 1117,1118,1123,1128 Village - Bhagora, Tehsil - Mhow, Dist. Indore (MP) by M/s Agarwal Enterprises, Shri Kalyan & Shri Abhishek Agarwal, 21-1, Dhanwanti Nagar, Rajendra Nagar, District Indore, MP.
- 2. The Prior Environmental Clearance was issued by SEIAA vide letter 2373/SEIAA/16 dated 25.09.2019 in the name of M/s Agarwal Enterprises, Shri Kalyan & Shri Abhishek Agarwal, 21-1, Dhanwanti Nagar, Rajendra Nagar, District Indore, MP.
- 3. It is noted that in support of his request the PP has submitted the following documents
 - No Objection Certificate in the form of Notarized Affidavit submitted by M/s Agarwal Enterprises, Shri Kalyan & Shri Abhishek Agarwal, 21-1, Dhanwanti Nagar, Rajendra Nagar, District Indore, (MP) for transfer of prior EC in the name of Shri Sawariya Mines Partner Shri. Pankaj Patidar s/o Shri Kailash Chandra Patidar Res. 102, Twin Tower near Dastur Garden, Scheme No 71, Indore mentioning that no legal action/ credible action has been initiated against the mine till date.
 - Notarized affidavit of Shri Sawariya Mines Partner Shri. Pankaj Patidar s/o Shri Kailash Chandra Patidar Res. 102, Twin Tower near Dastur Garden, Scheme No 71, Indore, MP mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- 4. It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA vide letter No. 2373/SEIAA/16 dated 25.09.2019 in the name of M/s Agarwal Enterprises, Shri Kalyan & Shri Abhishek Agarwal, 21-1, Dhanwanti Nagar, Rajendra Nagar, District Indore, (MP) is hereby transferred to Shri Sawariya Mines Partner Shri. Pankaj Patidar S/o Shri Kailash Chandra Patidar Res. 102, Twin Tower near Dastur Garden, Scheme No 71, Indore M.P. for Stone Quarry (Open Cast manual/ Semi Mechanized method) in an area of 2.0 ha. for production capacity of 21822.60 cum per annum at Khasra No. 1116, 1117,1118,1123,1128 Village - Bhagora, Tehsil - Mhow, Dist. Indore (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, it was decided to transfer the Prior EC in the name of Shri Sawariya Mines Partner Shri. Pankaj Patidar s/o Shri Kailash Chandra Patidar Res. 102, Twin Tower near Dastur Garden, Scheme No 71, Indore (M.P.) with the same terms & conditions under which the Prior Environmental Clearance was initially granted and for the same production capacity and validity period up to 20.01.2031.
