The case was discussed in 668th SEIAA meeting dtd 24.03.2021 and it has been recorded that

- (1) "It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 3.550 ha. for production capacity of 174000 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur (MP) by Shri Rakesh Chaurasia Tanay S/o Shri Bhagwan Das Chaurasia R/o Chaurasia Mohalla, Laudhi, Tehsil- Laudhi, Dist. Chhatarpur (MP) .
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. **1413/DEIAA/2016** dtd 24.9.2016 in the name of Shri Rakesh Chaurasia Tanay S/o Shri Bhagwan Das Chaurasia R/o Chaurasia Mohalla, Laudhi, Tehsil- Laudhi, Dist. Chhatarpur (MP) .
- (3) It is noted that in support of his request the PP has submitted the following documents

 - ii. Notarised affidavit of M/s Jai Shri Krishna Granite, Shri Sapan Agarwal, Partnerr, Gram-Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur - 471001, mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. **Copy of Prior EC issued by DEIAA vide letter No. 1413/DEIAA/2016** dtd 24.9.2016. to Shri Rakesh Chaurasia Tanay S/o Shri Bhagwan Das Chaurasia R/o Chaurasia Mohalla, Laudhi, Tehsil- Laudhi, Dist. Chhatarpur (MP) .

- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the

transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 24.9.2016 in the name of "Shri Rakesh Chaurasia Tanay S/o Shri Bhagwan Das Chaurasia R/o Chaurasia Mohalla, Laudhi, Tehsil-Laudhi, Dist. Chhatarpur (MP), is hereby transferred to M/s Jai Shri Krishna Granite, Shri Sapan Agarwal, Partnerr, Gram-Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur - for Stone Quarry in an area of 3.550 ha. for production capacity of 174000 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly."

In view of above, prior EC issued to Shri Rakesh Chaurasia Tanay S/o Shri Bhagwan Das Chaurasia R/o Chaurasia Mohalla, Laudhi, Tehsil- Laudhi, Dist. Chhatarpur (MP) by DEIAA vide letter No. 1413/DEIAA/2016 dtd 24.9.2016 is hereby transferred to M/s Jai Shri Krishna Granite, Shri Sapan Agarwal, Partnerr, Gram-Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur, MP for Stone Quarry in an area of 3.550 ha. for production capacity of 174000 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
