Ref: Proposal No.- SIA/MP/MIN/228716/2021- Case No 8716/2021: Prior Environment Clearance for **Stone Quarry** (Opencast Semi-Mechanized Method) in an area of 1.0 ha. for production capacity of 8820 cum per annum at Khasra No. 928, Village - Salon-A, Tehsil - Bhandar, Dist. Datia (MP) by Smt. Neeta Nageel residence near BS Krishi Karyalay MOG Line Indore, (MP) **Regarding Transfer of EC in the name of Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP - 284301.**

The case was discussed in 693rd SEIAA meeting dtd. 25.11.2021 and it was recorded that

- (1) It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry (Opencast Semi-Mechanized Method) in an area of **1.0 ha. for production capacity of 8820 cum per annum at Khasra No. 928, Village - Salon-A, Tehsil - Bhandar, Dist. Datia (MP) by Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP - 284301.**
- (2) The Prior Environmental Clearance letter was issued by DEIAA Datia vide letter no. 168-11/ Dated 16.05.2018 in the name of **Smt. Neeta Nageel residence near BS Krishi Karyalay MOG Line Indore, (MP).**
- (3) It is noted that in support of his request the PP has submitted the following documents:
 - I. **No Objection Certificate in the form of Notarized Affidavit submitted by Smt. Neeta Nageel residence near BS Krishi Karyalay MOG Line Indore, (MP).** for transfer of prior EC in the name of Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP - 284301, mentioning that no legal action/ credible action has been initiated against the mine till date.
 - II. **Notarized affidavit** of Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP - 284301 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - III. **Copy of Prior EC** issued by DEIAA Datia vide letter no. 168-11/ Dated 16.05.2018.
 - IV. **Copy of Environmental Management Plan** submitted by Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP - 284301

- V. Copy of **approved Mining Plan** submitted by Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP – 284301
- VI. **Lease transfer** letter issued by office of collector (Mining Devison) Datia Vide order no. 790, dated 26-09-2020 (Validity upto 22.05.2028) to Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP – 284301.

- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.


Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

- (5) EIA Notification 2006 (Amendment dated 13.07.2021) as per the sub-section (6) of section 8A of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957) provides that:

"Notwithstanding anything contained in sub-sections (2), (3) and sub-section (4), the period of lease granted before the date of commencement of the Mines and Minerals (Development and Regulation) Amendment Act, 2015 (10 of 2015), where mineral is used for other than captive purpose, shall be extended and be deemed to have been extended up to a period ending on the 31st March, 2020 with effect from the date of expiry of the period of renewal last made or till the completion of renewal period, if any, or a period of fifty years from the date of grant of such lease, whichever is later, subject to the condition that all the terms and conditions of the lease have been complied with"

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA vide L.No. 168-11/ Dated 16.05.2018 in the name of Smt. Neeta Nageel residence near BS Krishi Karyalay MOG Line Indore is hereby transferred to Shri Gulab Singh Dangi, Village - Pahadi Bujurg, Chirgaon, Dist. Jhansi, UP – 284301 for Stone Quarry (Opencast Semi-Mechanized Method) in an area of 1.0 ha. for production capacity of 8820 cum per annum at Khasra No. 928, Village - Salon-A, Tehsil - Bhandar, Dist. Datia (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted with following additional conditions :-

- i. PP should ensure to submit half yearly compliance report duly certified by Regional Office, MoEF&CC, Gol, Bhopal. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per SEIAA Office Memorandum No. 930/SEIAA/2019 dated 30.05.2019.
