With reference to above the proposal has been appraised as per prescribed procedure & provisions under the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006 and its amendment, on the basis of the mandatory documents enclosed with the application viz., Form I, Form IA, Conceptual Plan, drawings and subsequently submission of EIA report, PPT & the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- M/s Shikhar Housing Development Pvt. Ltd. has developed a group housing project at Village Pipliyakumar, Indore. The project proponent is M/s Shikhar Housing Development Pvt. Ltd. through Director, Mr. Mahesh Garg.
- ii. Project comprises of 4 nos. of residential block (408 Dwelling units), EWS housing (33 Dwelling units), club and small convenient shopping block along with the allied facilities like guard room, electrical room, green area and STP.
- iii. Project site is spread over area of 25,800 sq m (6.38 acres) and have built-up area of 42,986.92 sq m. Presently 17,435 sq m area is developed and rest area is reserved for future development.

- iv. As per the approval of T & CP Indore (vide letter 5197 dtd 20.07.2011) the total land area of the project is 2.58 ha. The total built up area proposed by PP is 42986.92 sq. m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 as the total construction is between 20,000 sq.m & 1,50,000 sq.m. MoEF&CC issued notification vide S.0.804 (E) dated 14th March, 2017 for violation cases. The project was then considered under violation category. As per the said notification; the proponent applied under the violation window.
- v. Committee considering the recent GoI, MoEF & CC Notification dated 8th March, 2018 recommends that case may be dealt as per the provisions laid down in this notification and the project may granted Terms of Reference for undertaking Environment Impact Assessment and preparation of Environment Management Plan on assessment of ecological damage, remediation plan and natural and community resource augmentation plan and it shall be prepared as a independent chapter in the EIA report by the accredited consultant and the collection and analysis of data for assessment of ecological damage, preparation of remediation plan and natural and community resource augmentation plan shall be done by an environmental laboratory accredited by the National Accreditation Board for Testing and Calibration Laboratories.
- vi. Application for ToR was submitted on 05th June 2018 and the presentation for ToR was made in 319th SEAC meeting dtd. 22.06. 2018. ToR was issued vide letter no.212/PS-MS/ MPPCB/ SEAC/ TOR (319)/2018 dated 10.07.2018. PP has submitted the EIA report vide letter dated 22.01.2019 which was sent to SEAC vide letter no. 2089 dated 31/01/2019, which was placed before the committee.
- vii. PP has submitted the remediation plan and natural community resource augmentation plan corresponding to the ecological damage assessed and economic benefits derived due to violation in the tune of suggested guidelines by the committee, with the supported by documentary proofs, such as bills, CA audit, certificates, photographs, prescribed various undertakings and CER.
- viii. The case was discussed in SEAC meetings 345th SEAC meeting dated 21.02.2019, 350 SEAC meeting dated 15-03-2019 and 400 meeting dtd. 31.10.2019 and is recommended for grant of EC subject special conditions and submission of bank gurantee (BG) with 03 years validity of Rs. 20,16,350/- (equivalent to amount proposed in remediation and resource augmentation plan) with the MP Pollution control Board.
- ix. Project land belongs to M/s Shikhar Housing Development Pvt. Ltd and Permission was obtained from Gram Panchayat for development of the project. Entire land is in possession of the M/s KML Real Estate and Construction Pvt. Ltd.PP has submitted copy of Khasra Panchsala 2012-2013. As per Khasra Panchsala the land is the name of M/s KML Real Estate and Construction Pvt. through Director Shri Narendra S/o Shri Laxman Batra & Shri Manish S/o Shri Rajababu Agarwal. A joint development agreement between M/s KMM Real Estate and Construction Pvt. Ltd. through Director Shri Manish S/o Shri Rajababu Agarwal and Shikhar Housing Development Pvt. Ltd. through Shri Pawan Agarwal S/o Shri Asharamji Agarwal for development of the project.
- x. Total water requirement for the project is 330 KLD out of which Fresh water requirement is 222 KLD and recycled water requirement is 108 KLD. Source of water during operation phase is ground water currently and permission from DM is obtained for the project

(Indore is notified zone by CGWB). Narmada water supply scheme is in proposal for establishment in area by Indore Municipal Corporation and permission has been taken from IMC (letter dtd 28.05.15) to supply Narmada water when the scheme will be completely established.

- xi. Sewage generation from the project site during operation phase is 267 KLD which is treated in STP (FAB Technology) of 300 KLD. 213 KLD is recovered water available from the STP. 108 KLD is re-used at site for flushing, DG cooling, landscaping and road & car washing. Excess 105 KLD of water is given for construction purpose to nearby-sites and if surplus is discharged into sewer. Permission of discharge of excess treated sewage to sewer is granted by Indore Municipal Corporation (letter dtd 30.10.14).
- xii. The Municipal Solid Waste approx. 12,191 Kg/day, this consist all types of wastes as recyclable waste- 357 Kg/day, 892 Kg/day - non- recyclable waste will be generated during operation phase. Generated Solid waste are being segregated & collected and temporarily stored at common solid waste collection center inside the project premises for having a capacity of 48 hour garbage storage, then picked up by hired waste management/ municipal agency for their treatment and disposal. Rejected fraction of the waste is collected and disposed by local agencies on daily basis and will be disposed at the locations designated by Indore Municipal Corporation. Permission is given by IMC (letter dtd 30.10.14) to dispose the solid waste from the project site. Recyclable waste and E-waste is sold to authorized vendors. Used oil from DG sets is sold to authorized vendors
- xiii. Storm water drainage system is provided at project site for channelizing storm water and prevents local flooding. Covered storm water drains are provided at the site. Run-off from the site is collected and recharged into the ground through RWH pits.
- xiv. The total power requirement is 3000 KVA. The source of power supply is MPEB. 2 nos. of DG sets of 125 kVA are provided at the site to meet the essential load requirement during power failure. 1 DG set of 125 KVA is operational and another 125 KVA DG set is kept as stand by. The proponent has taken various energy conservation measures which include:
 - Total energy saving is approx 9.2%
 - · Energy efficient lifts installed at the site
 - All the electrical fittings and lighting is 5 BEE star rated
 - · CFL/LED lights are used for internal lighting
 - · Solar lights are used for lighting in common area.
 - Usage of low energy embodied locally available construction material. Usage of fly ash bricks, hollow bricks and fly ash mix cement for construction purpose. Usage of excavated soil and construction debris within the project site as filling material
- xv. As per the T & CP approval maximum height of the building is 18 m (P + 6) & front road width 30 m; Front MOS 9m/12m and side/rear MOS 6.0 m.
- xvi. Road construction has been undertaken in the project site to facilitate movement of the vehicles expected at the site. Internal roads of adequate width /pedestrian pathways are developed in the project site. Road are designed so as they can bear the expected vehicle load and also width is as per NBC standards for movement of fire tender.

- xvii. PP has proposed to provide fire fighting provisions with hose reel, hose, wet riser, automatic sprinkler system in entire building, manual call points, automatic fire detection system in entire buildings, underground water storage tank, overhead water tank, fire pumps, potable fire extinguishers, exit signs, P.A. System, Yard Hydrants etc. PP has submitted copy of fire fighting NOC issued from UADD vide letter dtd. 08.12.2014
- xviii. For rainwater harvesting, 08 recharge pits will be constructed for harvesting rain water.
- xix. PP has proposed to provide parking for 302 ECS (Basement- 126 ECS Stilt-169 ECS and open-07 ECS)
- xx. Total green area measures 3870 m2 i.e. 22.2% of the net development area is planned to be kept under green cover by planting 218 trees. Out of the total green area, 1802 sq m is soft green area and remaining 2068 sq m is hard green area. Evergreen, native species preferably planted at the project site.
- xxi. PP has proposed Rs. 26,53,350/- (Rs. 20,16,350/- as Remediation Cost and Rs. 63,7000/- as EMP) for this project and PP submitted bank guarantee of INR Rs. 19,43,600/- towards Remediation Plan. The Authority after considering the bank gurantee (BG) with three years validity of Rs. 20,16,350/- (equivalent to amount proposed in Remediation Plan /Restoration Plan) and decided to deposit the same with the MP Pollution control Board for further procedure.

xxii. Under CER activities PP has proposed Rs. 64,10,000 up to five years for the following activities:

Based on the information submitted at Para i to xxi above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 638th meeting held on 16.09.2020 decided to accept the recommendations of 400th dtd. SEAC meeting held on dtd. 31.10.2019.

Hence, Environmental Clearance is accorded under the provisions of EIA notification dtd. 14th September 2006 and its amendments to the proposed Group Housing Project "Balaji Skyz" at 74/2, 74/3, 76, 78 & 79/4 Village Pipaliya Kumar Tehsil & District Indore MP Total Plot Area: 25800 sq.m Net Development Area: 17435.38 sq.m Built-up Area:

Ltd. through Director, Mr. Mahesh Garg Khasra no. 79/4, Village Pipaliyakumar, Nipania Main Road, Indore, MP -452010 subject to the compliance of the Standard Conditions and the following additional Specific Conditions as recommended by SEIAA & SEAC in its meetings.

A. Specific Conditions as recommended by SEIAA:-

- 1. The fresh water supply arrangement should be met through Municipal corporation Indore (dtd.28.05.15) and there should no extraction of ground water.
- 2. The inlet and outlet point of natural drain system should be maintained with adequate size of channel for ensuring unrestricted flow of water.

3. Disposal of waste water.

- a. PP should ensure disposal of waste water arrangement should be done in such a manner that water supply sources are not impaired.
- b. PP should explore the possibility to linkage with Nagar Nigam Indore, for sewer line for disposal of extra treated waste water.
- c. The project not having provision for discharge of excess treated sewage cannot permit to start operation unless proper arrangements are put in place for its safe handling.

4. Solid Waste Management:

- a. Separate wet and dry bins must be provided at the ground level for facilitating segregation of waste.
- b. The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material.
- c. Ensure linkage with Mobi-trash as per agreement (dtd.30.10.14) for final disposal of
- 5. PP should ensure building height, road width, front MOS and side / rear as per approved layout of T & CP.

6. For firefighting:-

PP should ensure distance of fire station approachable from the project site & provide fire fighting measures such as water sprinklers, fire hydrant pipe, Adequate firefighting requirement shall be taken into account while designing the electrical distribution system, Wet risers and hose reel, Adequate numbers of fire extinguishers, underground water storage tank properly.

7. For Rain Water Harvesting, and Storm water management:-

PP should ensure the rain water harvesting with 08 recharging pits and these pits should be connected laterally to consume the surplus runoff. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.

8. Car Parking:-

PP should ensure to provide car parking 302 ECS (Basement- 126 ECS Stilt-169 ECS and open-07 ECS)

9. Green belt :-

PP should ensure plantation in an area of 3870 m2 i.e. 22.2% of the net development area by planting 218 trees as a green belt and landscaped area with regular maintenance and also explore the possibility to plant trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar, Saltree, Gulmohar etc.

10. PP should ensure to complete the activities listed under ecological remediation, Natural resource augmentation & community resource augmentation for a total amount of Rs. 20,16,350/- as propsed during presentation.

- 11. PP shall carry out the works assigned under ecological damage, natural resource augmentation and community resource augmentation within a stipulated period and submitted to same in MPSEIAA.
- 12. PP should ensure the implementation of CER activities to the extent of Rs. 64.10 lakh up to three years will be also used for Infrastructure facilities at govt. schools of nearby area in consultation with district administration Indore (MP).
- 13. PP should ensure to submit half yearly compliance report and CER activity report with photographs of plantation in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.

Specific Conditions as recommended by SEAC

Statutory Compliance

The project proponent shall obtain all necessary clearance/permission from all relevant agencies including town planning authority before commencement of work. All the construction shall be done in accordance with the local building byelaws. ii.

The approval of the Competent Authority shall be obtained for structural safety of building due to earthquakes, adequacy of firefighting equipment etc as per National

Building code including protection measures from lightening etc.

The project proponent shall obtain Consent to Establish/Operate under the provisions iii. of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control Board/Committee.

The project proponent shall obtain the necessary permission for drawl of ground iv. water/surface water required for the project from the competent authority.

A certificate of adequacy of available power from the agency supplying power to the V. project along with the load allowed for the project should be obtained.

All other statutory clearances such as the approvals for storage of diesel from Chief Vi. Controller of Explosives, Fire Department, Civil Aviation Department shall be obtained, as applicable, by project proponents from the respective competent authorities. VII.

The provisions for the solid Waste (Management) Rules, 2016, e-Waste (Management) Rules, 2016, and the Plastics Waste (Management) Rules, 2016 shall be followed.

The project proponent shall follow the ECBC/ECBC-R prescribed by Bureau of Energy VIII. Efficiency, Ministry of Power Strictly.

Air Quality Monitoring and preservation II.

Notification GSR 94(E) dated: 25/1/2018 MoEF & CC regarding Mandatory implementation of Dust Mitigation Measures for Construction and Demolition Activities for project requiring Environmental Clearance shall be complied with.

A management plan shall be drawn up and implemented to contain the current ii. exceedance in ambient air quality at the site.

- The project proponent shall install system to carryout Ambient Air Quality monitoring iii. for common/criterion parameters relevant to the main pollutants released covering upwind and downwind directions during the construction period.
- 02 no. of Diesel power generating sets of 250 kVA (2x 125 kVA) capacity is proposed iv. as source of backup power should be of enclosed type and conform to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Use of low sulphur diesel. The location of the all DG sets may be decided with in consultation with State Pollution Control Board.
- Construction site shall be adequately barricaded before the construction begins. Dust, smoke & other air pollution prevention measures shall be provided for the building as

well as the site. These measures shall include screens for the building under construction, continuous dust/ wind breaking wills all around the site plastic/tarpaulin sheet covers shall be provided for vehicles bringing in sand, cement, Murram and other construction materials prone to causing dust polluting at the site as well as taking out debris from the site.

- vi. Sand, Murram, loose soil, cement, stored on site shall be covered adequately so as to prevent dust pollution.
- vii. Wet jet shall be provided for grinding and stone cutting.
- viii. Unpaved surface and loose soil shall be adequately sprinkled with water to suppress dust.
- ix. All construction and demolition debris shall be stored at the site (are not dumped on the roads or open spaces outside) before they are properly disposed. All demolition and construction waste shall be managed as per the provisions of the Construction and Demolition Waste Rules, 2016.
- x. The diesel generator sets to be used during construction phase shall be low sulphur diesel type and shall conform to Environmental (Protection) prescribed for air and noise emission standards.
- xi. The gaseous emission from 250 kVA (2x 125 kVA) shall be dispersed through adequate stack height as per CPCB standards. Acoustic enclosure shall be provided to the DG sets to mitigate the noise pollution. Low sulphur diesel shall be used. The location of the DG set and exhaust pipe height shall be as per the provisions of the Central Pollution Control Board (CPCB) norms.
- xii. For indoor air quality the ventilation provisions as per National Building Code of India.

III. Water quality monitoring and preservation

- i. The natural drain system should be maintained for ensuring unrestricted flow of water. No construction shall be allowed to obstruct the natural drainage through the site, on wetland and water bodies. Check dams, bio-swales, landscape and other sustainable urban drainage systems (SUDS) are allowed for maintaining the drainage pattern and to harvest rain water.
- ii. Buildings shall be designed to follow the natural topography as much as possible Minimum cutting and filling should be done.
- iii. The total water requirement during operation phase is 330 KLD out of which 222 KLD is fresh water requirement and 213 KLD will be the total recycled water generated out of which 93 KLD recycled water will be used for flushing, while 12 KLD water will be used for horticulture/landscaping.
- iv. The quantity of fresh water usage, water recycling and rainwater harvesting shall be to monitor to monitor the water balance as projected by the project proponent. The record shall be submitted to the Regional Office, MoEF & CC along with six monthly Monitoring reports.
- v. A certificate shall be obtained from the local body supplying water, specifying the total annual water availability with the local authority, the quantity of water already committed the quantity of water allotted to the project under consideration and the balance water available. This should be specified separately for separately for ground water and surface water sources, ensuring that there is no impact on other users.
- vi. At least 20% of the open spaces as required by the local building bye-laws shall be previous. Use of Grass pavers, paver blocks with at least 50% opening, landscape etc. would be considered as previous surface.
- vii. Installation of dual pipe plumbing for supplying fresh water for drinking, cooking and bathing etc and other for supply of recycled water flushing, landscape irrigation, car washing, thermal cooling, conditioning etc. shall be done.
- viii. Use of water saving devices/fixtures (Viz. low flow flushing systems; use of low flow faucets tap aerators etc) for water conservation shall be incorporated in the building plan.

- Separation of grey and black water should be done by the use of dual plumbing ix. system. In case of single stack system separate recirculation lines for flushing by giving dual plumbing system be done. X.
- Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- The local bye-law construction on rain water harvesting should be followed. If local by-Xi. law provision is not available, adequate provisions for storage and recharge should be followed as per the Ministry of Urban Development Model Building bylaws, 2016. Rain water harvesting recharge pits/storage tanks shall be provided for ground water recharging as per the CGWB norms.
- A rain water harvesting plan needs to be designed where the recharge bores of xii. minimum one recharge bore per 5,000 square meter of built up area and storage capacity of minimum one day of total fires water requirement shall be provided. In areas where ground water recharge is not feasible, the rain water should be harvested and stored for reuse. The ground water shall not be withdrawn without approval from the Competent Authority. xiii.
- For rainwater harvesting, 08 recharge pits will be constructed for harvesting rain water. The Mesh will be provided at the roof so that leaves or any other solid waste/debris will be prevented from entering the pit. xiv.
- The RWH will be initially done only from the roof top. Runoff from green and other open areas will be done only after permission from CGWB. XV.
- All recharge should be limited to shallow aquifer.
- No ground water shall be used during construction phase of the project. XVI.
- Any ground water dewatering should be properly managed and shall conform to the XVII. approvals and the guidelines of the CGWA in the matter. Formal approval shall be taken from the CGWA for any ground water abstraction or dewatering. xviii.
- The quality of fresh water usage, water recycling and rainwater harvesting shall be measured and recorded to monitor the water balance as projected by the project proponent. The recorded shall be submitted to the Regional Office, MoEF & CC along with six monthly Monitoring report. XIX.
- Sewage shall be treated in the STP based on FAB technology (Capacity 300 KLD). The treated effluent from STP shall be recycled/re-used for flushing. AC makes up water and gardening. As proposed, no treated water shall be disposed in to municipal XX.
- The waste water generated from the project shall be treated in STP of 300 KLD capacity (based on FAB technology) and then reused for various purposes. No water body or drainage channels are getting affected in the study area because of this project.
- No sewage or untreated effluent water would be discharged through storm water XXI. drains.
- Periodical monitoring of water quality of treated sewage shall be conducted. Necessary XXII. measures should be made to mitigate the odour problems from STP.
- Sludge from the onsite sewage treatment including septic tanks, shall be collected, XXIII. conveyed and disposed as per the Ministry of Urban Development, Control Public Health and Environmental Engineering Organization (CPHEEO) Manual on Sewerage and Sewage Treatment Systems, 2013.

IV. Noise monitoring and prevention

Ambient noise levels shall conform to residential area/commercial area/industrial area/silence zone both during day and night as per Noise Pollution (Control and Regulation) Rules, 2000. Incremental pollution loads on the ambient air and noise quality shall be closely monitoring during construction phase. Adequate measures shall be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/SPCB.

Noise level survey shall be carried as per the prescribed guidelines and report in this regard shall be submitted to Regional Officer of the Ministry as a part of six-monthly compliance report. iii.

Acoustic enclosures for DG sets, noise barriers for ground run bays, ear plugs for operating personnel shall be implemented as mitigation measures for noise impact due to ground sources.

V. Energy Conservation measures.

Compliance with the Energy Conservation Building Code (ECBC) of Bureau of Energy Efficiency shall be ensured, Building in the State which have notified their own ECBC, shall comply with the State ECBC. ii.

Outdoor and common area lighting shall be LED.

Energy Conservation Techniques can be considered as Space Cooling: External iii. shading prevents solar radiation from entering into the buildings and reduces the cooling load, results to better control of overheating and indoor temperatures. Space cooling load may be reduced by 30% due to proper shading. iv.

Thermal insulation of buildings external walls and roof reduces the cooling load and improves indoor thermal comfort conditions by lowering heat gains through the building's envelope. Energy consumption in insulated buildings may be 5-30% less

than in non-insulated buildings.

Domestic hot water: Solar collectors reduce the annual energy consumption for V. domestic hot water production by lowering the load covered by electrical or thermal heating. Energy consumption in buildings with solar collectors may be 60-80% less than in buildings with electric heaters.

Concept of passive solar design that minimize energy consumption in buildings by using design elements, such as building orientation, landscaping, efficient building envelope, appropriate fenestration, increased day lighting design and thermal mass etc. shall be incorporated in the building design. Wall, window, and roof u-values shall be as per ECBC specifications. vii.

Energy conservation measures like installation of CFLs/LED for the lighting the area outside the building should be integral part of the project design and should be in place

before project commissioning.

VI. Waste Management

Total solid waste 12,191 Kg/day, this consist all types of wastes as recyclable waste-357 Kg/day, 892 Kg/day - non- recyclable waste and shall be treated/ disposed off as per provision made in the MSW Rules 2016. ii.

A certificate from the competent authority handling municipal solid wastes, indicating the existing civic capacities of handling and their adequacy to cater to the MSW

generated from project shall be obtained.

- Disposal of muck during construction phase shall not create any adverse effect on the neighboring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of competent authority. iv.
- Separate wet and dry bins must be provided in each unit and at the ground level for facilitating segregation of waste. Solid waste shall be segregated into wet garbage and
- All non-biodegradable waste shall be handed over the authorized recyclers for which a written lie up must be done with the authorized recyclers.
- Any hazardous waste generated during construction phase, shall be disposed off as per applicable rules and norms with necessary approvals of the State Pollution Control
- Use of environment friendly materials in bricks, blocks and other construction VII. materials, shall be required for at least 20% of the construction materials quantity. These include fly ash brick, hollow bricks, AACs, Fly Ash Lime Gypsum block, compressed earth blocks and other environmental friendly materials.

Any wastes from construction and demolition activities related thereto small be ix. managed so as to strictly conform to the construction and Demolition Rules, 2016.

Used CFLs and TFLs should be properly collected and disposed off/sent for recycling X as per the prevailing guidelines/rules of the regulatory authority to avoid mercury contamination.

VII. Green Cover

Total 218 trees shall be planted in the area of 3870 sq. mt. (22.2% of plot area) which is developed as greenbelt development.

Not tree can be felled/transplant unless exigencies demand. Where absolute ii. necessary, tree felling shall be with prior permission from the concerned regulatory authority. Old trees should be retained based on girth and age regulations as may be prescribed by the Forest Department. Plantations to be ensured species (cut) to species (Planted)

A minimum of 1 tree for every 80 sqm of land should be planted and maintained. The iii. existing trees will be counted for this purpose. The landscape planning should included plantation of native species. The species with heavy foliage, broad leaves and wide canopy cover are desirable. Water intensive and/or invasive species should not be

used for landscaping.

Where the trees need to be cut with prior permission from the concerned local Authority, Compensatory plantation in the ratio of 1:10 (i.e. planting of 10 trees for every 1 tree that is cut) shall be done and maintained.  - a. Hierarchy of roads with proper segregation of vehicular and pedestrian traffic
 - b. Traffic calming measures.
 - c. Proper design of entry and exit points
 - d. Parking norms as per local regulation
- Vehicles hired for bringing construction material to the site should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards be operated only during non-peak hours.
- A detailed traffic management and traffic decongesting plan shall be drawn up to iii. ensure that the current level of service of the road within a 05 Kms radius of the project as maintained and improved upon after the implementation of the project. This plan should be based on cumulative impact of the development and increased habitation being carried out or proposed to be carried out by the project or other agencies in this 05 Kms radius of the site in different scenarios of space and time and the traffic management and the PWD/competent authority for road augmentation and shall also have their consent to the implementation of components of the plan which involve the participation of these departments.
