Sub: Case No. - 5815/2019, Prior Environment Clearance for Papredi Marble Mine (Opencast Semi - Mechanized Method) in an area of 4.50 ha for production capacity of 10,500 cum/year at Khasra No.- 554/1 (Part) at Village - Papredi, Tehsil - Beohari, District - Shahdol (MP) by M/s Shree Marble, Plot No. 186, Nalanda College, Mahaveer Nagar, Katni (M.P.).

The case was discussed in 531st SEIAA dtd. 18.03.2019 and it was recorded that.....

" PP has submitted a letter dated 01.03.2019 with certification of Tehsildar Biohari District Shahdol (vide L.No. 121 dated 28-02-2019) that the natural drain 300 m. away from the mining site and requested to remove conditions number 08 & 09 recommended by SEAC. The conditions are mentioned at No. 28 and 29 of EC issued vide L.No. 2501/SEIAA/19 dated 05.03.2019 as given below:-

- Retaining wall along with drain shall be provided all around the natural drain. 19.
- 50 meters area shall be left as non-mining area on the both sides of the natural drain.

After detail discussion, it is decided to withdraw the conditions No. 28 and 29 mentioned in the Prior EC on the basis of the certification of Tehsildar Biohari District Shahdol and other conditions will remain unchanged. Copy to PP and all concerned."

In view of above decision, the condition No. 28 and 29 mentioned in the Prior EC is hereby withdrawn. The other conditions of the prior EC will remain unchanged.
