



 - i. The case was discussed in 115th SEAC meeting dtd.5.01.2013 and recommended in 117th SEAC meeting dtd.16.01.2013 based on the submission of documents and presentation made by the PP the committee has recommended for grant of prior EC to the project subject to the 14 conditions.
 - ii. It was noted that the PP has applied in Form-I for Prior Environmental Clearance of Piplia to Manasha Road Project Murum & Metal Stone Quarry in an area of 4.0 ha. for production capacity Murum 25,000 m³ per year & Metal Stone 40,000 m³ per year at Survey No. 931/1, at Village-Narayangarh, Tehsil-Malahargarh, Distt.-Mandsaur (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Mandsaur (vide No. 514 dated 07.03.2012) where in temporary permission for mining is mentioned.

It was noted that SEAC in its 117th meeting dtd. 16.01.2013 has mentioned that project pertains to mining of stone with production capacity 25,000 m³ per year, while on scrutinizing the documents viz Form-1 and the letter from office of the Collector (Mining), District-Mandsaur (vide No. 514 dated 07.03.2012) it was found that the proposed project is for Murum & Metal Stone Quarry (Opencast Mechanized Mining Method) in an area of 4.0 ha. for production capacity of Murum 25,000 m³ per year & Metal Stone 40,000 m³ per year.
 - iii. As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**

- The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the collector.



13. **Case No. 1062/2012-** Prior Environmental Clearance for Sand Quarry (manual/ semi mechanized) in an area of 2.0 ha. for production capacity 20,000 m³ per year at Survey No. 326 at Village - Chhoti Begalgaon, Tehsil – Sondwa Distt- Alirajpur (M.P) by Mr. Raru S/o Shri Haru, Village - Chhoti Begalgaon, P.O. – Umariya, Tehsil – Sondwa, Distt. - Alirajpur (M.P.) 457888.

- i. The case was discussed in 115th SEAC meeting dtd.5.1.2013 and recommended in 117th SEAC meeting dtd.16.01.2013 based on the submission of documents and presentation made by the PP the committee has recommended for grant of prior EC to the project subject to the 14 conditions.
- ii. It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of sand Quarry in an area of 2.0 ha. for production capacity 20,000m³ per year at **Survey No. 326** at Village-Chhoti Begalgaon, Tehsil– Sondwa Distt- Alirajpur (M.P). It is found that PP has submitted the copy of the letter from office of the collector District Alirajpur (vide No.170 dtd. 05.04.2012) wherein temporary permission for mining is mentioned.
- iii. As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- iv. It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body at the **distance of 500 m. from the mining site.**
- v. It was noted that the information about the distance of mining site from the Forest (Reserved/Protected) land is not available in the records.
- vi. It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- vii. The PP has proposed the lease period for two years and SEAC has recommended two years lease period.
- viii. The Environmental Management Scheme (EMS) submitted by the PP as a part of **Appendix-II** was examined and found that the EMS as submitted by PP is sketchy.
- ix. It was decided to accept the recommendation of 117th SEAC meeting dtd 16.01.2013 to grant *Prior Environmental Clearance* for Prior Environmental Clearance for Sand Quarry in an area of 2.0 ha. for production capacity 20,000 m³ per year at Khasra No. 326 at Village - Chhoti Begalgaon, Tehsil – Sondwa Distt- Sheopur Alirajpur (M.P) for lease period of **Two years** by Mr. Raru S/o Shri Haru, Village - Chhoti Begalgaon, P.O.– Umariya, Tehsil – Sondwa, Distt. - Alirajpur (M.P.) 457888 subject to the following conditions :-
 - **The sand mining should be carried out at the distance of 25 m. from the stream bed.**
 - In case if the distance is less than 250 m. the Collector would ensure that the PP has obtained the NOC from the committee constituted under the Chairmanship of PS Forest before execution of quarry agreement/ mining.

- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.

- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
 - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
 - Scheme of removal, storage and utilization of overburden.
 - Scheme of plantation of trees.
 - Measure for prevention air and water pollution.
 - Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
 - Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.
- The Collector or an officer authorized by him will ensure the implementation of the EMS accordingly.
- The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the collector.





14. **Case No. 633/2011**, Prior Environmental Clearance for Captive Thermal Power Plant of 2 x 30 MW existing trident group Complex at village Budni, District Sehore, MP by M/s Trident Corporation Ltd, Somghera 148101
- The proposed project is Coal based thermal power plant with production capacity 2 x 30 MW (coal based) and located at Khasra No. 36/1, 36/2, 36/4, 36/5, 36/6, 40/1, 40/2, 40/3, 39/1, 39/2, 41/1, 41/2, 42 & 43 in total 600 acres land at Village Budhni, Distt. – Sehore (M.P.) The project is covered under category B and mentioned at S.N. 1(d) of Schedule of EIA Notification, 2006.
 - In the 79th SEAC meeting dtd 02/09/2011, TOR was issued to the proponent to carry out EIA. The case was discussed in 99th SEAC meeting dtd 24.07.2012 and 116th SEAC meeting dtd 15.01.13 and it is recorded that *".....In view of above the committee is of the opinion that the case may be taken up for discussion only after receipt of revised EIA report incorporating the public hearing issues. Thus proponent has to get the Public Hearing as per the provisions of EIA Notification and the revised EIA / EMP report has to be submitted incorporating the public hearing issues....."*
 - PP vide letter dtd 21.06.12 & 12.09.12 received in SEIAA office on 25.06.2012 & 13.09.12 requested for providing exemption from the public hearing for the project on the ground that the proposed unit is located in the notified industrial area. The letter was forwarded to SEAC vide SEIAA letter no. 476 dtd 04.07.12 & 1606 dtd 29.11.12 respectively.
 - The case was discussed in depth and it is noted that the proposed unit is located in Budhni Industrial area notified vide Commerce, Industries & Employment Deptt, GoMP Gazette, notification no. F-11-66-2010-B11 dtd 21.03.12.
 - It is noted that the industrial area has been notified after the EIA notification, 2006 and no EIA or public hearing was conducted or prior environmental clearance has been obtained for the said industrial area.
 - The Authority accepted recommendation of 116th SEAC meeting dtd 15.01.13 and the Authority decided that PP should be informed that his application (dtd 21.06.12 & 12.09.12) has been rejected for grant of exemption for public hearing for the reasons given in minutes of 116th SEAC meeting dtd 15.01.13. The Proponent should get the public hearing conducted as per the provision of EIA Notification and submit to SEAC.
15. **CaseNo.657/2011**, Prior Environmental Clearance for Single Super Phosphate 1500 TPD(Granulated SSP 500 TPD & Powder SSP 1000 TPD) Survey No. 7/1, 9, 6, 7/2 & 7/2 (Part), under revenue patwari halka no. 34 (new 79), Revenue circle no 2, Village Yasbanth Nagar, Near Sunkota, Tehsil Tarana, Distt.- Ujjain (M.P.) by M/s Advance Fertilizers India Pvt. Ltd., Mr. Ashish Tiwari 203, 2nd Floor, Indore Trade Centre, South Tukoganj, Indore,(M.P.)
- This case pertains to production of Single Super Phosphate with production capacity of 1500 TPD (Granulated SSP 500 TPD & Powder SSP 1000 TPD). The Single Super Phosphate Units are covered under Sr. No. 5(a) of Column 'B' of the Schedule of EIA Notification 2006 and as amended.
 - The case was discussed in 87th SEAC meeting dtd 07.01.12 ,89th dtd. 14.02.12 & 90th SEAC meeting dtd 02.03.12 and 116th SEAC meeting dtd 15.01.13 and it

ii. As per approval from T & CP, Bhopal (L. No. 461/L.P.58/Na. Gra. Ni./2012 dtd 16.07.12) the total land area is 3.834 ha (total 09 Khasras). The total built up area proposed by PP is 28565.04 sqmt. (Form-1) & 29812.188 sqmt in the SEAC presentation, and is between 20,000 sqmt. & 1,50,000 sqmt. hence the project comes under 8 (a) category of schedule of EIA Notification 2006.

iii. The case was examined and it was found that :-

- a. The proposed project is Group Housing project at Village DamKhera ,Tehsil-Huzur, District – Bhopal M.P. The Proponent (PP) is M/s Agrawal Colonizer through partner Sanjeev Agrawal S/o Shri S. K. Agarwal.
- b. As per SEAC meeting minutes, Form-1 and T&CP approval the Khasra mentioned are 194/2/1/12,215/1/1/1,215/1/1/2,215/1/1/3,215/1/2/2,214/1/1, 214/1/2, 214/1/3, 216/1/Ka and the total land area proposed for the project is 3.834 ha. As per the Khasra Panchsala 2011-12 the land details are as follows:

- c. As per the Khasra Panchsala 2011-2012 the land 3.834 ha (total 09 Khasras) for the proposed project is under the possession of Sudhir Kumar Agrawal S/o Sushil Kumar Agrawal. It is noted that PP has not submitted partnership deed or joint venture agreement. It is decided that PP should submit the partnership deed or joint venture agreement between the Proponent and land owner.

- d. As per the approval from Joint Director office of T & CP Bhopal, (issued vide L.No. 461/ L.P. 58/Na. Gra. Ni./2012 dtd 16.07.12 and map) the land use of the proposed project site is residential (as per the Bhopal Vikas Yojna 2005), the maximum height is G+1, the total land area is 3.834 ha. The total nos. of duplexes is 208, EWS & LIG 31.
- e. The total water requirement is 186 KLD (94 domestic + 47 flushing + 45 land scaping) and recycled water 108 KLD through dual plumbing. The source of water proposed by PP is municipal supply 34 KLD + ground water 60 KLD. The SEAC in its 116th meeting has imposed a condition that fresh water requirement will not exceed 94 KLD (Municipal supply 34KLD + Ground water 60KLD) and the ground water can be abstracted only after obtaining permission from CGWA. It is noted that PP has not obtained permission from Nagar Nigam, Bhopal or CGWA for the water supply. It is decided that the entire demand of water supply should be met through the Bhopal Municipal supply and there should be no extraction of ground water. PP should submit firm commitment letter for 94 KLD fresh water supply from Nagar Nigam, Bhopal.
- f. PP has proposed roof top rain water harvesting for ground water recharge through percolation tanks and is satisfactory. PP should ensure its implementation.
- g. PP has proposed STP of capacity 120 KLD. It is noted that the recycling of treated waste water of 108 KLD is proposed (47 KLD flushing + 45 horticultural & miscellaneous uses) and there is extra 16 KLD of treated waste water. It is noted that PP has not submitted the details of final discharge of waste water. It is decided that PP should submit details of integration of waste water discharge with Municipal Sewer System.
- h. It is noted that solid waste generation is 0.469 TPD. PP has proposed for segregation of solid waste at source and its disposal at trenching site of BMC for which Health Department of BMC has given consent vide letter no. 657 dtd 31.10.12 and is satisfactory. PP should ensure integration with BMC for MSW disposal.
- i. As per Gol office memorandum dtd 07.02.2012 regarding guidelines for high rise building the fire fighting NOC, road width and distance of fire station conditions are applicable to buildings more than 15 m. It was noted that the maximum height proposed is 6 m, hence the provision of Gol office memorandum dtd 07.02.12 are not applicable.
- j. PP has provided independent parking space for 208 duplexes i.e. for 208 cars. It is decided that PP should ensure independent parking for one car in the premises of each individual house.


