1. **Case No. 930/12-** Prior Environmental Clearance for **Stone/Boulder Quarry-Crusher** (Manual/Semi Mechanized Method) in an area of 01.980 ha. for production capacity of 28,350 m³ per year at Khasra Nos. 181, 182, 184, 166 at Village-Mothar, Tehsil-Seoni, Distt.-Seoni (M.P.) by Shri Rajesh Janghela S/o Shri Fullsingh Janghela, Proprietor, M/s Janghela Stone Crusher, Village-Sonadongri, Post-Bhonga Kheda, Tehsil & District-Seoni (M.P.)-480882.

- (1) The case was discussed in 114th SEAC meeting dtd. 04.01.2013 and recommended in 121st SEAC meeting dtd. 28.02.2013/05.03.2013 based on the submission of documents and presentation made by the PP the committee has recommended for grant of prior EC to the project subject to the 13 conditions.

- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone/Boulder Quarry-Crusher** (Manual/Semi Mechanized Method) in an area of 01.980 ha. for production capacity of 28,350 m³ per year at Khasra Nos. 181, 182, 184, 166 at Village-Mothar, Tehsil-Seoni, Distt.-Seoni (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Seoni (vide No. 3385 dated 19.08.2011).

- (3) It was found that there is variation in production capacity. PP in Form-1 applied for 28,350 m³ per year while in Appendix-1 he has mentioned 5,000 m³ per year. Also the SEAC has reduced production capacity to 8,000 m³ per year without mentioning any reason.

In this context it was decided to write the Collector to seek information regarding the actual production capacity for which the PP has applied in the mining office or he may be allowed. It should be made available to SEIAA within one month. A copy of the letter should be endorsed to the PP also.

2. **Case No. 1010/13-** Prior Environmental Clearance for **Soil (Mud) Quarry** (Manual Method) in an area of 2.609 ha. for production capacity of 8,000 cubic meter per year at Khasra No. 530/1 at Village-Malakhedi, Tehsil-Hoshangabad, Distt.-Hoshangabad (M.P.) by Smt. Somvati Bai W/o Mr. Kodulal, Village-Malakhedi, Tehsil-Hoshangabad, Distt.-Hoshangabad (M.P.)-461001.

committee has recommended for grant of prior EC to the project subject to the 9 conditions.

- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Soil (Mud) Quarry** (Manual Method) in an area of 2.609 ha. for production capacity of 8,000 cubic meter per year at Khasra No. 530/1 at Village-Malakhedi, Tehsil-Hoshangabad, Distt.-Hoshangabad (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Hoshangabad (vide No. 723 dated 18.07.2012) wherein temporary permission for mining is mentioned.
- (3) As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no water body, educational institute, historical monuments e.t.c. but **there is habitation/settlement within 500 m. from the mining site.** "नर्मदा निर्मित केन्द्र तथा रेशम केन्द्र बना है।"

In this context it was decided to write to the Collector to seek information regarding the exact distance of the "नर्मदा निर्मित केन्द्र तथा रेशम केन्द्र" from the mining site and likely impact of mining activity. It should be made available to SEIAA within one month. A copy of the letter should be endorsed to the PP also.


3. **Case No. 1140/13-** Prior Environmental Clearance for **Stone Crushing – Crusher Unit** (Semi Mechanized Method) in an area of 1.834 ha. for production capacity of 2,000 MT per month at Khasra No. 138 at Village-Makdawan, Tehsil-Shamgarh, Distt.-Mandsaur (M.P.) by Shri Rajendra Kumar Chamaria C/o Donyolo Udyog Ltd. P.O. Shamgarh, District-Mandsaur (M.P.)-458883.

- (1) The case was **recommended in 121st SEAC meeting dtd. 28.02.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 11 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Crushing – Crusher Unit** (Semi Mechanized Method) in an area of 1.834 ha. for production capacity of 2,000 MT per month at Khasra No. 138 at Village-Makdawan, Tehsil-Shamgarh, Distt.-Mandsaur (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Mandsaur (vide No. 335 dated 11.02.2013). wherein proposal for 10 years is recommended.
- (3) As per information given by the PP in Appendix-1 duly certified by Ranger & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body within **500 m. from the mining site.**
- (5) It was found from the available records that the production capacity mentioned by the PP in Form-1 is 2000 MT per month and in Appendix-1 is 5000 m³ per year.

In this context it was decided to write to the Collector to seek information regarding the actual production capacity for which the PP has applied in the mining office. It should be made available to SEIAA within one month. A copy of the letter should be endorsed to the PP also.

4. **Case No. 1142/13-** Prior Environmental Clearance for **Stone Mine (Furshi) / Flag Stone Mine** (Manual Method) in an area of 2.53 ha. for production capacity of 3,000 m³ per year at Khasra No. 45/1 at Village-Batediya, Tehsil-Jirapur, Distt.-Rajgarh (M.P.) by Mr. Ankush Mundra, Partner, M/s Red Stone Impex, 13/1, Silver Enclave, Old Palasiya, Indore (M.P.)-452001.

- (1) The case was **recommended in 121st SEAC meeting dtd. 28.02.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 10 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Mine (Furshi) / Flag Stone Mine** in an area of 2.53 ha. for production capacity of 3,000 m³ per year at Khasra No. 45/1 at Village-Batediya, Tehsil-Jirapur, Distt.-Rajgarh (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District- Rajgarh (vide No. 701 dated 27.11.2012).
- (3) As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body **within 500 m. from the mining site.**
- (5) It was noted that the information about the distance of mining site from the Forest (Reserved/Protected) land is not available in the records.
- (6) It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- (7) The PP has proposed the lease period for **ten years** (in PFR) and SEAC has recommended ten years lease period.
- (8) It is noted that PP has applied for **Flag stone mining but he has not mentioned the lease period neither in Form-1 nor he has submitted the Appendix-2.** However, the SEAC has mentioned Ten years lease period. In this context it was noted that under Sub Rule 2 of Rule 7 of Minor Minerals Rules 1996 the period of quarry lease for Flagstone is Five years.


In view of above, Member and Member Secretary decided the maximum lease period for **Five years**. However, Chairman recorded his dissent on the basis of decision taken in 117th SEIAA meeting dated 22-01-2013, which is mentioned at Para no 10 of Point no 13 of the minutes. The relevant lines of the Para showing the reason of dissent are given hereunder;

"Now prior EC is to be considered for the new cases of these three minor minerals by adopting the procedure prescribed for the B-1 category i.e. by issuing TOR, preparation of EIA and public consultation in my considered view."

- (9) It was decided to accept the **recommendation of 121st SEAC meeting dtd. 28.02.2013** to grant Prior Environmental Clearance for **Stone Mine (Furshi) / Flag Stone Mine** (Manual Method) in an area of 2.53 ha. for production capacity of 3,000 m³ per year at Khasra No. 45/1 at Village-Batediya, Tehsil-Jirapur, Distt.-Rajgarh (M.P.) for lease period of **Five years** by Mr. Ankush Mundra, Partner, M/s Red Stone Impex, 13/1, Silver Enclave, Old Palasiya, Indore (M.P.)-452001 subject to the following conditions :-

- In case if the distance is less than 250 m. it was decided that the Collector would ensure that the PP has obtained the NOC from the committee

constituted under the Chairmanship of PS Forest before execution of quarry agreement / mining.

- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.


In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.


- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
 - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
 - Scheme of removal, storage and utilization of overburden.
 - Scheme of plantation of trees.
 - Measure for prevention air and water pollution.
 - Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
 - Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.
- The Collector or an officer authorized by him will ensure the implementation of the EMS accordingly.
- The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the collector.



- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone mine with crusher** (Manual method) in an area of 1.0 ha. for production capacity of 15,000 cum/year at **Survey No. 109/2** at Village Ganeshpur, Tehsil-Dindori, District-Dindori (M.P.). It was decided to write the Collector to seek information regarding the actual production capacity for which PP has applied in mining office. It should be made available to SEIAA within one month. A copy of the letter should be endorsed to the PP also.
