- (1) The case was **discussed in SEAC meetings 113<sup>th</sup> dtd. 18.12.2012 & 115<sup>th</sup> dtd. 05.01.2013 and recommended in 123<sup>rd</sup> SEAC meeting dtd. 12.03.2013** ..... based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 11 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Mine – Crusher Unit** in an area of 1.0 ha. for production capacity of 5,000 m<sup>3</sup> per year at Khasra No. 96/2 at Village-Koyalbuddhi, Tehsil-Shahpur, Distt.–Betul (M.P.). It is found that PP has submitted the copy of the Order from office of the Collector (Mining), District- Betul (vide No. 664 dated 24.04.2012) wherein mining lease is sanctioned for 10 years.
- (3) As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body **within 500 m. from the mining site.**
- (5) It is noted that the distance of mining site from the Forest Boundary is more than 250 m. (vide DFO, Betul L.No. 4607 dtd. 24.05.2011).
- (6) It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- (7) The PP has proposed the lease period for ten years (EMS & Appendix-2) and SEAC has recommended ten years lease period.


In this regard Member and Member Secretary agreed with the recommendation of SEAC. However, Chairman recorded his dissent on the basis of decision taken in 117<sup>th</sup> SEIAA meeting dated 22-01-2013, which is mentioned at Para no 10 of Point no 13 of the minutes. The relevant lines of the Para showing the reason of dissent are given hereunder;

***"Now prior EC is to be considered for the new cases of these three minor minerals by adopting the procedure prescribed for the B-1 category i.e. by issuing TOR, preparation of EIA and public consultation in my considered view."***

- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.

- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-

- Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
- Scheme of removal, storage and utilization of overburden.
- Scheme of plantation of trees.
- Measure for prevention air and water pollution.
- Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
- Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.

- The Collector or an officer authorized by him will ensure the implementation of the EMS accordingly.

- The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the collector.

- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Murum & Stone Quarry** (Manual method) in an area of 1.00 ha. for production capacity of Murum 800 cum/year & Stone 200 cum/year at **Survey No. 361/13** at Village Nagpurakala, Tehsil Itarsi, District Hoshangabad (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Hoshangabad (vide L No. 1143 dated 19.10.2012) where in temporary permission for mining is mentioned.

In this regard it was noted that the SEIAA has formulated a Policy in its 107<sup>th</sup> SEIAA meeting dtd 17.09.2012 in which following criteria was decided

- (2) PP (vide letter dtd. 21/12/09) informed that as per MoEF, GoI Notification Dated 01.12.09 (*Annex-1*). As per the rule V(iv) of the said amendment notification "in case of the secondary metallurgical processing industrial units, those projects involving operation of furnaces only, such as induction and electric arc furnace, submerged arc furnaces and cupola furnace with capacity more than 30,000 tonnes per annum(TPA) would require EC."
- (3) In view of the amendment notification PP requested for exemption from EC.
- (4) SEIAA sent the PP letter (vide letter no. 450 dtd. 15/01/10 ) to MS, SEAC for opinion, regarding exemption.
- (5) The case was discussed in SEAC 47 mtg dtd. 29.01.10 Neither the PP nor his representative was present in the meeting however, Committee has decided to return the case to SEIAA in view of amended EIA Notification dated 01/12/2009.
- (6) The case discussed in 32<sup>nd</sup> SEIAA meeting dtd 07.04.2010 and it was the project proponent should be asked to furnish a declaration to the Authority, regarding the type and quantum of auxiliary fuel proposed to be used in the above project. Accordingly a letter (no. 61 dtd.04.05.2010) was sent to PP but no response has been received till date.
- (7) The case discussed and it is decided that since PP has not submitted the information hence as per GoI office memorandum no. J-11013/5/2009-IA-II (Part) dtd 30.10.2012 the case is delisted.
