The applicant, presented the salient features of the project .Information pertaining to the above project was examined by the committee. After discussion on the project it was revealed that:

This is a case for enhancement of production from 24 MW to 30 MW at Industrial Development Centre-Phase -II Satlapur (Mandideep), Distt.-Raisen (M.P.). As production enhancement is proposed in the unit already operating in notified industrial area public hearing is not required. It was submitted by the proponent that there will be no change in boiler capacity and no additional land is required for the proposed expansion. The coal requirement is reported to be 586 TPD, with fly ash generation of about 205 TPD. Industry has installed ESP in boiler and bag-filters in coal handling plant. PP has submitted that the generated fly ash is being sold to the cement manufacturing units and local brick manufacturers. The fly-ash is being collected dry and stored in silo. It was also informed by the PP that the generated power shall be used in-house and excess power shall be sold to the State grid. Total water requirement after expansion will be 2558 KLD and shall be supplied by AKVN. Committee has agreed to issue standard TOR to the PP to carry out EIA /EMP, with inclusion of following:

1. Micro-level features shall be depicted on to-the-scale map and presented with the EIA.
2. Industrial area map showing the details of surrounding industries.
3. Compliance of Air & Water Consent conditions and Environmental Statement has to be furnished with the EIA.
4. Extra efforts for Conservation of water have to be proposed in EIA.
5. Agreement document for utilization of fly-ash has to be furnished.
6. Intent of CDM where ever possible (such as waste heat recovery) has to be taken up.
7. Mode of transport of coal up to the industry to be furnished.

This is a proposal of 10 MW biomass based power project at Village- Kherkhedi, Tehsil-Shajapur, Distt. - Shajapur (M.P.). Earlier the project (Case no. 239/08) was proposed at village Choma & accordingly the TOR was issued, with change in the location PP has submitted fresh application to SEIAA, hence earlier TOR may be treated as null & void. The case no 239/08 may send back to SEIAA for delisting. The documents and presentation made by the PP reveal that about 85000 MT/Y of bio-mass shall be required and water requirement shall be 1500 m³ /day, which shall be obtained from river Lakhunder. The Raw material shall be collected from the near by area and coal shall be procured from the local vendors.

- *Raw material:* Source & availability (quantification of demand vis-à-vis collection) of bio-mass with supportive documentation (lease, agreements etc.) to be produced. In case separate land is hired or acquired for bio-mass cultivation documents pertaining to the same have to be produced. Quality of coal proposed to be purchased has to be certified by the supplier.
- *Water:* Approval and commitments from the concerned departments for lifting water from the river Lakhunder along with the permission for laying pipe line up to the site, have to be furnished with EIA.
- Lean period flow (summer) of the river and competitor users of river water has to be assessed and reported with EIA.
- *Social Corporate Responsibility:* Details of welfare activities planned for the workers to be provided.
- *Map Depictions:* Coloured maps depicting land-use of the region showing sensitive / fragile features (such as Kharmore Sanctuary) and detailed lay-out of the site clearly showing green-belt (existing & planned)
- Satellite Image of the location should be submitted.
- Location is also to be shown in Tehsil map procured from revenue department.

This being an Area Development and Integrated Township project is covered in category 8 (B) of the Schedule of EIA Notification 2006 and has to be appraised by the SEAC before grant of EC.

The applicant, presented the salient features of the project. Information pertaining to the above project was examined by the committee. After discussion on the project it was revealed that:

The project consist of construction of Commercial block, Hotel, Club, School and group housing with total constructed area of 59,250 sqm and a Plotted & villa development is proposed in an area of 2,03,294 sqm. Total cost of the project is 90 Crore, total water requirement during operational phase is 1468 KLD; source water is Narbada Water supply Scheme-Phase-III. Waste water generation is reported to be 857 KLD which shall be treated through a dedicated STP of capacity 1000 KLD. The treated water is proposed for use in flushing, horticulture and cooling of DG set & HVAC. Municipal Solid Waste to be generated is reported as 2.6 TPD, the MSW shall be collected & segregated at source. The bio-degradable solid waste is proposed for composting and shall be used as manure at site, the remaining waste shall either be sold to re-cycler or shall be disposed off at designated trenching ground. The power requirement is reported to be 7 MW. DG sets of 7500 KVA is proposed for power back-up. PP has submitted a proposal for use of solar lighting, CFL based lighting, Solar Water heater system and appropriate door/window glasses (towards the compliance of ECBC guidelines). PP has also submitted water harvest system. Parking space for 530 ECS in commercial complex and hotel is proposed as per the MoEF norms. 34.77 % of the total area has been proposed for green area development.

Water requirement during construction phase is 30 m³/day, which shall be purchased from the private water suppliers.

- Provision for Septic tank and soak pit has to be made & furnished for management of waste expected from the temporary hutments of labours at site.
- The proposed STP needs to be upgraded to achieve desirable treatment of the sewage; accordingly proposal has to be submitted.
- Locations of STP and the MSW vermi-composting facilities may be re-considered so as to maintain hygienic conditions and avoid odour nuisance in the residential sector. Accordingly proposal has to be submitted.
- Land owner-ship documents to be submitted.
- A declaration from the consultant and PP for authentication of the supplied information to be provided.
