

Minutes of the 108th Meeting of SEIAA dated 01.10.2012

The 108th meeting of the State Level Environment Impact Assessment Authority was convened on 01.10.2012 at 10.30 AM at the Authority's Office in M. P. Pollution Control Board Building, Paryavaran Parisar, Bhopal. The meeting was chaired by Shri Amar Singh, Chairman, SEIAA. The following members attended the meeting:-

1. Following cases received from SEAC have been considered and the details of the receipt of the recommendations & record from the office of SEAC is as follows:



2. **Case No. 45/2008**, Prior Environmental Clearance for Mall Multiplex at old MPSRTC Workshop, Khasra No. 524, 525, 529, 530 & 531 Race Course Road, Gwalior (M.P.) by M/s Girija Colonizer Shri Promod Maheswari, General Manager, Special Project, Dwarka Sadan, Bhaskar Lane, Jayandra Ganj , Gwalior (MP)

- i. The case was examined and it was noted that the case was discussed in 4th SEIAA meeting dtd 16.10.08. The case was returned to SEAC for want of permission from Central Ground Water Board for abstraction of ground water and building permission from Municipal Corporation, Gwalior, MP. Thereafter, PP vide letter dtd 19.07.12 submitted the information.
- ii. The case was discussed in 101st SEAC meeting dtd 22.08.2012. it is recorded that ".....PP has submitted a permission from CGWA for abstraction of 40 KLD ground-water and letter of intent from Gwalior Municipal Corporation for supply of 200 KLD water. As all other aspects of the project have already been examined by the SEAC in the earlier meetings as referred above, committee decided to send back the case to SEIAA with earlier recommendation for grant of prior EC subject to the 8 special conditions."
- iii. The case was examined in depth and it was noted that the PP has not submitted the following information :
 - a. Notarized copy of land ownership documents and latest notarized copy of Khasra Panchsala .
 - b. PP has submitted copy of the planning permission from Town & Country Planning, Gwalior (vide letter no. 754 dtd 30.05.08), however the map approved by T & CP is not submitted. Hence, PP should submit notarized copy of map approved by T & CP, Gwalior.



- c. PP has submitted the building permission from Nagar Palik Nigam, Gwalior (vide letter no. 425/2008 X 3 /3 dtd 10.09.08), however the map approved by Nagar Palik Nigam, Gwalior is not submitted. Further it was also observed that the permission is old (2008) the validity of the said permission is over. Hence, PP should submit renewed building permission along with the maps.
 - d. It is noted that the total water requirement is 309 KLD out of which 126 KLD is recycled water and the fresh water requirement is 183 KLD. In this regard Central Ground Water Board has given permission for extraction of 40 KLD ground water vide letter no. 2268 dtd 17.09.10. Gwalior Municipal Corporation has given letter of intent for supply of 200 KLD water to PP (vide letter no. 202 dtd 07.08.12). Hence PP should submit clear NOC from Nagar Nigam, Gwalior regarding the water supply.
 - e. As per office memorandum (no. 21-270/2008-IA.III dtd 07.02.2012) of MoEF, Gol and MP Bhumi Vikas Niyam, 2012 PP has not submitted the details of width of the roads with respect to height of the building, location of fire station, NOC from the Fire Deptt. PP should also submit MOS, car parking details etc.
 - f. PP has submitted application in old format and this has since been revised. He should submit application in the format prevailing now.
 - g. The NOC from the local Fire Station as has been prescribed in the circular of Ministry of E & F, Gol mentioned in sub clause 'e'.
- iv. It was decided that PP should submit the above information latest by 30.11.12.
- 3. Case No. 397/2009, Prior Environmental Clearance for Flag Stone quarry in an area of 10.0 ha for production capacity of 58,860 m³/annum at Village-Mahatoli, Distt.-Morena M.P. by Shri Deepak Sharma, M/S Girraj Shramik Khanij Sahkari Sansthan Maryadit, Station Road Banmore Distt-Morena-476444 (M.P.).**
- i. The case was discussed in 75th SEIAA meeting dtd. 14.12.11 and it has been recorded that..... " *As per Para 7 stage III (iii) of the EIA notification, 2006, it has been clearly mentioned that public hearing shall be conducted at, or in close proximity to the site (s) in all cases. In the present case the public hearing has been conducted in Collectorate, which is about 23 km away from the site. The issue was discussed in depth and the Authority decided that public hearing should again be conducted at / or in the close proximity of the mining site as per EIA Notification. The report should be submitted within two months.*

The Authority also decided that the letter should be sent to MS, MPPCB mentioning that the public hearing should be conducted at / or in close proximity of the area in all cases in future as per EIA notification".
 - ii. The case was examined and found that in compliance of decision of 75th SEIAA meeting dated 14.12.2011 the Public Hearing was again conducted on 04.04.2012 at Village-Mahatoli, Distt. Morena M.P. which is about 0.5 Km away from mining lease area. It was also noted that the SEAC in its minutes of 101st meeting dated 22.08.2012 has mentioned that no adverse



- comments from public have been observed in the minutes of Public Hearing.
- iii. It was found that PP vide affidavit dated 08.10.2011 had committed that they will not carry out any blasting activity for mining of stone in the lease area. Hence, it was decided that no blasting should be carried out in the mining area.
 - iv. Regarding plantation it was found that out of the total 10.00 ha. mining lease area, an area of 8.005 ha. to be covered under pit and rest area i.e. 1.995 ha. to be covered under plantation as per afforestation plan by end of quarry period. The plantation program was found to be satisfactory.
 - v. The Authority accepted the recommendation of 82nd & 101st SEAC meeting dated 13.10.2011 & 22.08.2012 respectively and decided to accord Prior Environmental Clearance for Flag Stone quarry in an area of 10.0 ha for production capacity of 58,860 m³/annum for mining lease period i.e. up to 15.01.2019 only at Village-Mahatoli, Distt.-Morena M.P. by Shri Deepak Sharma, M/S Girraj Shramik Khanij Sahkari Sansthan Maryadit, Station Road Banmore Distt-Morena –M.P.
4. **Case No. 398/2009**, Prior Environmental Clearance for Flag Stone Quarry in an area of 10.0 ha for production capacity of 62,106 m³/annum at Village-Mahatoli, Distt.-Morena M.P.by Shri Suresh Singh Rajput, M/S Ganesh Khaivariyan Kamgar Udhog Sahakari Samiti, Maryadit, Station Road Banmore Distt. Morena-476444 (M.P.).
- i. The case was discussed in 75th SEIAA meeting dtd. 14.12.11 and it has been recorded that..... *"As per Para 7 stage III (iii) of the EIA notification, 2006, it has been clearly mentioned that public hearing shall be conducted at, or in close proximity to the site (s) in all cases. In the present case the public hearing has been conducted in Collectorate, which is about 23 km away from the site. The issue was discussed in depth and the Authority decided that public hearing should again be conducted at / or in the close proximity of the mining site as per EIA Notification. The report should be submitted within two months"*.
 - ii. The case was examined and found that in compliance of decision of 75th SEIAA meeting dated 14.12.2011 the Public Hearing was again conducted on 04.04.2012 at Village-Mahatoli. Distt. Morena M.P. which is about 0.5 Km away from mining lease area. It was also noted that the SEAC in its minutes of 101st meeting dated 22.08.2012 has mentioned that no adverse comments from public have been observed in the minutes of Public Hearing.
 - iii. It was found that PP vide affidavit dated 08.10.2011 had committed that they will not carry out any blasting activity for mining of stone in the lease area. Hence, it was decided that no blasting should be carried out in the mining area.
 - iv. Regarding plantation it was found that out of the total 10.00 ha. mining lease area, an area of 8.74 ha to be covered under pit and rest area i.e. 1.26 ha. to be covered under plantation as per afforestation plan by end of quarry period. The plantation program was found to be satisfactory.



- v. The Authority accepted the recommendation of 82nd & 101st SEAC meeting dated 13.10.2011 & 22.08.2012 respectively and decided to accord Prior Environmental Clearance for Flag Stone Quarry in an area of 10.0 ha for production capacity of 62,106 m³/annum for mining lease period i.e. up to 20.09.2016 only at Village-Mahatoli, Distt.-Morena M.P. by Shri Suresh Singh Rajput, M/S Ganesh Khaivariyan Kamgar Udhyog Sahakari Samiti Maryadit, Station Road Banmore Distt. Morena-476444 (M.P.).
5. **Case No. 606/2010**, Prior Environmental Clearance for Grain based Distillery (28 KLD) of Alcohol, Grain required:75-80 MT/day, IMFL bottling of 5000 cases per day and cogeneration power plant 1.5 MW area 6.07 ha at Village – Imaliya, Tehsil & District Morena (M.P.) by Shri Gaurav Chaturvedi M/s J.J. Distillers & Beverages Pvt. Ltd, Nagendra Bhawan, Narayni Bai Ki Gali, Near Nagar Palika, Duttapura, Distt.- Morena (M.P) –476001
- i. The case was discussed in 101st SEAC meeting dtd 22.08.2012 it is recorded that ".....After deliberations committee has recommended the project for grant of prior EC subject to 12 special conditions."
- ii. The case was examined and it is noted that initially the site was proposed at village Jafarabad, District Morena (area 7.75 acres) however as per SEAC recommendation for alternative site, the new site was selected by PP at village Imaliya, District Morena (area 15.0 acres i.e. 6.07 ha) and revised Form-1 was submitted and subsequently revised ToR was issued by SEAC. Accordingly in the SEIAA agenda and minutes new site (village Imaliya area 15.0 acres i.e. 6.07 ha) has been mentioned.
- iii. The Chambal Century is located 12 km from the site (DFO, Morena letter no. Ma.Chi./10/3186 dtd 11.07.12), however, the letter from Collector / EE PWD, Morena regarding distance of interstate boundary is not submitted.
- iv. The nearest forest boundary is 10 km from the proposed site (DFO, Morena letter no. Ma.Chi./10/3186 dtd 11.07.12).
- v. The total land requirement is 6.07 ha. However notarized copy of land ownership documents, notarized copy of latest Khasra Panchsala, diversion order, copy of license, permission from Industries Deptt., NOC from Gram Sabha (readable) and other document as per MP, SEIAA office memorandum (no. 964 & 966 dtd 27.01.2012) and other requisite permission for alternative site at village Imaliya have not been submitted.
- vi. The total water requirement is 1038 KLD out of which fresh water requirement is 416 KLD and recycled water 667 KLD. The source of fresh water is proposed to be met from ground water; however the permission from Central Ground Water Board for extraction of ground water is not submitted.
- vii. The public hearing was examined and it was found that there is nothing adverse.
- viii. It was noted that PP has applied for cogeneration of power plant of 1.5 MW for which 70 Tonnes per day of coal shall be required. PP should submit the

source of obtaining the coal specifying whether it will be purchased from market or link with any coal block.

ix. It was decided that :-


- a. A letter should be sent to PP for submission of all the above information by 30.11.2012.
- b. A letter should be sent to Collector / EE PWD, Morena to provide information to PP regarding distance of interstate boundary.

6. **Case No. 676/2012**, Prior Environmental Clearance for " Shalimar Swayam " of Coral Infrastructure Pvt. Ltd. at Khasra No. 4/1, 4/3, 4/4, 5/2, 6/1, 6/2, 6/3, 9/2, 9/3, 9/4, 10/4, 10/5, 10/6, 10/7, 10/8, 10/9, 11/1, 11/2, 11/3 Village – Kabir Khedi, Tehsil – Indore, Distt. – Indore (M.P.) Total Land Area – 10. 587 ha (105891.00 sq. mt.) , Total Built Up Area – 93,363.90 sq.mt. by Shri Sachin Upadhyay, M/s Coral Infrastructure Pvt. Ltd. , 210, Shalimar Corporate Centre, 8-B, South Tukoganj, Distt. – Indore (M.P.) – 452001

- i. The case was discussed in 101st SEAC meeting dtd 22.08.2012 it is recorded that ".....After examination of the documents and earlier submissions made by the PP the committee was satisfied with the EMP and other environmental aspects proposed in the project, hence decided to recommend the case for grant of prior EC subject to the 8 special conditions."
- ii. The case was examined in depth and it was noted that the PP has not submitted the following information :
 - a. Notarized copies of latest Khasra Panchsala for only 9 Khasras have been submitted and remaining 10 Khasras Khasra Panchsala are not submitted by PP.
 - b. PP has submitted the planning permission from Town & Country Planning, Indore (vide letter no. 4054/ SP/ 227/Na.Gra.Ni./2010 dtd 03.07.10), however the map approved by T & CP is not submitted. Hence, PP should submit map approved by T & CP, Indore.
 - c. It was noted that PP has not submitted the building permission. Hence, PP should submit building permission along with the approved maps by Nagar Nigam, Indore.
 - d. It is noted that the total water requirement is 1400 KLD out of which 550 KLD is recycled water from STP and the fresh water requirement is 862 KLD and it has been proposed to get 180 KLD from Municipal Corporation & to extract 682 KLD from ground water. PP is directed to seek permission of 862 KLD fresh water from Municipal Corporation.
 - e. As per office memorandum (no. 21-270/2008-IA.III dtd 07.02.2012) of MoEF, Gol and as prescribed in rule 42 of MP Bhumi Vikas Niyam, 2012 PP has not submitted the details of width of the roads with respect to height of the building. He should also submit "no objection certificate" regarding fire safety as prescribed in MoEF, Gol office memorandum dtd 07.02.2012.

- f. Since it has been proposed to make commercial use of the premises also, hence PP shall give full details regarding the details prescribed in rule 41 of MP Bhumi Vikas Niyam, 2012.
 - g. PP should submit an undertaking regarding content of data and its originality as per EIA notification, 2006 and 2009.
 - iii. It was decided that PP should submit all the above information latest by 30.11.12.
7. Regarding pending cases it was decided that the cases received from SEAC shall be considered on priority followed by the cases related to additional information in the forthcoming SEIAA meetings.


