# Minutes of the 61st Meeting of SEIAA dtd 6-7-2011

The 61st meeting of the State Level Environment Impact Assessment Authority was convened on 6th July, 2011 at 11.00 A.M at the Authority's office in M.P. Pollution Control Board Building, Paryavaran Parisar, Bhopal. The meeting was chaired by Shri Amar Singh, Chairman, SEIAA. The following members attended the meeting:-

### 1. Case No:- 447/2010

Sachin Dubey, C/o Nehru Colony, Thatipur, Gwalior- M.P. M/s Padwar Laterite and fire clay deposit mine 11.13 ha at Vill-, Teh-Bahoriband, Distt-Katni-M.P.

The case was discussed in 51st SEIAA meeting dtd 25-02-11 and it was recorded that -"The above case was considered in the 76th meetring of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority went through EIA report submitted by the Project Proponent, and also scrutinised summary report of EIA and observed that anticipated impact by the activity are not quantified and mitigative measures have not been given. It was also observed by the Authority that the Project Proponent has not submitted an attested/ notarised copy of MIning Lease and latest copy of Khasra. Hence it was decided by the Authority to write to Project Proponent to submit following documents by 15th May 2011.

- Revised summary of EIA report which should be specific to the project, mitigative measures should be quantified, year wise scheme of plantation which include species and no.of plants.
- Attested/notarized copy of Mining Lease
- iii. Attested/notarized latest copy of Khasra.

The Authority also observed that the Project Proponent has not submitted the distance of mining lease area from forest boundary and the Protected Area under Wild Life Protection Act, 1972. Hence it was decided to write a letter to DFO, Katni to inform these actual distances of Mining Lease area".

The Authority scrutinized documents submitted by the Project Proponent vide their letter No nil dtd 12-05-11 i.e. summary of EIA report; mining lease in the name of Shri Sachin Dubey and certified copy of Khasra issued by Tehsildar. It was found that:

- i) There is no dispute on the land ownership documents.
- ii) The forest area is more than 250 m away and Protected Area is 90 km away from the mining lease.
- iii) The executive summary of EIA was also examined.

The Authority accepted the recommendation of the SEAC and decided to accord Prior EC to the project with the condition that greenbelt /plantation scheme at the mining area should be carried out in 11.02 ha as shown in the summary EIA and it should be monitored at six monthly duration as per provision of the Act.

### Case No: 492/09

M/s Sanktha Prasad Dwivedi, Distt-Satna-M.P. Jura lime stone mine 29.163 ha. at village Jura, Teh- Maihar, Distt- Satna-M.P.

The case was discussed in 51st SEIAA meeting dt 25-02-11 and it was recorded that - "The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance. The Authority while scrutinizing the documents observed that -

- i. Summary submitted by the Project Proponent is not specific to the project and anticipated impacts are not in measurable term.
- ii. The Project Proponent has not submitted attested/notarized copy of Mining Lease and latest copy of Khasra (attested/notarized).

Hence the Authority decided to write to Project proponent to submit following documents by 15th May 2011:

- Summary of EIA report in which anticipated impacts should be in measurable terms and specific to the project.
- ii. Attested/notarized copy of Mining Lease
- iii. Attested / notarized latest copy of Khasra. Also submit supporting documents which clearly show the transfer

of agriculture land to the project proponent for mining activity".

The Authority scrutinized documents submitted by the proponent vide their letter No. nil dtd 11-05-11 and found that the land ownership of 29.163 ha mining area at village Jura, Teh- Maihar, Distt- Satna seems to be in private ownership. The Authority has also scrutinised the executive summary of EIA report and found that budget provision for the plantation programme seems to be very low. Hence, it was decided:

i) To write to Collector, Satna to know the legal provision on the basis of which mining lease has been granted to the proposed project on the land of private persons.

## 3. Case No 131/08

M/s Ashwin Purendrasingh Chandel, 15, Sardar Patel Marg, Alirajpur, Jhabua M.P., Behadawa Dolomite mine 8.34 ha, 4000 TPA at Vill- Behadawa, Teh-Alirajpur, Distt-Jhabua M.P.

The case was discussed in 47th SEIAA meeting dt 27-01-11 and it was recorded that—"The above case was recommended by SEAC after reconsideration in their 63rd meeting on the issue of distance of Mining Lease Area from the protected areas under Wildlife Protection Act, 1972. The DFO, Alirajpur's letter no 3586 dtd 18-08-10 specify the distance to be more than 10 K.M. Hence it is acceptable to the Authority.

Since the proposed project is located in Jhabua District, which is a border district, the Authority decided to ask the Distt. Collector to specify the distance of Mining Lease Area from the interstate boudnary by 15th March, 2011".

The Authority scrutinised the information certified copy of letter from Tehsildar, distt. Alirajpur vide their letter No nil dtd 20-05-11 and found that the distance from interstate boundary from Gujrat State is 21 km. The Authority accepted the recommendation of 63rd meeting of SEAC and decided to accord Prior EC to the proposed project.

## 4. Case No: 267/09

M/s Shri P.C. Sharma, HIG-9, Housing Board Colony, Katni-M.P., Bauxite & ochre mine 16.187 hact. at Village- Amoch, Teh- Bahoriband, Distt-Katni-M.P.

The case was discussed in 51st SEIAA meeting dt 25-02-11 and its was recorded that - "The above case was considered in 76th meeting of SEAC and recommeded for grant Prior Environmental Clearance".

The Authority while scrutinizing the documents observed that the Project Proponent has not submitted summary EIA report as indicated in Appendix III A of notification S O 1533 dtd 14 th September 2006 issued by MoEF,GOI.

It was also observed by the Authority that the Project Proponent has not submitted an attested / notarized copy of Mining Lease and latest copy of Khasra.

It was decided by the Authority to write to Project Proponent to submit following documents by 15 th May 2011:

- i. Summary Report of EIA which should be project specific.
- ii. Attested/notarized copy of Mining Lease.
- iii. Attested/notarized latest copy of Khasra".

The Authority scrutinised the documents submitted by the prponent vide their letter No nil dtd 04-06-11 and it was found that proponent has submitted exeutive summary of EIA and attested copy of mining lease. However, as stated in this letter the certified copy of the latest khasra has not been submitted by them. Only a map indicating Khasra no. has been submitted. Hence the Authority decided to write to:

i) The Proponent to submit latest Khasra details and land ownership record by 31st July, 2011.

#### 5. Case No:573/10

M/s Jain Mines & Minerals India, Pvt Ltd, 127/1, Sangam Colony, Baldeobagh, Jabalpur-M.P, Iron ore Beneficiation Plant of capacity 90,000 TPA at Hargarh, Industrial area, Teh-Sihora, -Jabalpur-M.P.

The case was discussed in 53rd SEIAA meeting dt 16-03-11 and its was recorded that "The above case was considered in 76th meeting of SEAC dt 07-01-2011 and recommended for grant of Prior Environmental Clearance

The Authority while scrutinizing the documents observed that the Project Proponent has not submitted certified / notarized copy of mining lease agreement.

It was also observed by the Authority that public hearing has not been done in this case, as public consultation is mandatory as per Gol, MoEF Notification dt 14-09-2006. Hence it was decided by the Authority to write to Member Secretary, MPPCB to conduct public hearing for the proposed case within prescribed time. Letter to Project Proponent, is to be sent to submit certified / notarized copy of mining lease agreement and latest certified/ notarized copy of Khasra . After public consultation the proponent will resubmit final EIA report and also Executive summary to the SEIAA by 30-06-2011. After this the EIA report and other documents will be sent to the SEAC for a fresh appraisal".

As per above decision letter was issued to Member Secretary, MPPCB and the Project Proponent. The Authority found that no response has been received from Member Secretary, MPPCB. However, the proponent has submitted notarized/ certified copy of lease deed allotting the land by MPAKVN Ltd, Jabalpur at Hargarh Industrial Area, Sehora (vide letter No nil dtd 23-04-11). Therefore, the Authority observed that there is no need for submitting Khasra details. Regarding the request of the project proponent that public hearing is not required as per para 7, III stage (3) (i) sub point (b) of EIA notification 2006, the issue was discussed by the Authority. It was decided that:

A letter should be sent to Principal Secretary, Commerce and Industry, to provide the notification of the establishment of Hargarh Industrial Area, Sehora.
