- (I) Cases recommended by SEAC after reconsideration
- 1. M/s S.N Sunderson and Co. , Deshbandhu Gupta Road, PBNo. 5713, New Delhi, Lime stone mine 12.78 ha. Village Ametha, Teh. Vijayraghogarh, Distt. Katni M.P. Case No.80/2008.

The above case was sent back to SEAC for reconsideration on the ground of obtaining clearance from Forest Deptt. Project Proponent has submitted the NOC from Forest Deptt. to SEAC. SEAC after reexamining, recommended the project for granting environment clearance.

SEIAA accepted the recommendations of SEAC and decided to grant environment clearance to the above project.

2. M/s S.N Sunderson and Co., 1, Deshbandhu Gupta Road, P.B. No. 5713, New Delhi, Lime stone mine 5.82 ha. At village- Badari, Teh. Vijayraghogarh, Distt. Katni -M.P. Case No.79/2008

The above case was sent back to SEAC for reconsideration on the ground of obtaining clearance from Forest Deptt. Project Proponent has submitted the NOC from Forest Deptt. to SEAC. SEAC after reexamining, recommended the project for granting environment clearance.

3. M/s S.N Sunderson and Co., 1, Deshbandhu Gupta Road, P.B No.5713, New Delhi, Limestone mine 7.09 ha. located at village- Nanwara, Teh.Vijayraghogarh, Distt. Katni -M.P., Case No.78/2008.

The above case was sent back to SEAC for reconsideration on the ground of obtaining clearance from Forest Deptt. Project Proponent has submitted the NOC from Forest Deptt. to SEAC. SEAC after reexamining, recommended the project for granting environment clearance.

SEIAA accepted the recommendation of SEAC and decided to grant environment clearance to the above project.

4. M/s Arya Energy Ltd, 12 MW capacity biomass based power plant at vill-Gohandra, Teh- Kotma, Distt- Anuppur M.P., 12 MW capacity biomass based power plant, Case No.174/2008.

The above case was sent back to SEAC for reconsideration on the ground of obtaining permission from District Administration, Anuppur to draw ground water. The same has been provided by the project proponent to SEAC. SEAC after reexamining recommended the proposal for granting environment clearance.

SEIAA accepted the recommendations of SEAC and decided to grant environment clearance to the above project.

5. M/s Bright star Infrastructure Pvt. Ltd, Indore case No. 43/2008, Residential Township project at Jatkhedi, Hoshangabad Road, Bhopal(Group Housing & Commercial Area Deve.) Case No. 43/2008.

SEAC recommended the above case for granting environmental clearance after reexamination. SEIAA after examining the record decided that the papers related to land ownership and permission need further examination and hence decided to defer the final decision till next SEIAA meeting.

- (II) Cases recommended by SEAC for granting environment clearance.
- 1. Rajmata Vijaya Raje Sindhiya, AIIMS at Bhopal, (Construction). Case No.110/2008

The above case has been recommended by SEAC for granting environmental clearance. On examination it was found that project proponent has not submitted the building permission to be granted by the Bhopal municipal corporation. Hence the case is sent back to SEAC to obtain the present status on this matter from project proponent and submit its proposal again in the light of this finding.

2. M/s Badari lime stone mine10.246 hect. Shri Ashok Kumar Dubey, Teh-Vijay raghogarh, Distt.Katni, Case No. 25/2008

The above case was recommended by SEAC for granting environment clearance after appraisal of the proposal in detail.

SEIAA accepted the recommendation of SEAC and decided to grant environment clearance to the above proposal.

3. M/s Katangjhari magnese Mines, 5.26 ha. Teh-Waraseoni, Balaghat-M.P., J K. Minerals Balaghat M.P., Case No. 7 & 51 /2008

The above case was recommended by SEAC for granting environment clearance after appraisal of the proposal in detail.

SEIAA accepted the recommendation of SEAC and decided to grant environment clearance to the above proposal.

4. M/s Ramnik Power and Alloys Pvt Ltd, C/o M/s A.P Trivedi sons, Main Road, Balaghat, 6 MW Biomass based power project at industrial Dev.area, Village -Sarandi , Distt- Waraseoni, Balaghat- M.P. Case No. 109/2008

The case has been recommended by SEAC for grant of environment clearance. SEIAA after careful scrutiny of the documents submitted by the project proponent found that the water requirement will be met from borewells, open wells and the Chandan river. However, the project proponent has not submitted a NOC to draw ground water or water from Chandan river issued by the competent authority. Hence the case is sent back to SEAC for reconsideration on the above ground.
