

- Transportation shall be carried out in covered vehicles.
  - Material shall not be transported through forest area.
  - Water quality of the nearby water bodies shall be monitored regularly on U/S as well D/S.
  - Garbage & other wastes should be collected, segregated & disposed off appropriately.
  - Regular health check-up camps shall be organized for mine workers.
  - The EC & the lease shall be limited for a period of two years only.
  - A buffer of 500 meters shall be maintained around water intake points, over-bridges and other sensitive features.
  - After completion of mining the site should be reclaimed appropriately.
  - Mining department shall ensure that PP complies with all the conditions during mining period and after completion of the mining.

- iv. It was noted that as per **Appendix-I**, certified by the Nayab-Tehsildar Timarni, there is no habitation/settlement, school building, hospital and archaeological monument at the **distance of 500 m. from the mining site.**

Harda (M.P.) by M/s BVSR Harda Betul Roads Project (P) Ltd., 8-2-686/B/11/6/1, Plot No. 9 Road No. 12, Banjara Hills, Hyderabad-500034* subject to the following conditions :-

➤ It was decided that the sand mining should be carried out at the distance 33.6 m. (168/5 m) i.e. 1/5<sup>th</sup> from the bank of the river stream.

➤ Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.



- In case if the distance is less than 250 m. it was decided that the Collector would ensure that the PP has obtained the NOC from the committee constituted under the Chairmanship of PS Forest before execution of quarry agreement/ mining.
- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.

- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
  - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
  - Scheme of removal, storage and utilization of overburden.
  - Scheme of plantation of trees.



- vi. Further it is found that SEAC has also mentioned (**115<sup>th</sup> SEAC meeting dtd. 05.01.2013**) that..... the project pertains to category B-1 as per policy decided by SEIAA as the ML period is opted for more than 2 years & due to presence of habitation & water body within 500 meters. However committee is of the opinion that in view of the size of the project the case may be considered under B-2 category through limiting the lease period. EM-Scheme has been submitted by the PP.

Chairman and the Member didn't accept the recommendation because it is inconsistent with the criteria decided by the authority in its 107<sup>th</sup> SEIAA meeting minutes dated 17.09.2012 (Para-8). However, the criteria will be revisited / reconsidered. Member Secretary agreed with the recommendation of the SEAC for considering the case under B-2 category.


