were of general nature and nothing adverse was found regarding degradation of the environment. However, following observations of the Public Hearing panel were noted:-

- ➤ There is a Dam of Irrigation Department on the western side of the lease area. There is a possibility of damage due to blasting. Hence, mining should be done after obtaining the permission from Irrigation Department so that Dam is protected from damage.
- > Blasting should be done by wet drilling process and Muffle Blasting Technique.

In context of above it was noted that SEAC has not given any recommendation on the above issue. It was decided that blasting should be done in such a manner that there is no damage to the Dam located in the vicinity of the mining site and muffled blasting technique should be adopted. The Irrigation Department should be informed to keep a watch on mining activity in context to safety of the dam.

- (ii). The total water requirement is 543 KLD & Fresh water requirement is 356 KLD & 187 KLD recycled water (120th SEAC meeting minutes). PP has applied for NOC from CGWA for abstraction of ground water (and submitted copy of query reply to CGWA letter dtd. 25.02.13). PP has also applied to Nagar Nigam Jabalpur (vide let. 12.03.13.) and Chief Engineer Rani Avanti Bai Sagar Project, Jabalpur (dtd. 12.03.13) for water supply. It is decided that the entire demand of fresh water should be met either from municipal supply or from the Rani Awanti Bai Sagar Project, Jabalpur and there should be no extraction of ground water. PP should submit clear NOC for supply of 356 KLD fresh water from Nagar Nigam Jabalpur or EE Rani Awanti Bai Sagar Project Jabalpur, MP.
- (iii). PP has proposed roof top rain water harvesting by way of constructing recharge pits and storm water harvesting structures by providing drains with inverted filters.
- (iv). The total waste water generation is 487 KLD. The waste water from hospital complex is 304 KLD. The raw effluent from the hospital is proposed to be collected in the pre chlorination tank through the screen chamber where chlorination will be done. The treated effluent will be sent to STP for further treatment. PP has provided sewage treatment plant of 500 KLD capacity. 187 KLD of treated waste water is proposed to be recycled. Case No. 545/2010, Prior Environmental Clerance for Manganese ore mine in an area of 6.985 ha for expansion of production capacity from 1000 TPA to 9720 TPA at Khasra No. 134/1, 135, 136, 207/1, 207/2, 208 at Village Hathoda, Tehsil Katangi, District Balaghat (M.P.) by Smt. Shakuntala Kasal, Ward No. 13, Main Road Waraseoni Distt. Balaghat (M.P.).
 - (1) The case was discussed in 83rd & 91st, SEAC meeting dated 08.11.2011 & 03.03.2012, and recommended in 95th SEAC meeting dtd. 08.05.2012 based on the submission of documents and presentation made by the PP the committee has recommended for grant of prior EC to the project subject to the 12 conditions.
 - (2) It was noted that the PP has applied in Form-I for Prior Environmental Clearance of Manganese ore mine (Opencast other than fully mechanized) in an area of 6.985 ha. for expansion of production capacity from 1000 TPA to 9720 TPA at Survey No. 134/1, 135, 136, 207/1, 207/2, 208 at Hathoda, Tehsil Katangi, District Balaghat (M.P.).
 - (3) It was noted that the case was discussed in 97th & 110th SEIAA meeting dtd. 20.06.2012 & 16.10.2012 respectively.

The case was discussed in 110th SEIAA meeting dtd. 16.10.2012 it has been recorded that.... " It was noted that the Prior EC for the same project for production capacity of 1000 TPA was granted by MP-SEIAA vide letter No. 168/EPCO-SEIAA/09 dated 29.07.2009. As per decision taken in 97th SEIAA the PP was asked to submit certified copy of the compliance of the conditions of the prior EC from the Regional office, MoEF, Gol.

While examining the response submitted by the PP vide letter No. nil dated 16.08.2012 it was found that the PP himself has admitted that the first compliance report has been submitted to MoEF vide Letter No. nil dated 16.08.2012. It was decided that PP should be asked why the compliance reports were not submitted earlier, because as per earlier EC letter a six monthly compliance report should be submitted to the Regional office, MoEF. The PP should also be asked to submit the certified copy of the Compliance Report from RO, MoEF by 31.12.2012 and the letter should be endorsed to RO, MoEF."

- (4) It was noted that letter was sent to PP vide letter No. 1350 dated 02.11.2012 with endt. to Director (S) Regional Office, MoEF, Bhopal. Again letter was sent to RO, MoEF vide No. 2838 dated 13.03.2013.
- (5) It was noted that the proponent has submitted reply vide L.No. nil dated 21.04.2013 & 27.04.2013 received in SEIAA office 24.04.2013 & 29.04.2013 respectively and Regional Office, MoEF, Bhopal has also provided a copy of certification of compliance vide No. 18-B-50/2012(SEAC)/592 dated 08.04.2013. The following relevant points were found in the reply:-
 - The PP has submitted thatThe Prior EC was issued on 29.07.2009 vide L.No. 168/EPCO-SEIAA/09 for 1,000 TPA and thereafter consent to operate was obtained from the MPPCB on 29.01.2010 vide No. 728/TS/Mine/MPPCB/2010 but they were not able to take any production afterward which has been validated in inspection report of Regional Office of MPPCB and certified report of Regional Office of MoEF also.
- (6) Further it was noted that the copy of the compliance report duly certified from the R.O., MoEF was submitted to SEAC vide L.No. nil dtd. 21.04.2013 and the SEAC considered the report in its 132nd meeting dtd. 14.05.2013. The SEAC has recorded that the report reveals following:-
 - Compliances and implementation of conditions is satisfactory.
 - Housekeeping is also satisfactory.
 - No court case is pending against the PP.
 - No SCN/ Closure notices have been issued for the project over the last three years. The papers may be forwarded to SEIAA for further necessary action in the matter.

As such it was found that the procedure for the consideration of expansion proposals for grant of environmental clearance under EIA notification 2006 as per MoEF Circular vide no. J-11011/618/2010-IA –II (I) dtd 30.05.2012 (Para 2 & 3) has been fulfilled.

- (7) It was found that as per Mining Plan (BGT/Mn/MPLN- 987/NGP dtd 11.02.2011) the expected life of mine is 04 years (3880 Tonnes/9720 Tonnes = 4 years) and as per notarized copy of lease deed the lease period is for 20 years i.e from 16.10.2008 to 15.10.2028.
- (8) It was noted that the Public Hearing was held on 23.07.2011 at Gram Panchayat Office, Village Mathoda, District Balaghat under the Chairmanship of Additional Collector, Balaghat. The issues raised during public hearing were

- of general nature and nothing adverse was found regarding degradation of the environment.
- (9) It was decided to accept the recommendation of 95th SEAC meeting dtd. 08.05.2012 to grant Prior Environmental Clearance for Manganese ore mine (Opencast other than fully mechanized) in an area of 6.985 ha. for expansion of production capacity from 1000 TPA to 9720 TPA at Survey No. 134/1, 135, 136, 207/1, 207/2, 208 for the maximum period of the life of mine i.e. Four years at village Hathoda, Tehsil Katangi, District Balaghat (M.P.) by Smt. Shakuntala Kasal, Ward No. 13, Main Road Waraseoni Distt. Balaghat (M.P.).
