- (2) It was noted that MOEF, GoI has issued Office Memorandum vide No. J-11013/41/2006-IA.II(I) dtd. 22nd March, 2010 regarding Time limit for validity of Terms of Reference (TORs) prescribed under EIA Notification, 2006 for undertaking detailed EIA studies for developmental projects requiring environmental clearance. The relevant part of the OM is given hereunder:-

"It has been decided that from 01.04.2010, the prescribed TORs would be **valid for a period of two years** for submission of the EIA/EMP Reports, after public consultation where so required. This period will be extendable to the 3rd year, based on proper justification and approval of the EAC/SEAC, as the case may be. Thus, an **outer limit of three years** has been prescribed for the validity of TORs with effect from 01.04.2010.

In case of the proposals, which had been granted TORs prior to the issue of this O.M. the EIA/EMP reports should be submitted, after public consultation where so required, no later than four years from the date of the grant of the TORs, with primary data not older than three years".

(3) It has been informed by the SEIAA office that following 23 cases were registered wherein as per above OM the time limit of 4 years has expired after issuing ToR, but PPs have not submitted final EIA Report in SEIAA Office as yet. As per EIA Notification 2006 PP should submit EIA Report to SEIAA Office and subsequently would be sent to SEAC Office for appraisal. Presently this procedure is in practice too.

The SEIAA Office has also examined and found that PPs have not applied to extend time limit for validity of TOR and as such the prescribed time limit is over. Hence, it has been decided that all these 23 cases are summarily rejected. The list of these cases along with details is given below:

 - (1) The case was discussed in SEIAA meeting 109th dtd 08.10.2012 & 135 dtd 04.06.13 and it is recorded that
 - (I) In response to above query, reply submitted by PP (vide letter dtd 12.12.12, 01.03.13 & 16.05.13 received in SEIAA office on 17.12.12, 01.03.13 & 16.05.13 respectively) was examined in depth and it is noted that:
 - (a) PP has submitted notarized copy of Khasra Panchsala for year 2012-2013 and it is noted that as per the Khasra Panchsala (2012-13) the total nos. of Khasras are 28 having total area of 8.604 ha. It is observed that there is difference of 0.064 ha (640 sqmt.) which is negligible in view of total project area 86682.94 sqmt. As per Khasra Panchsala the ownership of the land in the name of M/s Prabhatam Infrastructure Ltd. Co. and is satisfactory.

- (i). PP has assured that road width shall be 18 m wide in place of 12 m and parking provision of 1270 car parking shall be done. It is decided that internal roads, open spaces and parking facilities should be ensured as per MP Bhumi Vikas Rule, 2012.
- (ii). PP has submitted that the 5% construction has been done after July 2011 after receiving permission from Nagar Nigam, Bhopal.  - a. PP has submitted notarized copy of Joint Venture Agreement (dtd 27.12.12) vide letter no. 4791/2012-21/CORR/4 dtd 11.01.13 to SEAC between M/s Amardeep Builders through partner Shri Pawan Agarwal & M/s Man Developments through partner Shri Rajendra Mansukhani for development and construction of residential complex in the proposed area of 2.035 ha.
 - b. PP has submitted copy of registered development agreement (dtd 30.03.2011) between M/s Amardeep Builders through partner Shri Pawan Agarwal & M/s Man Developments through partner Shri Rajendra Mansukhani & Umesh Liliani
 - c. The total water requirement is 253 KLD (163 KLD domestic + 46 KLD, flushing + 28 KLD horticulture + 1 KLD DG set cooling + 15 KLD swimming pool). The fresh water requirement is 163 KLD. The source of water supply is ground water. SEAC in its 119th meeting dtd 02.02.13 has recommended that fresh water demand shall not exceed from 178 KLD. PP has not submitted NOC of CGWA for supply of ground water. It was decided that as recommended by SEAC the fresh water demand should not exceed 178 KLD. The entire demand of fresh water should be met

- through the Municipal Water supply and there should be no extraction of ground water. PP should submit NOC for supply of 178 KLD fresh water from Municipal Corporation, Indore.
- d. PP has provided roof top rain water harvesting system and ground water recharge pits (2 nos.).
- e. The total waste water generation is 160 KLD. PP has provided sewage treatment plant of 200 KLD capacity. The total treated waste water 128 KLD. Out of this 46KLD is used for flushing 28 KLD Horticulture + 1KLD DG set cooling + 53 KLD irrigation). It was decided that the final disposal of treated waste water should be integrated with the Municipal sewer system. PP should submit NOC from Municipal Corporation, Indore for discharge of treated waste water.
- f. Regarding fire fighting PP has proposed facilities such as fire detectors, fire water pumps, automated fire water sprinklers, fire alarm system, fire extinguisher, hydro-pneumatic fire fighting, fire hydrants etc. The nearest fire station is Kabirkhedi is approximately 3.2 km from the proposed site. It was decided that the width of internal main road within the building campus should not be less than 15 m as per MoEF, Gol office memorandum (vide no. 21-270/2008IA.III dtd 07.02.12) guidelines for high-rise buildings between 15m-30m.

- i. Approximately 1.07 tonnes per day of Municipal Solid waste shall be generated this shall be segregated at source and collected in movable bins of various sizes.
