### (3). PENDING CASES OTHER THAN MINING

- (i). It was noted that MOEF, Gol has issued Office Memorandum vide No. J-11013/41/2006-IA.II(I) dtd. 22<sup>nd</sup> March, 2010 regarding **Time limit for validity of Terms of Reference (TORs)** prescribed under EIA Notification, 2006 for undertaking detailed EIA studies for developmental projects requiring environmental clearance. The relevant part of the OM is given hereunder:-


*"It has been decided that from 01.04.2010, the prescribed TORs would be **valid for a period of two years** for submission of the EIA/EMP Reports, after public consultation where so required. This period will be extendable to the 3<sup>rd</sup> year, based on proper justification and approval of the EAC/SEAC, as the case may be. Thus, an **outer limit of three years** has been prescribed for the validity of TORs with effect from 01.04.2010.*


*In case of the proposals, which had been granted TORs **prior to the issue of this O.M.** the EIA/EMP reports should be submitted, after public consultation where so required, **not later than four years from the date of the grant of the TORs, with primary data not older than three years**".*


- (ii). It has been informed by the SEIAA office that following 05 (five) cases were registered in 2011.
- (a). **It is decided that a reminder should be issued to PP from SEIAA office to submit the final EIA Report within the validity of ToR as prescribed in MoEF, Gol office Memorandum dtd 22.03.2010 otherwise the cases will be summarily rejected. A copy of letter should be endorsed to SEAC.**


(iii). It is noted that following **6 (six)** cases registered in 2011 are pending at SEAC. The list of these cases along with details is given below. **It is decided that for case no. 633/2011, 638/2011, 644/2011, 648/2011 & 656/2011 a letter should be sent to SEAC to submit the recommendation on following points:-**

- a. If the cases are pending for want of information at PP level then recommendation to de-list the case as per MoEF, Gol, O.M. No. J-11013/5/2009-IA-II(Part) dtd. 30<sup>th</sup> October, 2012.
- b. If relevant information has been submitted by the PP the case should immediately be appraised and recommendation should be sent to SEIAA accordingly.

(iv). In case no. 652/2011 it is noted that in the 86<sup>th</sup> SEAC meeting dtd 14.12.2011 during the presentation consultant failed to submit documents pertaining to NABET accreditation and PP was asked to submit to engage NABET accredited consultant and submit requisite documents. responsible for not submitting the documents for a period of more than 06 months. As per MoEF, GoI, O.M. No. J-11013/5/2009-IA-II(Part) dtd. 30<sup>th</sup> October, 2012. It is decided that the case is summarily rejected. PP, MS- SEAC, MS-MPPCB and all concerned should be informed accordingly.


- (v). It is noted that in case nos. 644/2011 & 648/2011 (8 (b)) EIA were sent to SEAC in February 2013 and case no. 656/2011 (8 (a)) was forwarded in December 2011. It is observed that SEAC has not taken any decision regarding recommendation / rejection even after a time period about six months, while as per Para 7 stages in the prior Environmental Clearance (EC) process for new projects and subsequent sub-para (iii) of IV stage (4) – Appraisal it is mentioned that *"The appraisal of an application shall be completed by the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned within sixty days of the receipt of the final Environment Impact Assessment report and other documents or the receipt of Form-1 and Form-1 A, where public consultation is not necessary and the recommendations of the Expert Appraisal Committee or State Level Expert Appraisal Committee shall be placed before the competent authority for a final decision within the next fifteen days...."*


In the context of above it was decided to inform SEAC that such delay should be avoided and norms of EIA Notification 2006 should be adhered to.

(i). It was noted that the PP had applied in **Form-I** for Prior Environmental Clearance of **manganese ore, Iron Ore & laterite** (Opencast other than fully mechanized method) in an area of 5.0 ha. **for expansion of production capacity** from 5000 MTPA (manganese ore) to 5,00,000 MTPA (manganese ore , Iron ore and laterite) at **Survey No. 199** at Village Mansakra, Tahsil-Sihora, Distt-Jabalpur (M.P.).

.....(2) To ensure the compliance to the environmental conditions and those stipulated in NOC, it has been decided that the following appraisal procedure be followed for the expansion projects, in both the categories i.e. category 'A' and category 'B'.

(i) The TORs shall indicate the need to have a separate chapter on compliance to environmental clearance conditions and/or the NOC from the respective State Pollution Control Boards. The testing/verification undertaken for the compliance shall be from the recognized environmental laboratory;

(ii) During the discussions at TOR and EC stages, it shall be verified from the project proponents if the unit has received any notice under the Section 5 of Environment (Protection) Act, 1986 or relevant Sections of Air and Water Acts and their compliance. "

In context of above it was decided to write to the Member Secretary, MPPCB to provide the information:-


- a Status of the consent / NOC under Air & Water Act up to 31<sup>st</sup> July 2013 and compliance thereof.
- b Any notice served to the PP under the Section 5 of Environment (Protection) Act, 1986 or relevant Sections of Air and Water Acts and their compliance.


Further it was also decided to ask from the PP whether any notice has been received under the Section 5 of Environment (Protection) Act, 1986 or relevant Sections of Air and Water Acts and their compliance.


The information should be made available by **30.09.2013**.

- (iv). It was also noted that in case of expansion certified report of the status of compliance of the conditions stipulated in the EC for the existing project by the RO, MoEF is required as per OM No. J-11011/618/2010-IA-II(I) dated 30.05.2012, which PP has not provided. The relevant part of the OM regarding – Consideration of expansion proposals for grant of Environmental Clearance under the EIA Notification 2006 is as follows:-

.....(2) It has been now decided that while submitting the application for consideration for grant of environmental clearance of all expansion projects under the EIA Notification, 2006, the project proponent shall henceforth submit a certified report of the status of

compliance of the conditions stipulated in the environmental clearance for the ongoing/ existing operation of the project by the Regional Offices of the Ministry of Environment and Forests .

(3) The status of compliance of the conditions stipulated in the environmental clearance as highlighted in the report(s) will be subsequently discussed by the respective Expert Appraisal Committees during the appraisal of the expansion proposal and duly recorded in the minutes of the meeting. Applications for expansion project received without the compliance status as mentioned in para no.2 above shall not be accepted and placed for consideration before the Expert Appraisal Committees

In context of the above it was decided that the letter should be written to the Regional Office, MoEF to provide the following information by 30.09.2013

- (i) Status of the six monthly compliance report submitted by the PP till date.
- (ii) Certified report of the status of compliance of the conditions stipulated in the environmental clearance for the existing operation of the project.

**The copy of the letter should be endorsed to the PP also.**


- (v). While scrutinizing the record it was found that the information regarding the distance of the mining site from the nearest forest boundary and National Park/Sanctuary have not been provided by the PP. However, it was noted that the case was earlier registered in 2008 (**Case No. 166/2008**) and Prior EC was granted vide No. 166 dated 29.07.2009 but above information is not available in the concerned record / file.


In context of above it was decided that letter should be written to the DFO, Jabalpur to provide the information **(i) Distance of the mining site from nearest forest boundary (ii) distance of mining site from National Park/Sanctuary** by 30.09.2013. The copy of the letter should be endorsed to the PP also.





- (2) In response to above queries, reply submitted by PP (vide letter dtd 05.11.12, 24.01.13, 22.02.13, 04.04.13 & 22.05.13, received in SEIAA office on 08.11.12, 29.01.13, 28.02.13, 06.04.13 & 27.05.13 respectively) were examined in depth and it is noted that :-
- (i). The Chambal Century is located at a distance of 12 km from the site (DFO, Morena letter no. Ma.Chi./10/3186 dtd 11.07.12), and interstate boundary is located at a distance of 12.8 km (Collector, Morena letter no. 5590 dtd. 01.11.12). Hence, the general conditions as per EIA Notification 2006 are not attracted.
  - (ii). PP has submitted (vide letter dtd. 05/11/12) permission from Ministry of Industries, GoI letter dtd 21.05.2012 & copy of letter from GoMP, Commercial Tax Department (LOI) dtd 25.02.2011 and found satisfactory.
  - (iii). It is noted that PP has applied for land diversion and has submitted copy of letter from MPVPS (dtd 31.01.2013) stating that the case is being examined.
  - (iv). It is noted that in Form-1 PP has mentioned village name as "Imaliya" however, actually it is village "Firozpur" under the Gram Panchayat Imaliya for which PP has submitted Khasra Panchsala 2011-2012 and letter from Tehsildar dtd 20.02.2013. PP (vide letter dtd 22.05.2013 received in SEIAA office on 27.05.2013 point no. 4) has submitted that " Due to above misunderstanding towards common name of the village, we have written Imliya instead of Firozpur in our application form and we extend our sincere regret for the inconvenience caused." **It is decided that as submitted by PP the name of the village "Firozpur" should be taken in record for the proposed site.**
  - (v). As per the notarized copy of Khasra Panchsala 2011-2012 submitted by PP (vide letter dtd. 05/11/12) the proposed land (village Firozpur) is in the name of J.J. Distillers & Beverages Pvt. Ltd Director Shri Gaurav Chaturvedi & in individual name of Shri Gaurav Chaturvedi S/o Shri Jitendra Chaturvedi and is satisfactory.
  - (vi). PP (vide letter dtd. 22.02.13 received in SEIAA office 28.02.13) has submitted copy of ground water permission (CGWA letter no.21-4 (141)/NCR/CGWA/2012-130 dtd. 18.01.13) for abstraction of 426 m<sup>3</sup>/day of ground water with conditions and is satisfactory. **It is decided that PP should strictly follow the conditions stipulated in the NOC (CGWA letter no. 130 dtd. 18.01.13) for ground water abstraction.**
  - (vii). It is noted that the manufacturing process includes the crushing of the grains, preparation of slurry, yeast propagation, fermentation, decantation and distillation of fermentation wash. PP has proposed zero discharge technology for treatment of effluent and as such there will no generation of industrial effluent. The decantation section will comprise of centrifuge decanter for separation of suspended solid from spent slops coming out of distillation plant. The wet cake from the decanter will be taken to dryer while the slops from decanter will be collected & recycled for further evaporation, the Solids will be mixed with wet cake and used as cattle feed and condensate will be recycled back in the process. The total process will be carried out under vacuum and the vapors generated in the system will be reused to economize steam consumption through thermal vapor recompression system. The water recovered from the evaporation will be recycled in the plant (dilution of slurry, cooling tower, floor, washing, plantation etc.) and the resultant slurry is

passed through Force circulation finisher for 50-55% concentration. Resulted 50-55% concentrated spent wash is sprayed at the incinerator, where the water is evaporated and dry matter is burnt (.ppt & 101<sup>st</sup> SEAC meeting dtd 22.08.12).


- (viii). Total solid waste generation will be around 38-39 TPD wet grains, 1-2 TPD yeast sludge which is proposed to be used for cattle feed. The boiler ash (15- 20 TPD) generated shall be stored in silo and given for brick manufacturing.
- (ix). PP vide letter dtd 05.11.12 has submitted a copy of letter of coal suppliers (Shree Balaji Traders & Sethi Coal Depot.) in which it is mentioned that the supplier would provide the coal as per requirement. According to PP the boiler is designed on the basis to take feed of locally available biomass such as Millet, Tur & mustard stalks along with the rice husk & coal with the said design basis coal requirement would be reduced significantly.
- (x). It is noted that PP has not submitted the coal linkage from the Ministry of Coal. **It is decided that:-**
  - a. PP should submit what efforts he has done to obtain permission for coal linkage from the Ministry.
  - b. **Alternatively PP should be asked to inform us whether the boiler can be operated using biomass only as fuel and if yes the quantity of biomass required for the proposed project and its availability.** It is to mention that the power plants up to 15 MW based on biomass and using auxiliary fuel such as coal /lignite / petroleum products up to 15% are exempted for prior EC under EIA Notification amendment dtd 01.12.2009 (refer Para V (iii) (c) (i)). **PP should submit the information as above clarifying the use of fuel for power generation.**


(3) PP should submit the above information latest by 20.08.2013."

- (ii). **In response to above query, reply submitted by PP (letter dtd 16.07.13 received in SEIAA office on 17.07.13) examined in depth and it is noted that :-**

- (a). PP has submitted that they have proposed distillery unit wherein steam is essential requirement for distillation process which is produced through boiler. The steam which moves in the column during production of alcohol is also used at the same time for co-generation of power. The condition of coal linkage is applicable for isolated thermal power plant. To prevent the wastage of steam, power is generated as co generation in between the process of manufacturing of rectified spirit.
- (b). PP has submitted that the requirement of coal in the project is very small; such small quantity of Coal will be availed through the designated Coal Suppliers in the region, (M/s Balaji Traders & Sethi Coal Depot) who have already confirmed their eagerness to supply such small quantity of Daily requirement which does not attract coal linkage agreement. PP has submitted that in case of use of coal or bio mass at 100%, it will require 70 TPD or 95 TPD



respectively. It is proposed to use biomass as principal fuel with addition of 15% of coal, which will be about 80.75 TPD of biomass and 14.025 TPD of coal. The availability of biomass is not a question as the main raw material for distillery is grain only, therefore their husk/ stalks will be available as bio mass.

- (c). Further PP has proposed to install the high efficiency "**Fluidized Bed Combustion**" Boiler, suitable for not only Coal, but use of Rice Husk, Tur Husk, Millet & Mustard Husk. The boiler is dual fuel based, PP have proposed to use bio-mass as main fuel along with coal 15% which has been allowed also by the MoEF.
- (iii). It is noted that as per the sub Para (c) of Para V(iii) of MoEF EIA Notification as per amendment dtd. 01.12.2009 the "*(i) Power plants upto 15 MW, based on biomass and using auxiliary fuel such as coal /lignite/petroleum products upto 15% are exempt.....(ii).....(iii).....*". Hence, it is decided that as per PP's statement the power generation is based on biomass and only 15% of coal is to be used EC for Co-generation of power is not required. PP should ensure that the boiler should be designed to use biomass fuel and PP should use coal not more than 15%.
- (iv). On the basis of recommendation of 101<sup>st</sup> SEAC meeting dtd 22.08.2012 with 12 special conditions it is decided to accord prior Environmental Clearance **for only Grain based Distillery (28 KLPD) of Alcohol, IMFL bottling of 5000 cases per day** area 15 Acre (6.07 ha) at Village – Firozpur, Gram Panchayat Imaliya, Tehsil & District Morena (M.P.) by M/s J.J. Distillers & Beverages Pvt. Ltd through Shri Gaurav Chaturvedi, Nagendra Bhawan, Narayni Bai Ki Gali, Near Nagar Palika, Duttapura, Distt.- Morena (M.P) subject to specific conditions imposed by SEIAA in the earlier meetings.
- (3). **Case No. 631/2011**, Prior Environmental Clearance for Group Housing Project "Chinar Dream CT" land area 95456.68 sqmt. As per the minutes of 121<sup>st</sup> SEAC meeting dtd 05.03.2013 it is mentioned that the fresh water requirement & waste-water generation for the project has been quoted incorrectly due to typographical error the same as per the records is 467 KLD and 621 KLD respectively.

- (3) In response to the above query, reply submitted by PP (vide letter dtd 28.01.13 & 22.02.2013 and received in SEIAA office on 30.01.2013 & 26.02.13 respectively) was examined in depth and it is noted that :


(i) As per information submitted by PP (vide letter dtd 28.12.12) the total water requirement is 860 KLD and fresh water requirement is 411 KLD. PP has submitted that the project site falls in Gram-Panchayat area outside the Bhopal Municipal area located 15 k. m. away from the nearest Municipal Water supply line and 7 km. away from the ongoing Narmada pipe line. So at present it is impossible to connect project water supply line to Municipal/Narmada line particularly for this project. According to PP BMC has assured (verbally) that in future if any water supply network passes through the project area then water supply from BMC will be considered for the project.


- (4) It is decided that until the NOC for water supply from Municipal Corporation, Bhopal is not obtained and submitted by the PP, the project is summarily rejected and all concerned should be informed accordingly."


- (ii). In response to the above query, reply submitted by PP (vide letter dtd 15.07.13 & 20.08.13 received in SEIAA office on 17.07.13 & 22.08.13 respectively) was examined in depth and it is noted that :-

(a).PP was asked to submit NOC for water supply from Municipal Corporation, Bhopal with firm commitment. The letter dtd 18.08.2013 from Nagar Nigam, Bhopal submitted by PP is not the NOC / consent letter however it is mentioned in the letter that in future depending on the demand and availability water supply may be considered. **It is decided that the earlier decision taken in 135<sup>th</sup> SEIAA meeting dtd 04.06.13 is reiterated that until the firm NOC for fresh water supply (411 KLD) from Municipal Corporation is not obtained and submitted by PP, the project is summarily rejected and all concerned should be informed accordingly.**
