- v. The maximum height of the building is 18 m. PP has provided road width 12 m; Front MOS 7.5 m and side/rear MOS 6.0 m. It is decided that the width of the road and side & rear MOS should be as per MPBVR 2012 rule no. 42 table 1.

However, as per the T & CP approval issued vide letter 2577 dtd 25.04.11 for Khasra Nos. 328/2/3, 331/2, 332, 333 & 336/1 total area is 5.567 ha and is in the name of M/s Laxman Nagar Griha Nirman Sahkari Santha Samiti, Indore. As per the Khasra Panchsala 2012-13 the above khasras (5 nos.) are in the name of M/s Laxman Nagar Griha Nirman Sahkari Santha Samiti, Indore. It is decided that PP should clarify the total land area for which Prior EC is required.

A letter should be sent to Principal Secretary, GoMP, Housing and Environment giving the details of violation to take action as per office memorandum of MoEF, Gol J-11013/41/2006 IA II (I)dt. 27.06.13 & 12.12.12 (Para 5 (ii)) "to initiate credible action on the violation by invoking powers under section 19 of the Environment (Protection) Act, 1986 for taking necessary legal action under section 15 of the Act for the period for which the violation has taken place and evidence provided to MoEF of the credible action taken." The details of legal action taken by the Principal Secretary H & EN GoMP taken should be made available to the Authority by 15.12.14.
