Minutes of First SEIAA Meeting held on 7th August 08

The first meeting of State Level Environment Impact Assessment Authority was convened on 7th August'08 at 11.00 A M at SEIAA's in M.P. Pollution Control Board Building, Paryavaran Parisar, Bhopal, chaired by Shri Subroto Banerji,

The following members attended the meeting:-

- 1. Shri Mohd. Hashim, Member SEIAA
- 2. Smt. Deepti Gaur Mukerjee, Member Secretary

A. The following case recommended by SEAC for granting environmental clearance was discussed:-

• Deficient other than married accommodation in KLP at the Grenadiers Regimental Centre at Jabalpur (M.P.). case no. 15/2003.

This is a construction project to be implemented in four phases. The phase wise construction area is

On the basis of the total built up area it falls under category `B'

The SEAC has recommended grant of environment clearance on the following conditions:-

- i. Proponent shall take all measures to manage the debris and construction material in safe manner so as to maintain clean environment in and around the site.
- ii. Eco-friendly construction material to be used where ever possible.
- iii. Provision for plantation has to be made as per the norms (33% of total land).
- iv. Provision for efficient rain water harvesting should be made.

The members after looking in to the proposal in detail were of the view that Environmental Clearance to the above proposal may be granted, imposing the conditions mentioned by SEAC.

B. The following cases recommended by SEAC for rejection were discussed:-

 Mining project submitted by M/s Radheshyam Somchand Gupta for mining of Dolomite mineral, mining area 8.00 hect. at Gram Kund Sawen, Tehsil - Alirajpur, Distt- Jhabua Case No. 5/2008

SEAC mentioned that project proponent has failed to produce all information required to appraise the proposal, hence case can not be appraised. Project proponent may submit a fresh proposal with all relevant document and then only may it be considered.

SEIAA accepted the recommendations of SEAC and decided to reject the proposal.

2. 400 MW coal Bed Methane (CBM) based power plant proposed at Shahdol by M/s Western Indus Power & Mining Co. Pvt .Ltd, A-23, Defence Colony, New Delhi, case No 19/2008

SEAC has mentioned in their minutes that the following requirements were not fulfilled by the applicant:-

- i. Land has not been acquired and hence no land acquisition documents were submitted.
- ii. No certificate regarding non-proximity of site from FR/PF/sanctuary issued by Forest Deptt.
- iii. No details about the buyers of power to be generated.
- iv. Water source other than River Son has to be explored and included in ToR.

On the above grounds, SEAC has recommended rejection of the case. SEIAA accepted the recommendations of SEAC, and decided to reject the proposal.
