

Minutes of the 31st SEIAA Meeting held on 6th April, 2010

A. The Authority heard the following project proponents during the meeting

1. M/s Shanti realty Pvt Ltd, 3, Janki Nagar, Annex-A.B. Road, Indore – M.P., High-rise multi storied residential project of M./s Shanti Realty Pvt Ltd at Village Nipaniya, Indore – M.P. Khasra No. 45/1, 45/2, 45/3 & 47/1 **Case no.283/2009**

The Authority decided in its 29th meeting held on 6th February, 2010 that the project proponent should submit a firm commitment letter issued by the Municipal Corporation, Indore, regarding supply of water as per the demand.

The project proponent informed the Authority about the commitment letter issued in this regard by the Municipal Corporation, Indore. He was asked to submit the original/attested copy of the letter for consideration of the Authority.

1. M/s Shukdeo Prasad Goenka, C/o Goenka Bhawan, Station Road, Katni M.P., Laterite yellow ochre and manganese red oxide, red ochre mines fire clay 48.562 hact. Vill- Jhinna Teh- Dhimmerkhera, Distt- Katni M.P. **Case no. 153/2008.**
 - i. It was decided in its 24th meeting held on 17th November, 2009 that the Collector Katni may be ask to verify the issue of illegal mining raised during the Public Hearing and inform the Authority accordingly. But after writing twice to the District Collector, no communication has been received so far. However, the project proponent has submit a letter issued by the District Mining Officer, stating that no case of illegal mining was registered against the project proponent as per government record.

It was decided by the Authority to send the copy of the letter issued by the Mining Officer to the District Collector, Katni for authentication.
