

Minutes of the 39th SEIAA Meeting held on 26th June, 2010

The 39th meeting of the State Level Environment Impact Assessment Authority was convened on 26th June, 2010 at 4.00 P M at the Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji, Chairman SEIAA.

(A) Cases recommended for Prior Environmental Clearance

1. Shri Marutaya Balaji Steels Pvt Ltd, 5, Bentinck street Kolkata, West Bengal, Limestone mine 18.935 hect. production capacity 1,00,000 TPA at Village-Hadbadpur, Taluka Raghuraj Nagar, Distt-Satna-M.P. **Case no. 291/2009**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

2. M/s Savitri Minerals Pathak ward, Katni M.P., Laterite and Bauxite mine 8.094 ha. at Village Tikaria, **Case No. 54/2008**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents submitted by project proponent noticed that the Forest Deptt.Noc does not specify the distance of protected areas under Wildlife Protection Act 1972, from the mining lease area.

Hence it was decided to send the case back to SEAC for reconsideration on the above ground.

3. S.N.S. Minerals Ltd, Maihar, Distt- Satna M.P., Limestone & Dolomite mine 42.567 ha. Village Tamoria, Teh-Maihar, Distt-Satna M.P. **Case No.128/2008.**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

4. M/s Ghanshyam Das Mahawar, Distt-Katni-M.P., Fireclay, Laterite & silica's and mine 8.00 hact.at vill-Pindari, Teh-Dhimarkhera, Distt- Katni M.P, **Case No.184/2008**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents noticed that a photo copy of the Forest Deptt. NOC has been submitted, in stead of an attested/original one. It also does not specify the distance of protected areas under Wildlife Protection Act 1972, from the mining lease area.

Hence it was decided to send the case back to SEAC for reconsideration on the above grounds.

5. Shri Jagdish Dhaneria, 119/1 Kumawatpura, Juni-Indore M.P. Bauxite laterite ochre & clay deposit, 9.71 hact. at village Chitti, Jagir, Teh-Sirmour, Distt-Rewa-M.P. **Case No.255/2009.**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents submitted by project proponent noticed that the Forest Deptt.NOC does not specify the distance of inter state boundary from the mining lease area.

Hence it was decided to send the case back to SEAC for reconsideration on the above ground.

6. M/s Chhindwara mines Pvt Ltd, 11/1, Sarvepriy Vihar,New Delhi, Manganese Ore mine 8.776 ha. Vill-Gowani-Wadona, Teh-Sausar, Distt-Chhindwara M.P., **Case No.127/2008.**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents submitted by project proponent noticed that the Forest Deptt.NOC does not specify the distance of inter state boundary from the mining lease area.

7. Jain Energy Ltd, 5th Floor, Premlata, 39, Shakespeare, Sarani, Kotkata- 700 001, 10 MW Biomass based power project at village Sanver, Teh- Sonkachh Distt- Dewas M.P. **Case No.222/2008.**

The above case was recommended by SEAC for exemption as the above case is a biomass based power project having a capacity of less than 15 MW.

It was decided by the SEIAA to ask for a commitment letter from project proponent stating that the auxiliary fuel will not be used more than 15%. The same has been submitted by the proponent.

SEIAA accepted the recommendation of SEAC and decided to exempt the above case.

8. M/s Rajshree Power Ispat Pvt Ltd. Ist Floor Reena Apartment NH-43, Pachpedi naka, Raipur (CG), 10 MW Biomass based power project at Vill- Kherkhedi, Teh- & Distt- Shajapur-M.P. **Case No.445/2009.**

The above case was recommended by SEAC for exemption as the above case is a biomass based power project having a capacity of less than 15 MW.

It was decided by the SEIAA to ask for a commitment letter from the project proponent stating that the auxiliary fuel will not be used more than 15%. The same has been submitted by the proponent.

SEIAA accepted the recommendation of SEAC and decided to exempt the above case.

9. Jain Energy Ltd, 5th Floor- Premlata, 39, Shakespeare, Sarani, Kotkata- 700 001
10 MW Biomas based power project at village – Sonkachh, Teh- Sehare,
Distt- Sehare- M.P. **Case No .223/08.**

The above case was recommended by SEAC for exemption as the above case is a bio-mass based power project having a capacity of less than 15 MW.

It was decided by the SEIAA to ask for a commitment letter from the project proponent stating that the auxiliary fuel will not be used more than 15%. The same has been submitted by the proponent.

SEIAA accepted the recommendation of SEAC and decided to exempt the above case.

10. Ranjan Grover, Civil Line, Distt-Katni M.P. Lime stone and Dolomite mine 19.360 ha. at Village- Ametha Teh- Vijay Raghavgarh, Distt-Katni -M.P. **Case No .57/08.**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents submitted by the project proponent found that the Forest Deptt.Noc does not specify the distance of mining lease areas from protected forest (PF) areas, only distance from reserved forest has been specified.

Hence it was decided to send the case back to SEAC for reconsideration on the above ground.

11. BLA Power Pvt Ltd, 84, Mokal Chamber III, Teh-Gadarwara, Nariman point, Mumbai , 140 MW (2x70) Thermal Power Plant at Vill- Niwari Teh-Gadarwara Distt-Narsinghpur, **Case No.178/2008**

The project proponent has been accorded prior environmental clearance for 70 MW Thermal Power Plant instead of 140 MW, because the proponent does not possess sufficient land. The Project proponent has made an application that he has 77 acres of land in his possession and it is sufficient to accommodate 2x45 MW units. Since his original proposal was for 2x70 i.e. 140 MW, he may be permitted to install 2x45 MW unit at site.

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

13. Shri Raj Kishore Agarwal, C/o Ganesh Motors, Jabalpur Road, Katni M.P. Limestone and dolomite mines 18.09 ha. village- Nanhwarakala, Teh-Vijraojarh, Katni -M.P. **Case No.72/2008.**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

14. M/s Narayan Metals and Minerals, Shop No.3, Bengali Club Market, Karamchand Chowk, abalpur-M.P. Manganese Iron ore, blue dust laterite mine area 12.77 ha. at village Gosalpur Teh- Sihora, Distt-Jabalpur-M.P **Case no. 416/2009**

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

(B) Cases Deferred by SEIAA

15. Gopal Enterprises, 4-Old Palasia, A-B Road, Indore M.P., Stone Gitti mine (quarry) 7.5 ha. at Bicholi Mardana, Indore- M.P. **Case no 106/2008**

The above case was recommended by SEAC for prior environmental clearance. The case was discussed in the 38th SEIAA meeting but it was deferred till next meeting for further discussion.

SEIAA while scrutinizing the documents submitted by project proponent observed that the Forest Deptt.NOC does not specify the distance of mining lease area from the forest area.

16. Jaiprakash Associates Ltd, Distt-Rewa-M.P., Jaypee Hi-Tech costing centre
Khasra No- 641, 643 & 644 Chijwar, Rewa Road, Distt- Rewa- M.P. **Case no 442/2010**

The above case was recommended by SEAC for delisting. Since the capacity of the proposed metallurgical process unit is 18000 MT/year which is less than 30000 MT/year. The case was discussed in the 38th meeting but it was deferred till next meeting for further discussions.

SEIAA accepted the recommendation of SEAC and decided to delist the above case.

17. M/s Shukdeo Prasad Goenka, C/o Goenka Bhawan, Katni M.P. Laterite yellow ochre and manganese red oxide, red ochre mines fire clay 48.562 hect. Vill- Jhinna Teh- Dhimmerkhera, Distt- Katni M.P., **Case no 153/08**

The above case was recommended by SEAC for grant of prior environmental clearance. It was discussed in the 39th SEIAA meeting but deferred till next meeting for further discussion in the matter.
