

Minutes of the 3rd SEIAA meeting held on 25th September 2008

The third meeting of State Level Environment Impact Assessment Authority was convened on 25th Sept'2008 at 11.00 A M at Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji.

The following members attended the meeting:-

(I) Following cases recommended by SEAC for granting environmental clearance were discussed.

(A) Case No. 14/2008, Construction of Housing Project Windsor Hills at Village Dungarpur, Gwalior, submitted by M/s Assotech (P) Ltd. Noida.

SEAC has recommended the project for granting environmental clearance on following condition.

- i. The project proponent shall not exploit the ground water without prior permission/approval from Central Ground Water Board.
- ii. Eco-friendly construction material shall be used where ever possible.
- iii. Provision for efficient rain water harvesting should be made as proposed.
- iv. Provision for plantation has to be made as per the norms (33% of total land)

On examination of the case, SEIAA accepted the conditions mentioned at point no. (ii) to (iv) and decided to send the proposal back to SEAC for reconsideration of the condition proposed by it that project proponent would take permission of Central Ground Water Board after environmental clearance. SEIAA was of the view that availability of water and the possible repercussions of extracting ground water on environment should be examined before considering grant of environmental clearance. Hence SEIAA decided to return the case to SEAC for reconsideration on the above issue.

(B) Case no 43/2008, Construction of Group Housing & Commercial area development at village Jatkhedi, Bhopal submitted by M/s Bright Star Infrastructure Pvt Ltd, Indore.

SEAC has recommended the project for granting environmental clearance on following condition.

- i. The project proponent shall not exploit the ground water without prior permission/approval from Central Ground Water Board.
- ii. Eco-friendly construction material shall be used where ever possible.
- iii. Provision for efficient rain water harvesting should be made as proposed.
- iv. Provision for plantation has to be made as per the norms (33% of total land)

On examination of the case, SEIAA accepted the conditions mentioned at point no. (ii) to (iv) and decided to send the proposal back to SEAC for reconsideration of the condition proposed by it that project proponent would take permission of Central Ground Water Board after environmental clearance.

SEIAA was of the view that availability of water and the possible repercussions of extracting ground water on environment should be examined before considering grant of environmental clearance. Hence SEIAA decided to return the case to SEAC for reconsideration on the above issue.

SEIAA also decided that building permission for the proposed construction work should be sought from the project proponent by the SEAC..

C. Construction of 21 mall at Indore submitted by Shri Gurjeet Singh Chabra case no 2/2008.

D. Construction of Rai Hotel at Indore submitted by Shri Gurjeet Singh Chabra Case No.1/2008.

E. Construction of M2K Megamall at Indore, submitted by Shri Gurjeet Singh Chabra case no 3/2008.

The SEAC has recommended all the above three cases (C), (D) & (E) for granting environmental clearance on following condition.

- i. The project proponent should enter into an agreement with the Municipal Corporation clearly mentioning that Narmada Water shall be made available to the project in required quantity.
- ii. The project proponent shall not exploit the ground water without prior permission/approval from Central Ground Water Board.
- iii. Eco-friendly construction material shall be used whenever possible.
- iv. Provision for efficient rain water harvesting should be made as proposed.
- v. Provision for plantation has to be made as per the norms (33% of total land)
- vi. ECBC guide lines shall be complied according to the provision laid down therein.

On examining the cases SEIAA accepted all the above recommendations except condition no (ii), and decided that Project Proponent should ensure adequate water supply during construction and operation phase from Municipal Corporation. The SEIAA decided to grant environmental clearance to the three cases with the above specific conditions.

(II) Following cases recommended by SEAC for rejection on grounds mentioned against their names.

(F) Case No.64/2008, Sh. Rituraj Verma, Adhartal, Jabalpur, M.P. Project: Kaliwas Laterite Mine (Proposed mineral iron ore, manganese) Toposheet No.54M/15, Khasra No.1, Village Kaliwa, Tahsil Sehora, District Jabalpur Area-13.57 Ha.. The applicant is continuously absent since last 5 meetings, without intimation or valid reason.

(G.) Case No.58/2008, M/s Kunjilal Ishwari Prasad Agarwal, Village & Post-Jaitwara, District Satna- Project: Koldiha-II, Bauxite, White clay, Ochre & laterite mine of Kunjilal Ishwari Prasad Agarwal (25000 MT/A) Mining Lease Area-45.892 Ha.. The applicant is continuously absent since last 5 meetings, without intimation or valid reason.

- (H) **Case No.90/2008, M/s Ruchi Enterprises, 373, Sarva Sampanna Nagar Indore (M.P)** Project: Reclaiming of Lead Ingots through lead-Acid Battery Recycling Survey No.193/1 Gram: Navada Panth, Dhar Road Indore (M.P.). The applicant is continuously absent since last 3 meetings, without intimation or valid reason.
- (I) **Case No.95/2008, Aslam Ahamad S/o Late Shri Ishak Ahamad Mission Chowk P.O. Katni, Distt.Katni (M.P)** Project: Bhatgawan Sunehara Limestone & Dolomite Mine Lease Area 25.19 Ha. Prod.:4820 MT/A. The applicant requested for withdrawal of case, committee has accepted the request.
- (J) **Case No.182/2008, R.K. Mineral Corp. Prop.Rakesh Kumar Jain, Sawarkar Ward, Nai Basti, Katni** Kandari Lime stone and Clay mine, Distt- Sagar-Mining Lease Area-40.00 Ha. & PFR, ToR & mining plan were not enclosed with application. Committee has directed for complete submission of the documents only than the case can be considered for hearing.
- (K) **Case No.183/2008, R.K. Mineral Corp.Prop.Rakesh Kumar Jain, Sawarkar Ward, Nai Basti, Katni** Kandari Lime stone and Clay mine, village Kandari, Distt-Sagar Mining Lease area 15.04 Ha. Prod. Cap.1200 MT/A **Case No.183/2008** PFR, ToR & mining plan were not enclosed with application. Committee has directed for complete submission of the documents only than the case can be considered for hearing.
- (L) **Case No.113/2008, Sophia Real Estate Ltd, S P center C-Wing, 41/44 Minoo Desai Marg Near Radio club, Colaba, Mumbai-400 005.** Project proponent has withdrawn the case

Members of SEIAA accepted the recommendation of SEAC for rejection of the seven projects mentioned at S.No.(F) to (L) and decided to reject these cases.
