

## Minutes of the 43<sup>rd</sup> SEIAA Meeting held on 10<sup>th</sup> December, 2010

The 43<sup>rd</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 10<sup>th</sup> December, 2010 at 11.00 A.M. at the Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Amar Singh, Chairman SEIAA.

### **(A) Cases recommended for Prior Environmental Clearance**

1. Ushma Technologies Pvt Ltd, 301, Ever shine mall, Malad Vivek Road, Malad (West) Mumbai, Drug manufacturing Industrial area, Pithampur Distt- Dhar-M.P. **Case no 493/2009.**

The above project was recommended by SEAC for Prior Environmental Clearance after reconsideration.

The Authority accepted the recommendation of SEAC and decided to accord Prior Environmental Clearance to the above project.

2. M/s Dolphin marbles Pvt. Ltd, New Bus stand, Katni M.P, Marble mine 6.02 ha. at Kachhargaoon, Teh-Bahuriband, Katni M.P. **Case no 203/2008.**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

While scrutinizing the documents, it was noticed that the mining lease documents and ownership documents have not been submitted by the Proponent. Similarly a summary EIA report mentioned at Appendix III-A of EIA notification has also not been submitted.

It was decided to send the above case back to SEAC for reconsideration on the above grounds.

3. M/s Shri Govind Reality PB-5, Block `C' Mansarovar Complex, Bhopal, Shopping mall with multiplex at Bawadia Kalan Teh-Huzur, Distt-Bhopal, Total plot area 15637 sq.mt. built up area 52605 sq.mt. **Case no 508/2010.**

The above project was recommended by the SEAC for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents did not find the Rin pustika showing the ownership of land and a summary EIA report mentioned at Appendix III-A of EIA notification in the file. It was also decided to ascertain from the SEAC if the work has been already started?.

It was decided to send the case back to SEAC for reconsideration on the above ground.

4. Shri Ganesh acid Chemical (P) Ltd, Ward No-1, Mishra Nagar, Waraseoni, Distt-Balaghat- M.P., Borikheda manganese deposit 5.977 hact. at village Borikehda, Teh- Katangi, Distt-Balaghat-M.P **Case no 271/2009.**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

The Authority while scrutinizing, observed that the file does not contain the ownership of land document and a summary EIA report mentioned at Appendix III-A of EIA notification. Similarly the specific distance of Protected Area under Wild Life Protection Act has also not been mentioned.

It was decided to send the case back to SEAC for reconsideration on the above grounds.

5. M/s Savitri Minerals Pathak ward, Katni M.P. Laterite and Bauxite mine 8.094 ha. at Village Tikaria, **Case no 54/2008.**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

The Authority did not find the Mining Lease document, ownership document and the summary EIA report mentioned at Appendix III-A of EIA notification in the file.

Hence it was decided to send the case back to SEAC for reconsideration on the above grounds.

6. Shri Pradeep Jain, C/o Jain Medical store, Main market, Tendukheda, Narsinghpur M.P. Dolomite & Limestone mine 7.626 ha. Village-Kanheri, Teh- Tendukheda, Distt-Narsingpur M.P. **Case no 124/2008.**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

While scrutinising the documents the Authority noticed that the proponent has not submitted ownership document, summary EIA report mentioned at Appendix III-A of EIA Notification and the specific distance from the protected areas under Wildlife Protection Act. It was also noticed that the Mining Lease area as per Form I is 7.626 Ha. While 6.817 Ha. as per Mining Lease document. Hence it was decided to return the case to SEAC for re-consideration.

7. Shri Rajendra Krishna, Kusmariya S/o Shri Ramkrishna Kusmariya, village & post Sakor, Teh- Hata, Distt- Damoh-M.P., Dhurkheda & Puraina Kanti Lime stone deposit 15-546 at Dhurkheda & Puraina Katni, Teh- Hata, Distt- Damoh-M.P. **Case no 476/2009.**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

The Authority did not find the Mining Lease document, ownership document and the summary EIA report mentioned at Appendix III-A of EIA notification in the file.

Hence it was decided to send the case back to SEAC for reconsideration on the above grounds.

8. M/s Samdriya Builders Pvt Ltd, Samdariya House, Russel Chowk, Distt-Jabalpur-M.P, Shopping mall with multiplex, civic centre at Jai Prakash, Narayan ward scheme no-18, Distt-Jabalpur-M.P. **Case no 516/10**

The above case was recommended by SEAC in 64<sup>th</sup> Meeting, held on dt 31-08-10 for grant of Prior Environmental Clearance and the proposal was received in SEIAA office on 14-09-2010. Since SEIAA was not functional w.e.f 16<sup>th</sup> August 2010, the case was sent to MoEF for further necessary action.

After the constitution of SEIAA on 12<sup>th</sup> November 2010 this case was sent back to SEIAA for consideration by MoEF and was received on 04/12/2010. As per the provisions of EIA notification the SEIAA has to take a final decision and communicate to the proponent accordingly within 45 days from the date of receipt of recommendations from SEAC. As the prescribed period is over, it was decided to get a clarification from MoEF in light of the provision of EIA notification dated 14-09-2006 of Ministry of Environment and Forests. .

It is also observed that the proponent has completed the construction work and the building is functional before getting an Environmental Clearance. Hence it is a case of violation of the provision of EIA notification. It was decided to report the matter to the State Govt. for further action, as per law.

9. Wonderland Real Estate Pvt Ltd, 6<sup>th</sup> Floor, Treasure Island - II, Tukoganj, Main Road, Indore , Residential Township project at village Rangwasa, Indore M.P. **Case 228/2008**

The above case was recommended by SEAC for grant of Prior Environmental Clearance.

Authority while scrutinizing the document found that the project is proposed at Indore. As per the MoEF's office memorandum of 13/01/2010 and 15/03/2010, a moratorium was imposed on the projects proposed at Indore. It is also observed that the land ownership is not in the name of the firm.

It was decided to ask the Project Proponent to furnish Basic information about the project location as per the revised EIA notification dated 1<sup>st</sup> December 2009 and also clarify the issue of land ownership as mentioned above.

10. M/s Twenty first century Developers Pvt Ltd, 6<sup>th</sup> Floor, Treasure Island - II, Tukoganj, Main Road, Indore M.P. Residential Township Project at Bijalpur, Indore-M.P.  
**Case no 229/2008**

The above project was recommended by SEAC for grant of Prior Environmental Clearance.

It was observed by the Authority that the project is proposed in Indore city, on the basis of the building permission issued by Indore Municipal Corporation. Since Indore city is a critically polluted area having CEPI more than 70. The Ministry of Environment and Forests, Vide its Office Memorandum dt 26/10/2010 had imposed a moratorium up to 31<sup>st</sup> March 2011 in such type of cases. It was decided to put up the case before the Authority after further instructions from the Ministry.

11. Commissioner Municipal Corporation, Jabalpur M.P., Sanitary landfill site at Kathonda Jabalpur M.P. **Case no 108/2008.**

The above case was recommended by SEAC in 63<sup>rd</sup> meeting, held on 30-08-2010 for grant of Prior Environmental Clearance and the proposal was received in SEIAA office on 14-09-2010. Since SEIAA was not functional w.e.f 16<sup>th</sup> August 2010, the case was sent to MoEF for further necessary action.

After the constitution of SEIAA on 12<sup>th</sup> November 2010 this case was sent back to SEIAA for consideration by MoEF and was received on 04/12/2010. As per the provisions of EIA notification the SEIAA has to take a final decision and communicate to the proponent accordingly within 45 days from the date of receipt of recommendations from SEAC. As the prescribed period is over, it was decided to get a clarification from MoEF in light of the provision of EIA notification dated 14-09-2006 of Ministry of Environment and Forests.

It was decided to hold next meeting on 14<sup>th</sup> December 2010 at 3.00 p.m.
