

## Minutes of the 46<sup>th</sup> SEIAA Meeting held on 12<sup>th</sup> January, 2011

The 46<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 12<sup>th</sup> January, 2011 at 11.00 A. M. at the Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Amar Singh, Chairman SEIAA.

### **(A) Cases recommended for Prior Environmental Clearance**

Following cases were considered in the meeting:-

1. Vinod Kumar Agrawal Civil line, Mandla M.P., Dolomite mines 6.81 ha. village Kakaiya Teh. Bichhiya Distt. Mandla -M.P. **Case no.47/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.

The Authority while scrutinizing the documents has observed that the Environment Management Plan, Disaster Management Plan and Environment Monitoring Plan is very generalized. Secondly the SEAC has not expressed their opinion on any such issue. Since SEAC does not exist at present and hence after its reconstitution they should reconsider these cases and send recommendation within 45 days from the date of reconstitution.

It was also observed that the Forest Deptt.NOC issued by DFO, Mandla, vide letter no 1795 dt 31-05-2010 states that some of the Khasras are falling within 250 mts from the forest boundary. Hence it was decided to write to the Project Proponent to send the Forest Deptt.NOC up to 31<sup>st</sup> January 2011 as per the Forest Deptt. of Madhya Pradesh. circular no F5/16/81/10-3 dated 27th August 2008. The copy of the letter should be endorsed to the Forest Deptt., Mineral Resource Deptt., Housing and Environment Deptt. and concerned Collector of the district.

The Project Proponent should also be asked to submit a attested copy of the Mining Lease document upto 31<sup>st</sup> January 2011.

2. Ku. Rani Ayodhya Singh, Gwalior, 6, Usha Colony, Laskar, Gwalior, Iron ore mine, Village- Panihar, Distt-Gwalior 20.235 Ha. Khasra No.1262 **Case no 93/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.

The Authority while scrutinizing the documents has observed that the Environment Management Plan, Disaster Management Plan and Environment Monitoring Plan is very generalized. Secondly the SEAC has not expressed their opinion on any such issue. Since SEAC does not exist at present and hence after its reconstitution they should reconsider these cases and send recommendation within 45 days from the date of reconstitution.

It was also observed that the DFO's letter no. 3098 dt 05-06-2000 only states that the mining lease area is located out of forest area. It does not specify the distance of mining lease area from the forest boundary.

Hence it was decided to write to the concerned DFO, asking the distance of Mining Lease area from the forest boundary up to 15-02-2011. The copy of the letter should be endorsed to the Conservator of Forest and the Project Proponent.

3. Dargawan Quarts Deposit, Near Chhoti Devi Temple, Tikamgarh- M.P. Quart Deposit mine 12.0 ha at Dargawan Teh-Tikamgarh, Distt-Tikamgarh M.P. **Case no 171/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.

The Authority while scrutinizing the documents has observed that the Environment Management Plan, Disaster Management Plan and Environment Monitoring Plan is very generalized. Secondly the SEAC has not expressed their opinion on any such issue. 4. Balasore Alloys Ltd, Balgopalpur, Balasore, Orissa, Jarah-Motigaon Manganese ore mines 11.766 ha. village Jarah, Mohgaon, Teh- Katgangi, Distt-Balaghat M.P. **Case no 251/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.

The Authority while scrutinizing the documents has observed that the Environment Management Plan, Disaster Management Plan and Environment Monitoring Plan is very generalized. Secondly the SEAC has not expressed their opinion on any such issue. Since SEAC does not exist at present and hence after its reconstitution they should reconsider these cases and send recommendation within 45 days from the date of reconstitution.

It was also observed that the distance of Mining Lease area from forest area is not specified in the available record. Hence it was decided to write to the concerned DFO, asking the distance of Mining Lease area from the forest boundary up to 15-02-2011. The copy of the letter should be endorsed to the Conservator of Forest and the Project Proponent.

5. Dr. Subhash Agrawal, 1396 Adhartal, Jabalpur, M.P., Iron ore, manganese and limestone, village-Sakri Teh- Panagar, Jabalpur -M.P. **Case no 71/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.

The Authority while scrutinizing the documents has observed that the Environment Management Plan, Disaster Management Plan and Environment Monitoring Plan is very generalized. Secondly the SEAC has not expressed their opinion on any such issue. Since SEAC does not exist at present and hence after its reconstitution they should reconsider these cases and send recommendation within 45 days from the date of reconstitution.

The copy of the letter should be endorsed to the Forest Deptt., Mineral Resource Deptt., Housing and Environment Deptt. and concerned Collector of the district.

6. Smt Susheela Singh Satna, Limestone 8.068 Ha. Village-Piparhat, Teh- Maihar, Distt-Satna-M.P. **Case no 81/2008.**

The above project was received from SEAC on 8<sup>th</sup> December 2010, with the recommendation to grant Prior Environmental Clearance.
