

Minutes of the 4th SEIAA meeting held on 16th October 2008

The fourth meeting of State Level Environment Impact Assessment Authority was convened on 16th October 2008 at 11.00 A M at Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji.

Following cases recommended by SEAC for granting environmental clearance were discussed.

1. Case No. 12/2008, Construction of Shopping mall cum multiples at Raslakhedi Bhopal by M/s PGH International Pvt Ltd.

The case is recommended by SEAC for granting environmental clearance. SEIAA after examining the documents submitted by project proponent found that the water demand has been proposed to be met by the ground water but a no objection certificate from Central Ground Water Board has not been obtained. Hence the authority members decided to send the project to SEAC for reconsideration on the above ground.

2. Case No.55/2008, construction of shopping mall at village Misrod, Distt. Bhopal by M/s 21st Century (P) Ltd.

The case is recommended by SEAC for granting environmental clearance. SEIAA after examining the documents submitted by project proponent found that the water demand has been proposed to be met by the ground water but a no objection certificate from Central Ground Water Board has not been obtained. Hence the authority members decided to send the project to SEAC for reconsideration on the above ground.

3. Case No. 118/2008, Construction of Govt. houses at Thatipur, Gwalior by Ex. Engineer (Redensification) M.P. Housing Board, Gwalior.

The case is recommended by SEAC for environmental clearance. But the project proponent has informed in writing that they have applied for building permission and requested to defer the consideration of the project by the authority. The authority accepted the request of the project proponent and decided to consider the case in the next meeting.

4. Case No. 45/2008, Construction of Mall cum Multiplex at old MPSRTC workshop, Gwalior by M/s Girija colonizers, Gwalior.

The case is recommended by SEAC for granting environmental clearance. SEIAA after examining the documents submitted by the project proponent observed that copy of the building permission by Municipal Corporation Gwalior, has not been submitted. It was also noted that Gwalior Municipal Corporation has given a commitment to the project proponent that water will be provided after two years. The project proponent has mentioned that ground water will be used during this period of two year i.e. during construction phase. But a no objection certificate from Central Ground Water Board has not been obtained.

Hence SEIAA has decided to send the above case to SEAC for reconsideration on above two grounds.

5. Case No. 13/2008, construction of integrated township at village Sulakhedi and Mundlabagh Teh. Sanwer, Distt. Indore by DLF Ltd, Indore.

The case is recommended by SEAC for environmental clearance.

SEIAA during examination of the documents submitted by the project proponent observed that it is proposed to use the ground water and the project proponent has mentioned that he has applied for a no objection certificate to draw ground water from Central Ground Water Board.

SEIAA decided to send the proposal back to SEAC for reconsideration and resubmit after the project proponent has received the NOC from CGWB.

6. Case No.53/2008, Bulk sample process plant at Chhatarpur distt. By M/s Tinto Exploration India Ltd., New Delhi.

The above case was sent to SEAC for reconsideration on certain grounds. SEAC in their meeting held on 25th September 08 reconsidered on the points raised by SEIAA and have again recommended the case for environmental clearance.

SEIAA after taking note of the SEAC's recommendation decided to accord environmental clearance to the above project.

7. Case No. 16/2008, Installation of Bulk Drug manufacturing unit at Malanpur Industrial area by M/s Tewa API India.

The case has been recommended by SEAC for Environmental clearance.

It is mentioned by the project proponent that the hazardous waste generated will be disposed of within their premises itself. SEIAA members decided to send the case to SEAC for re examination on the issue of hazardous waste management at site.

8. Case No. 78/2008, Limestone mine area 7.09 hect. Located at village Narwara Teh-Vijayraghagrah Distt. Katni, by M/s S.N. Sunderson & Co., New Delhi

9. Case No.79/2008, Lime stone Badari mine area 5.82 hect. Located at village-Badari , Teh. Vijayraghogarh, Distt. Katni -M.P. by M/s S.N. Sunderson & Co. New Delhi

10. Case No. 80/2008, Lime stone mine, area 12.78 hect. Village Ametha, Teh-Vijayraghogarh Distt. Katni by M/s s S.N. Sunderson & Co. New Delhi

All the above three projects menioned at Sr.no. **8, 9 & 10** pertain to mining of limestone. SEAC has recommended all these three mining cases for granting environmental clearance.

SEIAA examined the cases in detail on the basis of the documents submitted by project proponent and was of the view that considering to the proximity of the site to the forest area, a no objection certificate from forest deptt. should be obtained by the project proponent. SEIAA decided to send all the above three cases back to SEAC for reconsideration on above ground.
