Minutes of the 90th Meeting of SEIAA dated 13.04.2012

The 90th meeting of the State Level Environment Impact Assessment Authority was convened on 13.04.2012 at 02.30 AM at the Authority's office in M. P. Pollution Control Board Building, Paryavaran Parisar, Bhopal. The meeting was chaired by Shri Amar Singh, Chairman, SEIAA. The following members attended the meeting:-

1. Case No. 429/2009, Prior Environmental Clearance for Granite Quarry in an area of 5.00 ha for production capacity 10,000 MTA at village Bansia, Tehsil Loundi, District Chhatarpur, M. P. by M/S Bhagyawanti Granite & Stone Pvt. Ltd. at Chhangeraja House, Benisagar, Panna, M. P.

The case was discussed in 49th SEIAA meeting dtd. 10.02.11 and it has been recorded that "The case was recommended by SEAC after consideration in the 71st meeting held on 13th December, 2010.

The Authority while scrutinizing the documents observed that the EIA report submitted by the proponent is very general and vague and not the project specific. Hence it was decided to ask the Project Proponent to resubmit a detail EIA, (by 31 st May, 2011) which should be as per the manual issued by MoEF prescribed for the specific activity. It was observed that the Forest NOC is a photocopy, hence it was decided to verify above document from the concerned DFO.

It was also observed that land ownership of Khasra No. 677 of 5 ha at village Bansia, Tehsil Loundi, Distl Chhatarpur is not mentioned in the lease document hence it was decided to issue a letter to Collector, Chhatarpur to confirm ownership of the prescribed land. Collector should also be asked to intimate the distance of the mining area from the interstate boundary."

The Member Secretary, MP Pollution Control Board has issued consent for establishing the granite quarry (vide their letter no. 1912 -13 /TS/MPPCB/Mine-Sagar/2011 dtd 28.02.2011) mentioning that permission to establish is granted in view of deemed Environmental Clearance as per provision of the EIA notification and recommendation of the SEAC meeting dtd 13.12.2010. The permission shall be treated as cancelled if SEIAA denies Environmental Clearance. The fact is that the case was discussed in 49th SEIAA meeting dtd 10.02.2011. Therefore, the Authority decided that a letter should be sent to Member Secretary, MPPCB to seek clarification how the consent for establishment was issued on 28.02.2011 while the SEIAA meeting was held on 10.02.2011?

The Authority examined the letter (no. 129/ mining / 2012 Chhatarpur dtd 25.01.2012) of the office of the Collector and found that inter state boundary is 35 km in the north direction and 50 km in the western direction. The notarized copy of the letter of the DFO (General), Forest Division; Chhatarpur issued on 29.11.2010 was examined by the Authority and it was noted that the proposed site is 21 km from Ken Ghariyal Sanctuary. Thus SEIAA has the jurisdiction. The Authority also found that the proposed mining site is located 1.75 km away from the nearest forest boundary.

The Authority also scrutinized the Khasra Panchsala and mining lease. The entire land belongs to government land.

The public hearing was also examined and the Authority found no adverse remark. The plantation program was also found satisfactory.

Based on the recommendation of SEAC in its 71st meeting dtd 13.10.2010, the Authority decided to grant prior Environmental Clearance for granite quarry in an area of 5.00 ha for production capacity 10,000 MTA at village Bansia, Tehsil Loundi, District Chhatarpur, M. P. by M/S Bhagyawanti Granite & Stone Pvt. Ltd. at Panna, M. P.

Case No 437/2009, Prior Environmental Clearance for Lime Stone & Dolomite mine in 5.97 ha for production capacity of 13,000 TPA at Baragaon Tehsil Barwara District Katni, MP by M/s Ashok Goenka Station Road Distr-Katni MP.

The case was discussed in 76th SEIAA meeting dtd. 15.12.11 and it has been recorded that "It has been mentioned that after deliberations, the EMP proposed by the PP appears to be satisfactory. Based on the information provided and presentation before the committee, the case has been recommended for prior EC with five special conditions. The Authority examined the proposed plantation as mentioned in EIA and found it satisfactory. The public hearing was also found satisfactory. The Authority also examined the land records and it was revealed that application is related to Ashok Goenka while Santosh Kumar Mehar S/o Shri Ashok Kumar has been mentioned in Rin-Pustika. Thus there is difference in the name. Therefore, the Authority decided that justification should be obtained by the Project Proponent within one month in this regard".

The Authority examined the Rin-Pustika and the application of the PP received in the office of the SEIAA dtd 11.01.2012. The Authority also examined the Khasra Panchsala submitted by the PP in the office of SEIAA on 13.02.2012. It was found that संतोष कुमार ना. बा. वल्द अशोक कुमार वली मा. मु. किरन ध. प. स्व. अशोक कुमार has been mentioned in the Khasra nos. 111/2 & 119. The fact is that Ashok Kumar is signing on all the documents. The Authority decided the letter should be sent to the PP to get a certificate from the Tehsildar, Barwara about clarification on स्व. अशोक कुमार. The endorsement letter should also be sent to Tehsildar, Barwara, District Katni.

Case No. 466/2009, Prior Environmental Clearance for Suddi Laterite, Red ochre fire clay and red oxide mine in an area of 6.00 ha for production capcity 10,000 TPA at village Suddi Teh- Murwara, Distt-Katni-M.P by Shri Ankush Pathak, Shanti Bhawan Pathak Ward, Distt-Katni-M.P.

The case was discussed in 80th SEIAA meeting dtd. 18.01.12 and it has been recorded that "The Authority scrutinized letter dtd. 24.03.11 from DFO, Katni and found that the National Park Bandhavagarh is about 60 km from the proposed site. Thus the SEIAA has the jurisdiction. The Authority also examined that distance of the mining area is more than 250 m from the proposed forest boundary. The Authority scrutinized the plantation program as given in EIA Report and found that the proposed yearly plantation program of total 1.98 ha of the mining lease area is satisfactory. The Public

Hearing document was also scrutinized by Authority and it was found there is nothing adverse in the public hearing.

The Authority examined notarized copy of Khasra map, mining transfer lease deed, order issued by Mineral Resource Deptt., GoMP dtd. 27.07.10 regarding allotment of the mining lease and photocopy of the initial lease deed. The Authority decided that PP should submit notarized copy of Khasra Panchsala and initial mining lease deed within one month."

The Authority examined the notarized copy of Khasra Panchsala and initial lease deed submitted by PP dtd 13.02.2012 and found that the lease deed for Khasra No. 84 area 6.0 ha village Suddi, district Katni for mining of laterite, red ochre, fire clay, red oxide for 20 years w.e.f. 13.10.2002 to Shri Ramjan Bhai. As per mineral resource deptt. GoMP order (no. F-3-11/2002/12/2 Bhopal dated 27.07.2010) the mining lease for remaining period has been transferred to Shri Ankush Pathak for which transfer lease deed has been made on 31.01.2011.

Based on the recommendation of SEAC in its 77th meeting dtd 25.08.2011 issued in the name of Shri Ramjan Bhai the Authority decided to grant prior Environmental Clearance for laterite, red ochre fire clay and red oxide mine in an area of 6.00 ha for production capcity 10,000 TPA at village Suddi Teh-Murwara, Distt-Katni-M.P by Shri Ankush Pathak, Shanti Bhawan Pathak Ward, Distt-Katni-M.P.

 Case No. 575/2010, Prior Environmental Clearance for Bulk Drugs Unit at Plot No. 825-826 Industrial Estate Sector 3, Village & Tehesil Pithampur, District Dhar, MP by M/s Namokar Specialty Chemicals (P) Ltd (Unit-II) B-82-MIG Colony, A B Road Indore-M.P.

The case was discussed in 74th SEIAA meeting dtd. 01.12.11 and it has been recorded that " The Authority has gone through the letter received from office of the Collector, Dhar (vide no. 11488/RM/2011, Dhar dtd. 04.11.2011) mentioning that distance of the project from Indore Municipal Corporation is 36 km and Rau Municipal Corporation is 32 km. Hence, general condition does not apply.

While scrutinizing the documents it is observed by the Authority that public hearing of the proposed case has not been conducted. The Authority decided to write a letter to Industries Deptt. with a copy to proponent to submit following information with in one month -

- a. Copy of notification for declaration of Industrial Estate Sector 3- Vi Teh-Pithampur, Distt-Dhar-M.P.
- b. What types of activities are allowed and what are disallowed in this Industrial Estate."

The project site is located in notified industrial area. As per notification issued by Commerce Industries and Employment Deptt., GoMP (letter no. 154/ 165 /2012 / B-11 dtd. 18.01.2012) the proposed activity is not prohibited in the industrial area. Hence, public hearing is not required.

The Authority scrutinized the documents and EIA summary submitted by PP. The Authority considered the special condition no. 3 recommended by SEAC (i.e. all vents should be connected to a common collection / scrubbing system so as to ensure that no fumes are allowed to go into environment) in 76th meeting

dtd 07.01.2011 while recommending the case for grant of prior EC. The Authority decided to accord prior EC to the proposed manufacture of bulk drugs such as- Diclofenac (Sodium)-300 TPA, Diclofenac (Potassium)-40 TPA, Aceclofenac – 36 TPA and Phenyl Propanolamine, Oxime & others – 8 TPA and by-products – Hydro Chloric Acid, Aluminum Poly Chloride and Potassium Chloride.

Case No 628/2011, Prior Environmental Clearance for M/s Paras Life styles Pvt. Ltd E-2/69, Arera Colony Bhopal, MP High Rise Building Development, Bawadia Kalan, Tehsil Huzur Bhopal, MP.

The case was discussed in 76th SEIAA meeting dtd. 15.12.12 and it has been recorded that "The Authority has gone through the documents submitted by PP. It is observed that water requirement will be met from ground water and municipal line. The PP has submitted NOC from CGWA for 400 cum / day. It was decided that a letter should be sent to PP to submit following information within one month:-

- a. Commitment letter from Municipal Corporation, Bhopal for water supply.
- b. Approved layout plan of the project from T & CP."

The Authority scrutinized the documents submitted by the Proponent and it was observed that the Proponent has obtained CGWA permission for extraction of 400 m³ / day ground water and also obtained permission from Bhopal Municipal Corporation for municipal supply of 300 KLD water. However, as per the information given by the Proponent during the presentation the total water demand (including potable and non-potable water) is 290.13 KLD that can be fulfilled only from municipal supply. The Authority decided that a clarification from Proponent should be asked mentioning that the permission of water requirement has been obtained for 300 KLD water supply from BMC, then why permission for 400 m³ per day has been obtained from CGWA?

While scrutinizing the documents, the Authority observed that height of the building is 42 m as shown in the approved map of Town & Country Planning Deptt. Hence, the Authority decided that the Proponent should submit information in relation to minimum width of road, as per office memorandum issued by MoEF, GoI (no. 21-270/2008-IA.III dtd 07.02.2012) and submit certificate obtained from Bhopal Nagar Nigam regarding distance of the nearest fire station from the proposed project. The Proponent should submit all the information within one month.

It was also decided by the Authority that a letter may be issued to Principal Secretary, Home and head of State Disaster Management Authority seeking details on point no. VI of office memorandum issued by MoEF, GoI (no. 21-270/2008-IA.III dtd 07.02.2012) regarding Guidelines for High rise buildings and its applicability for high rise buildings.

Meeting ended with a vote of thanks to the Chair.
