

The meeting was called upon exclusively for considering the applications of mining projects having mining lease area less than 5 hectare. The meeting conducted on 5th January 2013 was presided over by Shri S.C. Jain. Following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

Consideration of the Projects:

These are the mining projects with lease area less than 5 hectare. The applications were forwarded by SEIAA for screening, scoping and appraisal as per the policy decided by SEIAA for such projects. The cases were taken up the committee one by one.

1. **Case No. 967/2012 – Shri Antar Singh S/o Shri Shankar Singh Village Bhortia Tehsil & Distt Alirajpur (M.P) 457887** Sand Mines- area- 0.90 Ha Capacity- 36000 m³ at Survey No. 262 Village Dewalni Tehsil- Sondhwa Distt. Alirajpur (M.P)

The project pertains to mining of sand in an area of 0.90 hectare and production capacity to the tune of 36000 m³ per year. It was reported by the PP that the sand quarry has been allotted to them through auction for a period of 02 years. After deliberations on salient features of the project and the EMP suggested by the PP committee has principally agreed to recommend the case for grant of prior EC. The PP was asked to submit the information in the prescribed format-1 duly verified by DFO and Tehsildar/SDM. The case shall be forwarded to SEIAA only after receipt of the requisite information from the PP.

The project pertains to mining of sand in an area of 2.0 hectare and production capacity to the tune of 45000 m³ per year. It was reported by the PP that the sand quarry has been allotted to them through auction for a period of 02 years. After deliberations on salient features of the project and the EMP suggested by the PP committee has decided to recommend the case for grant of prior EC subject to the following conditions:

1. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
2. Transportation of material shall be done in covered vehicles.
3. Curtaining of site shall be done using appropriate media.
4. Production shall be to the tune of 45,000 m³/annum.
5. Sieve or any other sizing device shall not be allowed in the mining lease area.

6. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
7. The validity of the prior EC & the lease shall be for a maximum period of two years only.
8. Transportation shall not be carried out through forest area.
9. PP shall take CSR activities in the region through the 'Gram Panchayat'.
10. The amount towards EMP shall be deposited with the Collector for further execution of the activities under EMP.

3. Case No. 965/2012 Shri Nosad Ahmed S/o Late Shri Imteyaz Ahmed M/s VIL Limited, B-5/21, Vishal Khand -5, Gomati Nagar, Lucknow (U.P.) – 226010 Lease Area – 1.0 Ha. Mandla to Pindrai & Salimnabad- Vilayat kalan Road (MDRs) on BOT (Annuity) basis project Murum Quarry of M/s VIL Limited Stone Mine at Kh. No. – 509, Patwari Halka No.- 06, at Village – Sarrapariya, Th. – Nainpur, Distt.- Mandla (M.P.) production capacity of 10,000 Cubic Meter , Mining Lease for - 02 Year.

The case pertains to mining project with lease area less than 5 hectare. The case was appraised as per the Policy decided by SEIAA. PP of the project along with the representative from M.P. Road Development Corporation presented the salient features of the project. The mining is linked with the road project of M.P.S.R.D.C. It was reported by the PP that the lease period has been opted for 02 years.

The project pertains to mining of Stone in an area of 1.0 hectare and production capacity to the tune of 10000 m³/ Year. It was also reported that a mobile crusher shall be used for sizing of the stone wherever required. Certified information in format has been submitted.

Based on the information provided by the PP, the project pertains to category B-2 as per policy decided by SEIAA. EM-Scheme has been submitted by the PP.

After deliberations on salient features of the project and the EMP suggested by the PP committee has decided to recommend the case for grant of prior EC subject to the following conditions:

1. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
2. Transportation of material shall be done in covered vehicles.
3. Curtaining of site shall be done using appropriate media.
4. Wet drilling method shall be adopted.
5. Crusher or any other sizing device shall not be allowed in the mining lease area.
6. The mobile crusher proposed to be used for sizing of the stone shall be provided with necessary pollution control measures.
7. The pits formed after the mining shall be appropriately developed into water body which should properly fenced and safe for easy access for the local residents.
8. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
9. The validity of the prior EC & the lease shall be for a maximum period of one year only.
10. Transportation shall not be carried out through forest area.
11. PP shall take CSR activities in the region through the 'Gram Panchayat'.
12. The amount towards EMP shall be deposited with the Collector for further execution of the activities under EMP.

The project was discussed in the earlier meeting dated 18/12/2012. PP was asked to submit clarification along with appropriate authority letter in name of the persons presenting the case before the committee. PP has submitted memorandum of Article along with the requisite authority letter. The submission made by the PP was accepted by the committee and the representative of the company was allowed to make the presentation before the committee.

The project pertains to mining of Stone / boulders in an area of 2.42 hectare and production capacity to the tune of 50000 m³ per year. It was reported by the PP that the stone quarry shall be leased to them for a period of 02 years. Certified information in format has been submitted. There are no adverse comments. The project falls under B-2 category as per the policy of SEIAA. EM-Scheme has been submitted by the PP.

After deliberations on salient features of the project and the EMP suggested by the PP committee has decided to recommend the case for grant of prior EC subject to the following conditions:

**Discussion on the requests / affidavits submitted by Project Proponents in
context to change in their project plan**

It was observed that these projects due proposed crushers in MLA and /or opted lease period of more than 02 years fall under B-1 category. During meeting the proponents have requested the committee to consider their projects under category B-2, accordingly these proponents have submitted an affidavit stating that crushers shall not be installed in the MLA and the lease period shall be reduced to 02 years only. The affidavits received were placed before the committee for scrutiny and further action in the matter. Case wise recommendations made by the committee are as follows:
