

Scrutiny and discussion on the responses could not be taken up due to shortage of time in the 121<sup>st</sup> SEAC meeting dated 28/02/2013. Hence it was decided by the committee unanimously that Shri A. P. Srivastava, Member SEAC and the Member Secretary may hold a meeting on convenient date to scrutinize, discuss and dispose the responses received against queries raised by the committee during appraisal of these cases.

Accordingly, the sub-committee comprising of Shri R.K. Jain, Member Secretary SEAC and Shri A.P. Srivastava, Member SEAC met on 5<sup>th</sup> March 2013 in the office of MPPCB, Bhopal. Project wise observations and recommendations are summarised below:

1. Case No. 1010/2012 (SEAC 115<sup>th</sup> Meeting dt 05<sup>th</sup> Jan 13) Smt. Somvati Bai, W/o Shri Kodulal, Village- Malakhedi, Tehsil & Distt. Hoshangabad- Lease Area –02.609 Ha. Soil - Mud Quarry at Khasra No. –530/1 at Village- Malakhedi, Tehsil & Distt. Hoshangabad (M.P) production capacity of 8,000 m<sup>3</sup> /Year, Mining Lease for – 02 Years.

The case was dealt in 115<sup>th</sup> meeting dated 05/01/2013. The project pertains to mining of Soil-Mud in an area of 2.609 hectare and production capacity to the tune of 8000 m<sup>3</sup> per year. It was reported by the PP that the mud quarry has been allotted to them for a period of 02 years. After deliberations on salient features of the project and the EMP suggested by the PP, SEAC agreed in principle to recommend the case for grant of prior EC. The PP was asked to submit the information in the prescribed format-1 duly verified by DFO and Tehsildar/SDM. It was decided by the committee that the case may be forwarded to SEIAA after receipt of the requisite information. PP has submitted the requisite information along with the supporting documents. The sub-committee found the information in order. Accordingly, the recommendation of SEAC may be sent to SEIAA for grant of prior EC subject to following special conditions:

- The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
- PP shall be responsible for the discrepancy, if any, in the submissions made by the PP to SEAC & SEIAA.
- Transportation of material shall be done in covered vehicles.
- Curtaining of site shall be done using appropriate media.
- Production shall be to the tune of 8000m<sup>3</sup> /annum and the average depth of the pit should not exceed 1.50 m from the ground level.
- The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
- The validity of the prior EC & the lease shall be for a maximum period of two years only.
- Transportation shall not be carried out through forest area.
- PP shall take CSR activities in the region through the 'Gram Panchayat'.

2. Case No. 757/2012 (SEAC 101<sup>st</sup> Meeting dt. 22<sup>nd</sup> Aug. 2012 ) Shri Sube Singh S/o Shri Jam Singh, Village- Akola, Tehsil – Alirajpur, Distt. – Alirajpur (M.P.) 457887 - Sand Quarry at Survey No.228, Village –Akola, Tehsil – Alirajpur, Distt. – Alirajpur (M.P.) Lease Area - 2.0 Ha. Capacity – 50 Cubic Meter Per day

The project pertains to mining of sand in an area of 2.0 hectare and production capacity to the tune of 50 m<sup>3</sup> per day or 15000 m<sup>3</sup> per year as per the application form-1. It was reported by the PP that the sand quarry has been allotted to them for a period of 02 years. The mining is proposed from a local river 'Urr'. The case was discussed in the 101<sup>st</sup> meeting of SEAC dated 22/08/2012. However, the decision on the matter was not taken in absence of final guidelines from SEIAA. The file was returned to SEIAA for further action in the matter after finalization of the guidelines. The project file was re-forwarded by SEIAA for appraisal in view of finalized guidelines. PP has submitted the requisite information in prescribed

Format-1 duly validated by the DFO and Tehsildar. The submissions made by the PP were

satisfactory and in order, hence it is decided to **recommend** the case for grant of prior EC subject to following special conditions:

1. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
  2. PP shall be responsible for the discrepancy, if any, in the submissions made by them to SEAC & SEIAA.
  3. Transportation of material shall be done in covered vehicles.
  4. Curtaining of site shall be done using appropriate media.
  5. Production shall be to the tune of 15000 m<sup>3</sup>/annum.
  6. Sieve or any other sizing device shall not be allowed in the mining lease area.
  7. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
  8. The validity of the prior EC & the lease shall be for a maximum period of two years only.
  9. Transportation shall not be carried out through forest area.
  10. PP shall take CSR activities in the region through the 'Gram Panchayat'.
  11. The amount towards EMP shall be deposited with the Collector for further execution of the activities under EMP
3. Stone /Boulder Quarry (New) at Khasra No. – 50/2/2, at Village – Habib Nagar, Tehsil – Nasrullaganj, Distt.– Sehore (M.P.) production capacity of 10,000 cubic meter per year.**

This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of stone boulders is proposed in the project in mining lease area of 0.809 Ha. Production capacity proposed is 10000 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The matter was dealt in detail during the 114<sup>th</sup> SEAC meeting held on 04/01/2013 and TOR was recommended in accordance to the prevailing guidelines of SEIAA. However, in view of revised guidelines the case was reconsidered after receiving the requisite information from PP. Proponent has submitted information in format-1 duly validated by the Tehsildar and DFO. This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of stone boulders was proposed in the project in mining lease area of 3.0 Ha. Production capacity proposed was 15000 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP revealed that mining of stone boulders was proposed in the project in mining lease area of 1.980 Ha. Production capacity proposed is 8000 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The matter was dealt in detail during the 114<sup>th</sup> SEAC meeting held on 04/01/2013 and TOR was recommended in accordance to the prevailing guidelines of SEIAA. However, in view of revised guidelines the case was reconsidered after receiving the requisite information from PP. The case has been forwarded to SEIAA as per the recommendation of committee in 117<sup>th</sup> meeting dated 16<sup>th</sup> January 2013. The original papers may be forwarded to SEIAA for further necessary action in the matter.

8. Case No. 727/2012- (101<sup>st</sup> meeting 22<sup>nd</sup> August 2012) **M/s RSPL Limited, 109/366, R.K. Nagar, G.T. Road, Kanpur –208012 (U.P.) Project : Optical Brightener Location at Plot No. 42-46 and 49-53, MPAKVN Sector- K, Sidhgawan Growth Centre- Sagar (M.P.) - 470004 Total Plot Area- 44000.0 sqm., Production Capacity – 4050 MTPA For –ToR Env. Consultant – ASCENSO Management and Consulting Services Pvt Ltd, New Delhi.**

The case was placed in the 101<sup>st</sup> meeting of SEAC. Whereby PP was asked to resolve following issues for further consideration of the project:

- The land belongs to M/s Rohit Surfactants Ltd. whereas the application for prior EC was made in the name of M/s RSPL.
- Consultant engaged by the PP was not qualified for proposed sector.
- The proposed Optical Brightener unit consists of other (detergent) units, hence integration of all the units have to be considered while framing / designing the proposed TOR and relevant documents.

PP has submitted satisfactory clarification for the above issues hence may be called upon for presentation on salient features of the project and proposed TOR in the next meeting as per turn.

9. This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of stone boulders is proposed in the project in mining lease area of 4.0 Ha. Production capacity proposed is 15000 T / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The matter was dealt in detail during the 101<sup>st</sup> SEAC meeting held on 22/08/2012 and TOR was recommended in accordance to the prevailing guidelines of SEIAA. However, in view of revised guidelines the case was reconsidered after receiving the requisite information from PP. Proponent has submitted information in format-1 duly validated by the Tehsildar and DFO. The submissions made by the PP were found satisfactory and acceptable hence, it is decided to recommend the case for grant of prior EC subject to following special conditions:

- a. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- b. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.

- c. PP shall be responsible for the discrepancy, if any, in the submissions made by the PP to SEAC & SEIAA.
- d. Transportation of material shall be done in covered vehicles.

10. Case No. 607/2010 (SEAC 100<sup>th</sup> Meeting dt. 21<sup>st</sup> Aug. 2012) M/s IVRCL, Infrastructures & Project Ltd. (Mining Division) Vijaynagar Colony, Hyderabad (A.P.) Mining of Basalt Rock Total Lease Area - 37.5 ha. Village – Rangwasa, Teh. Depalpur, Distt. Indore.

The case was discussed in detail in the 100<sup>th</sup> meeting of SEAC dated 21/08/2012. Whereby PP was asked to resolve following issues for further consideration of the project:

1. The mining lease is reported to be valid only up to February 2013; the validity of prior EC shall then be restricted only up to February 2013 where as it was reported by the PP that the construction and completion of the road project shall take more time, hence the PP was asked to give a written request regarding the completion time line of the project so as to decide the validity of prior EC.
2. NOC from the concerned DFO has to be furnished for starting the project.
3. Regarding CSR activity proposed in the project the PP should submit activity-wise fund allocation in co-ordination with Gram Panchayat.
4. Approach road up to the mining site should be made up of tar.
5. Photographs of the site clearly showing the status of plantation to be furnished.
6. Hot-mix plant and a sizing unit (crusher) is also proposed to be installed at site hence

PP was required to submit details of pollution control measures proposed in these two units. Response to the above was submitted by the project proponent. The submissions made by the PP were found satisfactory. The EIA report and the EMP submitted and presented before the committee was acceptable hence the case is **recommended** for grant of prior EC subject to following special conditions:

- a. Mining pits (about 3.5 ha) shall be developed in to ponds, which should be appropriately fenced, pitched and well structured. The pond shall be as per the engineered drawing & design.
- b. Repairing of approach road which is presently available shall be done by the PP.
- c. Control blasting will be done as per the Explosive Rules & regulations using appropriate Signage tin board/Barricades.
- d. The validity of prior EC shall be restricted only up to the completion of the road project or maximum up to February 2014 which ever falls earlier.
- e. The funds reserved for CSR shall be used up in coordination with the Gram Sabha of the region.

- f. All activities pertaining to environment management plan shall be validated by the MoEF Regional Office Bhopal, MPPCB & mining department hence PP shall submit the compliance reports to all these departments.
- g. Hot Mix Plant and the Crusher shall be provided with adequate pollution control systems as per the requirement of MPPCB.
- h. Blasting shall be strictly carried out under the supervision of experts from explosive department.
- i. Muffle-blasting will be taken up and practiced for prevention of flying stones.
- j. Explosives of low density and velocity of detonation shall be used along with safety fuse to avoid Ground vibration

11. Case No. 631/2011- (SEIAA 117<sup>th</sup> dt. 22<sup>nd</sup> Jan13) **M/s Chinar Reality Pvt Ltd Chinar House 231-Zone II M.P. Nagar Bhopal-462 011.** Group Housing Project Ratanpur Sadak & Narela Hanumant Teh-Huzur-Bhopal-(M.P)

The project was discussed in 81<sup>st</sup> and 93<sup>rd</sup> meetings of SEAC and recommended for grant of prior EC. After scrutiny of the papers and available data in the minutes it is concluded that the fresh water requirement & waste-water generation for the project has been quoted incorrectly due to typographical error the same as per the records is 467 KLD and 621 KLD respectively. The original file and submissions are available with SEIAA hence the condition pertaining to fresh water requirement for the project may be amended as per the information and facts submitted by the PP.

This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of stone boulders is proposed in the project in mining lease area of 4.00Ha. Production capacity proposed is 2000 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The matter was dealt in detail during the 114<sup>th</sup> SEAC meeting held on 04/01/2013 and TOR was recommended in accordance to the prevailing guidelines of SEIAA. However, in view of revised guidelines the case was reconsidered after receiving the requisite information from PP as category B-2 project. Proponent has submitted information in format-1 duly validated by the Tehsildar and DFO. The submissions made by them were found satisfactory and acceptable hence, it is decided to **recommend** the case for grant of prior EC subject to following special conditions:

- a. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- b. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
- c. PP shall be responsible for the discrepancy, if any, in the submissions made by the PP to SEAC & SEIAA.
- d. Transportation of material shall be done in covered vehicles.
- e. Curtaining of site shall be done using appropriate media.
- f. Production shall be to the tune of 2000 m<sup>3</sup>/annum and the average depth of the pit shall not exceed 1.00m at the end of 10 years.
- g. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
- h. The validity of the prior EC & the lease shall be for a maximum period of ten years only.
- i. Transportation shall not be carried out through forest area.
- j. PP shall take CSR activities in the region through the 'Gram Panchayat'.
- k. Crusher is proposed in the MLA, the mitigation measures proposed for combating the impacts from crusher have to be implemented as approved by the MPPCB.
- l. Permission for using water from village resources has to be obtained from Gram Sabha and furnished to MPPCB along with the consent application.

PP has submitted revised set of papers as per the directions of the meeting dated 01/02/2013; hence the PP may be called upon for meeting to be held in April 2013 as per his turn.

15. Case No. 685/2012 (SEAC 109<sup>th</sup> Meeting dt. 06/11/12 ) **Shri Manoj Jain, Partner,**

**“Maple High Street” M/s Global Properties Pvt. Ltd. Hoshangabad Road, Opp Ashima Mall, Bhopal (M.P.) 462036 – “ Maple High Street” Commercial Shopping Mall at Khasra No. 367, 374, 386/1 Village- Bawadian Kalan, Tehsil – Huzur, Distt. – Bhopal (M.P.) Total Land Area – 1.0115 Ha. (10114.96 Sq.m.) Total Built Up Area – 2.5255 Ha. (25255.37 sq mt) **Building Construction Project.****

The case was presented & discussed in detail before the committee in the 93<sup>rd</sup> Meeting of SEAC dated 10<sup>th</sup> April 2012. The committee has asked the PP for submission of response for the following queries:

1. Revised conceptual plan incorporating the suggestions of the members.
2. Present air and surface/ground water quality of the area to be reported.
3. Complete plan for door to door collection, location of collection points, proposal for pucca platform for MSW storage area and a notarized copy of agreement with Municipal Corporation for disposal of MSW at designated site.
4. Permission / commitment from competent authority for supply of water for the project to be furnished.
5. R.O.W of the approach road with distance of project boundary from the centre of the main road to be reported.
6. The existing tree-plants are proposed to be transplanted – complete plan in this regard including number of trees, location and area proposed for transplantation etc. to be submitted.
7. The transplantation plan should include the survival rate with plan for compensatory plantation for the lost trees.
8. Details with calculation for the STP proposed for the project.
9. Commitment for compliances of ECBC guidelines with highlights of green building concept being adapted in the project.
10. Proposal for dual plumbing (grey-water / fresh water) with built-in irrigation system for green areas to be provided.

PP has submitted reply to the above queries which were placed before the committee in 109<sup>th</sup> meeting dated 06/11/2012. The information provided by the PP was also found to be incomplete and PP was asked to submit further clarification on the following points:

- PP should submit appropriate management of MSW along with the requisite permissions from Bhopal Municipal corporation..
- The left out treated sewage is proposed to be drained out in the sewer line. Permission of the same has also not been obtained by the PP; the same has to be obtained and submitted along with the appropriate management plan and map showing ultimate disposal of extra sewage.
- The de-watered STP sludge shall be disposed off along with the MSW to the designated site.
- Revised lay-out depicting the locations of STP, water-harvesting locations, MSW storage area and MSW collection points to be submitted.
- Area statement with map showing green cover area to be furnished.

The response to the above queries was submitted by the PP and the same was placed before the sub-committee in this meeting the scrutiny of the response revealed that the response is satisfactory. Other submissions made by the PP in the meetings dated 10/04/2012 and 06/11/2012 were found acceptable hence the case is **recommended** for grant of prior EC subject to the following special conditions:

1. The water requirement shall not exceed 243 KLD.
2. Approx 170m<sup>3</sup>/day wastewater will be generated during the operational phase which shall be treated in a sewage treatment plant consisted of Aeration System and Multi-Media Filtration System.
3. The treated waste water shall be used in the gardening and flushing the extra treated sewage shall be disposed off into the municipal sewers.

4. The rainwater harvesting will be done from the roof top areas through four no. of percolation wells.
5. ROW and other road width shall be strictly as per the norms laid in the Bhoomi Vikas Niyam 2012.
6. ECBC guidelines laid down by BEE shall be followed for energy conservation.
7. Periodic energy audit shall be carried out through certified energy auditors and the certificate shall be submitted along with the other compliances.

16. Case no 613/2010-M/s **Ultra Tech Cement Ltd. (Birla White Unit) D7, Shastri Nagar, Jodhpur (Rajasthan) – 342003** Capacity expansion of Dolomite and Limestone production (19.71 ha) at Village Chhapparwaha , tehsil Badwara, dist – Katni (MP) Project Proponent M/s UltraTech Cement Ltd. (Unit Birla White) a flagship company of the Aditya Birla Group, Katni (MP).

EIA report of the project was discussed in detail in the 99<sup>th</sup> meeting of SEAC and the case was recommended by the committee for grant of prior EC. PP has submitted a copy of compliance report duly certified by the Regional Office of MoEF. The compliances were already dealt by the committee during EIA presentation made by the PP. As directed by SEIAA in its 104<sup>th</sup> meeting dated 04/09/2012, PP has obtained the validation report on compliances and present status of the mining area and submitted a copy of the same to SEAC. The report reveals that the previous lessee has mined out number of pits unsystematically and left the area unclaimed / unattended. The OB and other materials have been stalked haphazardly in the lease area. The same was submitted by the PP during appraisal of EIA report. It was pointed out in the report that while operating the present PP should ensure that mining activity should not affect the flow of Jirgaria Nalla and its water quality. The CSR activities being taken up by the present PP are satisfactory and need based CSR activities should be taken up.

After scrutiny of the facts furnished through the report committee further recommended following additional special conditions while issuing prior EC:

1. PP should take up activities pertaining to land reclamation as per the approved Mining Plan and shall submit progress report to MPPCB & Regional Office of MoEF.
2. Effective plan to prevent the Jirgaria Nalla and its water quality from mining activities shall also be submitted along with the progress report.
3. MPPCB shall ensure the implementation of actions submitted & approved under above mentioned conditions before granting consent to operate.
4. Other special conditions shall be as per the earlier recommendation.

Request from PP has been received for extension of validity of TOR. The TOR was issued to the PP vide letter dated 07/08/2008. Request for extension of validity of TOR was received vide SEIAA letter dated 04-02-13. It was observed by the committee that the maximum validity of the existing TOR (i.e. four years) in accordance to the MoEF OM dated 22/03/2010 has already expired on 22/03/2012. Hence no further extension can be granted, the PP may be advised to re-apply in the prescribed form as per the procedures laid in the EIA notification. The case is recommended for delisting.

18. M. Per Year.- Lease period 10 years.

The case was earlier placed in the 108<sup>th</sup> meeting dated 05/11/2012. PP did not attend the said meeting. SEIAA has forwarded enclosures for the said project i.e. information in format-1 and EMS. The validation of the information from DFO and Tehsildar has been done on the format itself without proper dispatch no. and date hence PP has to submit the same. PP may be called for necessary presentation in the next meeting scheduled in April 2013.

19. Case No. 865/2012 **Shri Chain Lal Ambade C/o M/s Neha Bedi, 104 A, Mohit Complex Near Navin Vidhya Bhavan Nepier Town – Jabalpur, Distt. – Jabalpur (M.P.) – 482001 - Chainlal Ambate Mining of Ordinary Clay (Mud) at Khasra No. – 475/2, Village - Murjhad, Tehsil – Waraseoni, Distt. – Balaghat (M.P.) Lease Area – 2.40 ha. Capacity – 6000 Cu. M. Per Year.**

The case was presented before the committee in the 108<sup>th</sup> dated 05/11/2012.

This is a mining project with lease area less than 5 hectare. The application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of mud is proposed in the project for manufacturing of bricks in mining lease area of 2.40Ha. Production capacity proposed is 6000 m<sup>3</sup> / year. Mining shall be done from the proponents own land. Lease period for which application has been filed with mining department is 02 years as reported by the PP. The matter was dealt in detail during the 108<sup>th</sup> SEAC meeting held on 05/11/2012 PP had not submitted the information in the prescribed format-1 the same was asked from the PP. Proponent has submitted the required information in format-1 duly validated by the Tehsildar and DFO vide SEIAA's letter no. 2303 dated 15/02/2013. The submissions made by the PP were found satisfactory and acceptable hence, it is decided to **recommend** the case for grant of prior EC subject to following special conditions:

- a. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- b. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
- c. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.

made by the PP reveals that mining of stone is proposed in the project in mining lease area of 0.75 Ha. Production capacity proposed is 10000 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The matter was dealt in detail during the 108<sup>th</sup> SEAC meeting held on 05/11/2012 and TOR was recommended in accordance to the prevailing guidelines of SEIAA. However, in view of revised guidelines the case was reconsidered after receiving the requisite information from PP. Proponent has submitted information in format-1 duly validated by the DFO. The information sought through 13 more points from Tehsildar is yet to be submitted. The same may be asked from the PP.

Scrutiny of the submitted information reveals that the proposed project is only 02 Km from Bandhavgarh National Park, hence the project falls under **Category – ‘A’** and appraisal of same is beyond the jurisdiction of SEIAA / SEAC. Hence the original files and papers of the project may be returned to SEIAA for **delisting** the same.

After revision of policy PP has submitted the requisite information in prescribed format-1 through DFO and Tehsildar. Katni The submissions made by the PP were found satisfactory and acceptable hence, it is decided to **recommend** the case for grant of prior EC subject to following special conditions:

- a. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- b. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
- c. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- d. Transportation of material shall be done in covered vehicles.

The case was presented before the committee in the 114<sup>th</sup> SEAC meeting dated 04/01/2013.

This is a mining project with lease area less than 5 hectare. The original application was forwarded by SEIAA to SEAC for screening and scoping in accordance to the prevailing policy decided by SEIAA for such cases. The salient features were presented by the PP. Submissions and the presentations made by the PP reveals that mining of stone boulders is proposed in the project in mining lease area of 4.0 Ha. Production capacity proposed is 9230 m<sup>3</sup> / year. Lease period for which application has been filed with mining department is 10 years as reported by the PP. The case was discussed in the 114<sup>th</sup> meeting of SEAC dated 04/01/2013 under category B-1, in accordance to the prevailing guidelines of SEIAA and TOR was determined to carry out EIA for the project.

In view of revised policy from SEIAA and submissions made by the PP the case was re-considered. It is observed that PP has submitted the requisite information in prescribed format-1 through DFO and Tehsildar. Katni. The submissions made by the PP are found satisfactory and acceptable hence, it is decided to **recommend** the case for grant of prior EC subject to following special conditions:

- a. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- b. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
- c. Transportation of material shall be done in covered vehicles.
- d. Curtaining of site shall be done using appropriate media.
- e. Production shall be to the tune of 9230 m<sup>3</sup>/annum and the average depth of the pits will not exceed 2.50m at the end of 10 years..

- f. The excavated material shall be utilized only for brick making.
- g. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
