PP has satisfactory response to above queries. The same were scrutinized by the committee. It is observed that this is case of mining of sand / bajri *Khasra No. – 11, Village – Mahendragaoon,, Tehsil – Sirali, Distt. – Harda (M.P.) in a lease area of 2.0 ha.* Proponent has submitted information in format-1 duly validated by the Tehsildar and DFO. The submissions made by the PP are found to be satisfactory and acceptable hence, it is decided to recommend the case for grant of prior EC subject to following special conditions:

- The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
