23/09/2013 has requested SEIAA to withdraw the condition of plantation in 35% of the total plot area as no such guidelines have been issued by any of the authorities in this regard. It was also stated that the EC has been granted to the project post-facto, i.e. after the project was completed based on the approved plan of TNCP. The matter was discussed in SEAC and it was decided to visit the site to evaluate present status of green covers in the project and for further suggestions / recommendations in this regard.

#### Discussion on the visit report placed by the visiting Sub-Committee:

Site- visit was taken up by the sub-committee on 9<sup>th</sup> October 2014 SEAC in compliance to the decision taken in the SEAC meeting dated 5<sup>th</sup> September 2014. The details of the observations and the recommendations thereby are as follows:

**Case No. – 1687/2013** M/s Shikhar Housing Development Pvt. Ltd., Director, M/s Pawan Agrawal, 248/4/1, Pipliya Kumar, Indore (M.P.) Proposed Residential Township Project "Balaji Skyz" at Khasra No. – 74/2, 74/3, 76, 78, 79/4 Village – Piplyakumar, Tehsil & Distt. - Indore (M.P.) Total Land Area = 17,435.88 m² Total Built up Area – 30,438.87 m². - Building Construction.

This is a building construction project with proposed plot area of 17,435.88 m<sup>2</sup> & total built-up area of 30,438.87 m<sup>2</sup> hence covered in the schedule of EIA notification 2006 as amended from time to time as item no. 8(a). Hence the project requires prior EC from SEIAA. The application along with the annexure was forwarded by SEIAA to SEAC for appraisal and necessary recommendations.

It was submitted by the PP that construction activities have been initiated at site admitting violation of the provisions of EIA Notification. PP has submitted a copy of Resolution along with evidence of credible legal action against the PP for the caused violation, in compliance to the O.M. of MoEF dated 12/12/2012. It was reported by the PP that the construction at site is almost complete and presently further construction activities have been stopped. Based on the submissions PP was allowed to make the presentation before the committee. The salient features of the project, environmental impacts, EMP and other relevant issues were presented by the PP and his consultant in the 149<sup>th</sup> SEAC meeting dated 5<sup>th</sup> September 2014.

Although, verification of the reported violation was not required as per O.M. of MoEF dated 12/12/2012, because PP himself has confessed and MPPCB has filed criminal case against the Project Proponent complying the need of credible action. Nevertheless, site- visit was taken up by the sub-committee on 9<sup>th</sup> October 2014 SEAC in compliance to the decision taken in the SEAC meeting dated 5<sup>th</sup> September 2014.

A sub-committee comprising Shri Manohar K. Joshi, Member SEAC and Shri Rameshwar Maheshwari, Member SEAC was constituted by the Chairman, SEAC for the purpose. The report of the sub-committee is attached at the **Annexure 'A'**.

- 1. Construction of residential segment was found to be complete accept for the finishing works in some of the blocks which were not yet sold.
- 2. It was informed that only 10% of the flats are yet to be sold. From already the sold flats possession of about 35% flats has already been given to the owners which are now occupied by the respective flat owners.
- 3. The commercial (convenient shopping center) segment consisting only one block (G+1) was found to be partly constructed up to ground floor only.
- 4. All construction activity including the finishing works has been stopped at site.
- 5. PP promised to submit/show an document regarding Bonus floor area, approximately 0.25. The FAR used as 1.7455 which is permitted as 1.25 as per bhoomi vikas niyam 2012 (rule 61). The excess built up area permission (bonus FAR) document should be furnished for verification.

#### B. Parking space-

- 1. The project consists of 420 dwelling units, assuming one car per unit total requirement of parking space is 420 ECS against which parking with 486 ECS has been provided in the project for car parking. Earlier, the same was proposed to be 296 ECS only.
- 2. The parking is provided in the stilt and basement of each of the blocks.
- 3. Parking for the visitors has been provided at entry gate.

#### C. Green cover / belt status-

- 1. The plantation around the boundary was partially done; it was informed that two row plantation has been planned all around the boundary wall of the project site.
- Landscaping in pockets was observed it was informed that the as soon as finishing of left out blocks is over the remaining landscaping tasks shall be taken up to avoid any damages to the growing plants.
- 3. Total green area in the project was only about 12%, which is more than that prescribed in the approved lay-out of the project.
- 4. Task of additional plantation on road-dividers has been accorded to the PP by the IMC with maintenance of the same for 05 years. The same was also visited by the sub-committee and found to be in place.

#### D. Water supply for the project-

- Water supply from IMC has been planned in the project. IMC has given commitment in this
  regard. It was observed that all plumbing work for water supply is already in place. But IMC
  has not yet connected the project with their water scheme. It was informed that the IMC
  water shall be made available for the project shortly.
- 2. Presently the water for the project is being supplied through private tankers. PP has made an agreement / MoU with the private water suppliers.

#### E. Sewage-treatment / disposal status-

- 1. About 272 KLD of waste water is expected from the project when fully operational. FAB based STP has been installed at site with a capacity of 300 KLD.
- 2. The STP was found to operational.
- 3. The treated waste water is being lifted and stored in separate tanks connected to the dedicated pipe line.
- 4. Re-use of treated waste water through dual plumbing pipe system was found in place. However the quantum being generated presently is on lower side as the occupancy in project is only about 30-35 %.
- 5. The surplus treated waste water (if any) shall be disposed off through the existing sewer line of IMC.

#### F. Municipal Solid waste /collection/ storage & disposal status-

- 1. The municipal solid waste is being collected from door to door by the engaged staff and is being disposed off at the designated site of IMC.
- 2. The planned system includes 48 hour storage area at exit gate and near shopping center. These are yet to be completed.
- 3. Bins have been placed only at some of the selected points based on the present occupancy. It was informed that after completion of project and when the project is fully operational, the collection bins shall be placed as per the plan.
- 4. No accumulation of MSW was observed in the premises or out side the premises.

#### G. Traffic management within the premises-

- 1. One way traffic has been planned in the project. The security staff deputed in the project has been trained for the same.
- 2. Movement of fire tender is expected to be smooth with present planning.

#### H. Fire-fighting system-

The fire-fighting system as proposed by the PP was found to be in place.

#### **Conclusion and recommendations:**

In light of the above observations, the sub-committee is of the view that the case may be considered for grant of EC. The location of the site is clear from environment point of view. The area break up for various utilities and land cover is as per the approved lay out. Area reserved for greening appears to be low. However, play space for the children has been provided in the project which compensates the same to some extent. During visit PP was directed to stringently comply with the following directions:

- 1. Development of green areas with in the project site has to be taken up on top priority.
- Presently single row plantation is being taken up around the boundary; PP should ensure that additional row of plantation should be taken up by removing the paved surface all around the boundary walls.
- 3. Parking space for the visitors appears to be on lower side hence, PP should demark some space in the existing surplus parking slots in stilts for the visitors. These spaces should not be sold to the flat owners.
- 4. Use of solar panels was not observed in the project at any point. PP shall ensure the use of solar energy in maximum common places.
- 5. Water supply from IMC should be regularized at the earliest before any more processions of the flats
- 6. The water being supplied to the residents through private tankers should be checked for quality on regular basis. Similarly, the water quality of treated STP waste water should be checked up quarterly by the third party.
- 7. Any activity pertaining to construction or sale / handing over processions should not be taken up till EC is granted to the project.

The above report was discussed by the committee at length. It was brought to the notice of the committee that PP was asked to furnish documents regarding Bonus floor area, approximately 0.25 as the FAR used in the project is 1.7455 against permitted FAR of 1.25 as per bhoomi vikas niyam 2012 (rule 61). The same has been submitted by the PP and scrutinized by the committee.

After discussion it was observed that the submissions made by the PP are satisfactory and acceptable thus based on the observations made in site visit report the <u>case was recommended for grant of post-facto EC subject to the above conditions.</u>
