- “ Separate and independent rain water drainage system shall be provided for collecting rain water from terrace, paved area, lawns and roads. Independent rain water down takes of appropriate size and number shall be provided in close coordination with architect.

- “ Perforated pipe drainage system shall be provided for open-to-sky courtyard/lawn. The storm water runoff from the ramp shall be separately collected and connected to sump.
- “ No storm water ingress shall be allowed into stilt portion. It shall be ensured to have electrical supply for all sump pump panel from electrical panel.

Construction debris

- Construction debris is bulky and heavy and re utilization and recycling is an important strategy for management of such waste. As concrete and masonry constitute the majority of waste generated, recycling of this waste by conversion to aggregate can offer benefits of reduced landfill space and reduced extraction of raw material for new construction activity.
- Recycled aggregate will be used for filler application, and as a sub base for road construction. Mixed debris with high gypsum, plaster, shall not be used as fill, as they are highly susceptible to contamination, and will be given to recyclers.
- Construction contractors shall remove metal scrap from structural steel, piping, concrete reinforcement and sheet metal work from the site. After deliberations PP was asked to submit response to the following queries:

1. Storage area of MSW to be marked on lay out with provision to store for 48 hours.
2. Mode of ultimate disposal of surplus treated sewage from the project.

3. Water balance needs to be reviewed and submitted.
4. STP sludge to be press filtered and disposed off with MSW ó proposal to be submitted with estimated STP sludge.

During the presentation, it was noticed that proponent has started construction activities which is about 25% of the total built up are, project proponent has submitted resolution of board of director also before the SEAC. It was also informed by the PP that they already approached MPPCB disclosing the facts so that credible action in this regard may be taken up. A letter written to MPPCB was shown by the PP.

Considering the facts produced by the PP, committee decided to differ the case till the evidences action produced before the SEAC as per MoEF OM no J- 110131/412006 _IA_II (I) dated 12.12.12 and dated 27.06.2013 for forwarding the case to SEIAA.

The case was again discussed in 153rd meeting dated 21/10/2014 and the submitted documents were examined by the committee. It was observed that PP was still required to submit clear response to following queries:

- Consent from Municipal Corporation for disposal of MSW.
- Consent from Municipal Corporation for water supply (275 KLD) for the project submitted.

Response to the above queries has been submitted by the PP. The submissions made by the PP were found to be satisfactory and acceptable. Hence based on the submissions made by the Pp and the presentations made the case was recommended for grant of EC subject to the following special conditions:

1. Fresh water requirement in the project shall not exceed 217 KLD.
2. Compliance of the outcome of the legal case against the PP for violation shall be binding on part of PP.
3. Area under green cover shall not be less than 3240 sq mt.
4. Green belt consisting two row plantations around the project boundary shall be developed along with other activities of the project.
5. Necessary consents under the provision of Water / Air Acts shall be obtained from MPPCB. The sewage treatment system shall be installed as per the directions of MPPCB.
6. Project proponent shall ensure smooth running and maintenance of the STP for project life. An affidavit in this regard shall be submitted to MPPCB.
7. Appropriate Escrow fund shall be created by the PP for execution of EMP as proposed in the project.

The case was considered in the 155th meeting dated 11th Nov. 2014 whereby the Pp was asked to submit response to the following queries:

- Comments from the competent authority on the issue of existence of large number of bird species in the region.
- Water and air analysis reports presented in the EIA report need to be reviewed/ revisited in view of several discrepancies pointed out by committee.
- The committee was not satisfied with the approach adopted by the consultant in preparation of EIA report particularly the discrepancies in analysis and survey based data/ information.

The submissions made by the PP were found to be satisfactory and acceptable. Hence based on the presentation and submissions made by the PP the case was recommended for grant of prior EC subject to the following special conditions:

1. In order to prevent haphazard excavation of pits, the development/production has been proposed at one place in quarry the same shall be observed while carrying out the mining operation.
2. Ratua Nalla reported at about 1 km in North and the topography also shown to have general slope towards North West, hence appropriate garland drains and check-dams shall be developed in this direction to prevent run-offs into the nearby water bodies.
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air pollution control measures have to be installed as per the recommendation of MPPCB.
5. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
6. Appropriate activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat.
7. Proper records shall be maintained for the water consumption in the mine.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. – 325, Village- Inpun, Tehsil – Punasa, Distt. – Khandwa (M.P.)* in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body.

The case was considered and recommended in the 150th meeting dated 25/09/2014, whereby it was decided to ensure that the mine has not exceeded production as prescribed in the consent, before forwarding the case to SEIAA. In this context PP has submitted the production figure duly verified from the Mining department and a copy of the consent issued by the MPPCB. From the submission made by the PP it reveals that the PP has been granted consent for

production of 4899 m³ (1.73 lac ft³) per year against which PP has excavated 2925 m³ in year 2013 (from July 2013 to December 2013) and 3370 m³ in year 2014 (January 2014 to July 2014). The mine is not operating since July 2014 i.e. after the lease expired for want of EC. From the clarification and supporting documents submitted by the PP no violation is observed, hence the case may be forwarded to SEIAA as per the decision taken in the 150th meeting dated 25/09/2014.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located *at Khasra No. 284 Village- Kayady, Tehsil- Waraseoni, Distt Balaghat (M.P.) in 2.428 ha.* The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body.

The case was presented before the committee in the 151st meeting dated 27/09/2014. After deliberations in the said meeting PP was asked to furnish a letter from Mining department verifying the facts on presence of other mines within 500 meters from the periphery of the proposed MLA as no details could be provided by the PP in this regard. The requisite information was submitted by the PP along with the supporting documents. It is reported by the concerned Tehsildar vide letter no. 1616 dated 14/10/2014 that 05 more mines are operating / proposed with in 500 meter radius around the proposed mine site and the cumulative lease area of all the mines is 11.928 Ha. The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.
6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.

Total Built up area - 39550.96 sqmt.**

The case was considered in the 154th SEAC Meeting dt. 10/11/14 whereby PP was asked to submit response to the following queries:

- It is proposed that the treated waste water from the project shall be disposed off into nearby surface water body; accordingly, the sewage treatment plant (STP) has to be planned such that the quality of treated waste water meet the river water standards. PP is required to submit a proposal in this regard with full details of the STP.
- The capacity of the STP has to be re-evaluated considering the quantum of sewage expected to generate from the project when fully operational.
- An undertaking has to be furnished stating: (a) A buffer of 09 meters between the boundary-wall of the project and the HFL of the nearby nallah shall developed & maintained as green, this area shall be developed aesthetically. (b) Quality of the treated waste-water shall be tested regularly and the same shall meet the river water standards at any point of time. (c) Ground water shall not be used for construction purpose under any circumstances.
- Location of the STP and MSW storage area has to be reviewed and re-located at suitable place, away from the nallah.
- Parking space for all 587 flats has to be provided with spare parking for visitors to avoid parking of vehicles on roads.
- Plantation scheme including the plantation in the buffer zone has to be submitted with a lay-out plan.

The reply and supporting documents submitted by the PP were placed before the committee. Submissions mad the presentations made by the PP were found to be satisfactory and acceptable hence committee recommended the case for grant of prior EC subject to the following special conditions:

1. Fresh water requirement in the project shall not exceed 258 KLD.
2. Compliance of the outcome of the legal case against the PP for violation shall be binding on part of PP.

3. Green belt consisting two row plantations around the project boundary shall be developed along with other activities of the project.
4. Necessary consents under the provision of Water / Air Acts shall be obtained from MPPCB. The sewage treatment system shall be installed as per the directions of MPPCB.
5. Project proponent shall ensure smooth running and maintenance of the STP for project life. An affidavit in this regard shall be submitted to MPPCB.
6. Appropriate Escrow fund shall be created by the PP for execution of EMP as proposed in the project.
7. A buffer of 09 meters between the boundary-wall of the project and the HFL of the nearby nallah shall developed & maintained as green, this area shall be developed aesthetically.
8. Quality of the treated waste-water shall be tested regularly and the same shall meet the river water standards at any point of time.
9. Ground water shall not be used for construction purpose under any circumstances.

Capacity: Metal Stone/Boulder - 5575 Cu.mt/Year..

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. – 697/1, Village-Kharkta, Tehsil-Chitrangi, District-Singrauli (M.P.)* in 2.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the Dy. Director (Mine), Singrauli vide letter no. 1156 dated 28/08/2014 that no mine is operating / proposed within 500 meters radius from the boundary of the proposed mine. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is also proposed within the project boundary. The case was considered in the 156th meeting dated 12/11/2014 whereby the PP was asked to submit following information with supporting documents: · (1) Activity-wise budget break-up. (2) Year-wise Plantation scheme. The response from PP for the above queries was placed before the committee. Committee found the submissions satisfactory.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. – 1042, 1043/1, Village-Siddhikala, Tehsil- Singrauli, District- Singrauli (M.P.) in 1.680 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the Dy. Director (Tech), Singrauli vide letter no 1167 dated 26/08/2014 that no mine is operating/proposed within 500 meters around the proposed project site. The case was considered in the 157th meeting dated 27/11/2014 whereby the scrutiny of the project revealed certain shortcomings in the information. PP was asked to submit following information for further action in the matter: (1) PFR has to be revised as per the prescribed format of MoEF, clearly addressing the feasibility of project considering the environment, social and financial aspects. (2)The ground water table reported by the PP should be supported with official document in this regard.

PP has submitted the above information and the same were placed before the committee in this meeting and found satisfactory.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA

The case was considered in the 163rd Meeting of SEAC dt. 24th Dec. 2014 whereby it was observed by the committee that in Bilua Region huge cluster of stone mines is operational, hence it was decided to verify the distance of this particular group of mines from major Bilua cluster through R.O. MPPCB / Mining Department. In this context the Mining Officer, Gwalior vide letter no. QL-31/2011 dated 29/12/2014 has reported that total six mines are operating / proposed within 500 meter radius and cumulative lease area of all the six mines including this mine is 9.625Ha, the distance of this cluster of six mines from the boundary of major cluster of mines in Bilua Region is more than 500 meters. Based on the submissions and presentation made by the PP the case was recommended for grant of prior EC subject to the special conditions laid in similar cases.
