

The 175th meeting of the State Expert Appraisal Committee (SEAC) was held on 25th February, 2015 under the Chairmanship of Dr. R. B. Lal. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

Discussion and decision taken on miscellaneous issues:

1. Case No. – 1703/2013 Gwalior Development Authority, Gwalior, M.P. Through Chief Executive Officer, Shri S.K. Mishra, Vikas Bhawan, 1, Ravi Nagar, Gwalior (M.P.) 474002 Commercial Complex " Madhav Plaza " at Khasra No. – 756, Village – Lashkar, Tehsil - Huzrat Road, Lashkar, Distt. – Gwalior (M.P.) Total Built Up Area – 54,240 sq.mt. for residential area development and 3212.15 sq.mt. Plotted Area. Building Construction.

This is an area development project comprising Residential campus. Total built-up area proposed is 54,240 m². The project is covered under the provisions of EIA Notification as item no. 8(a). Hence requires prior EC before commencement of activity at site. The application was forwarded by SEIAA to SEAC for appraisal and necessary recommendations. The salient features, EMP for construction as well as operational phase were presented by the PP before the committee.

After deliberations following observations/conclusions were made by the committee:

- Construction is reported to be completed hence violation of EIA notification is established and credible action against the PP is reported to be initiated by the concerned authority.
- Meanwhile, PP has moved to the Honorable High Court; Court directed SEIAA to consider the matter in the SEAC meeting dated 25/02/2015. Accordingly the case was placed in this meeting.
- Regarding development of green area it was observed that the same can not be taken up by the PP at this point of time as the project is already constructed at the site.
- Committee was of the view that PP should take up compensatory plantation on a land equivalent to 30% area of total plot area proposed in this project within Gwalior municipal limits. PP has agreed for the same.
- Committee asked the PP for submission of detailed plan for the above including details of land, plantation scheme and budget reserved for the same.
- An affidavit with undertaking shall be submitted in this context by the Project proponent.
- Committee shall plan for site visit to assess the acceptability of proposed mitigation and other aspects of the project. (Location of Bridge).

2. Case No. – 944/2012 M/s Meera Stone Mine, Prop. Smt. Meera Divedi Village & Post-Bandhawabada, Tehsil- Sohagpur, Dist. Shahdol (M.P.) Pin - 484001 Stone Boulder, Lease area- 0.607 ha. (1.50 Acre) Khasra No.- 718 in Vill.- Bandhwabada, Th.- Sohagpur, Distt. - Shahdol (M. P.) Capacity - 7000 MT/Year.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 718 in Vill.- Bandhwabada, Th.-

Sohagpur, Distt. - Shahdol (M. P.) in 0.607 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 19 dated 14/08/2014, that no mine is operating / proposed within 500 meter radius around the said mine. PP has reported that the pit formed after mining shall be developed into a water body.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be back-filled.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.
6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
7. Curtaining of site shall be done using appropriate media.
8. Garland drains and check-dams shall be constructed considering the slopes of the lease area.
9. Production of stone boulder shall be as per the mining plan not exceeding 7000 MT/Year. The maximum average depth of pits shall not exceed 6 meters.

3. Case No. – 2236/2014 Shri Kamal Singh S/o Shri Sekdiya Ji, Village-PratapFaliya, Tehsil-Jobat, District-Alirajpur (MP)-457990 Stone Quarry Lease Area –0.900 ha. at Khasra No. – 122/1,122/2 & 125 , Village-PratapFaliya, Tehsil-Jobat, District-Alirajpur (MP) Capacity -5700 Cum/Year.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

4. Case No. – 2237/2014 Shri Ratanlal Kumawat, Village-Banjali, Tehsil-Ratlam, District-Ratlam (MP) Stone Quarry Lease Area –0.600 ha.at Khasra No. – 136/1/1/1 , Village-Banjali, Tehsil-Ratlam, District-Ratlam (MP) Capacity - 5130 Cum/Year.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. – 136/1/1/1 , Village-Banjali, Tehsil-Ratlam, District-Ratlam (MP) in 0.600 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no.676 dated 07/11/2014, that 17 more mines are operating / proposed within 500 meter radius around the said mine and total lease area is 16.9 Ha. PP has reported that the pit formed after mining shall be developed into a water body.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be back-filled.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.
6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.

District- Dhar (MP) in 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 1121 dated 20/11/2014, that 01 more mine is operating / proposed within 500 meter radius around the said mine and total lease area is 3.5 Ha. PP has reported that the pit formed after mining shall be developed into a water body. EMP to revised 7 submitted.

Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence PP was asked to submit comments of concerned Forest Officer on this issue.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. - 852, Village-Banki, Tehsil-Seoni, District- Seoni (MP)* in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 2692 dated 17/11/2014, that 01 more mine is operating / proposed within 500 meter radius around the said mine and total lease area is 1.07 Ha. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area.

Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence PP was asked to submit comments of concerned Forest Officer on this issue.

The project requires prior EC before commencement of any activity at site. Mining is proposed for limited period of 03 years only.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 1286 dated 04/09/2014, that no mine is operating / proposed within 500 meter radius around the said mine. PP has reported that the pit formed after mining shall be developed into a water body.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.

2. The mined out pits shall be back-filled.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *village Kulhadi, Tehsil- Kolaras, District-Shivpuri, (M.P.)* in 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 1177 dated 27/08/14 that no mine is operating / proposed within 500 meter radius around the said mine. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. In view of shape of the lease area production of 10000 m³ / Year can be allowed with depth restriction of 6 meters. PP is required to submit response to the following issues:

- Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence PP was asked to submit comments of concerned Forest Officer on this issue.
- Conceptual Plan including post-mining measures.
- Written undertaking for a maximum production capacity not exceeding 10000 m³/Year and maximum average depth of all the pits shall not exceeding 6 meters as suggested by the PP.

Lease Area–6.00 ha., at Khasra no. – 54, Village - Rehi, Tehsil-Chitrangi, District- Singrauli (MP), Capacity- 145530 Cu.mt./Year Lease Period – 5 Year.

This is a case of mining of sand from river. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra no. – 54, Village - Rehi, Tehsil-Chitrangi, District- Singrauli (MP)* in 6.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 1642 dated 18/11/2014, that no mine is operating / proposed within 1000 meter from the peripheries of the said mine.

After deliberations PP was asked to submit the evacuation plan for the sand from site up to the main road. The same was submitted and shown by the PP in the meeting itself. Based on the submissions and the presentation made by the PP the case was recommended for grant of prior EC subject to the following conditions:

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. Plantation shall be carried out on the banks for stabilization of the banks.
4. Abstraction of sand shall be as per the approved Mining Scheme but not exceeding 145530 m³ in a year and the depth of mining shall be restricted to 3m or water level, whichever is less.
5. Mining shall be carried only between 1st November to 31st May i.e. during non-monsoon period.
6. Transportation of sand shall not be carried out through forest area.
7. The mining activity shall be done manually.
8. Heavy vehicles shall not be allowed on the banks for loading of sand.
9. The sand shall be transported by small trolleys up to the main transport vehicle.

14. Established water conveyance channels should not be relocated, straightened, or modified.
15. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
16. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
17. PP shall take Socio-economic activities in the region through the Gram Panchayat.
18. EC will be valid for mine lease period subject to a ceiling of 5 years.

Discussion on the visit report

Case No. – 1990/2014 Smt. Jaya W/o Late Shri Prashant Yadav, 180, Abdalpura, Ujjain (MP)-456001 *Stone (Gitti) Quarry Lease Area – 4.00 ha., at Khasra No. -192, Village-Jalakhedi, Tehsil-Ujjain, District-Ujjain (MP) Capacity – 30000 Cubic mt./Year.*

The case was discussed in the 164th meeting dated 07/01/2015. This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. -192, Village-Jalakhedi, Tehsil-Ujjain, District-Ujjain (MP)* in 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 574 dated 26/09/2014, that 10 more mines are operating / proposed within 500 meter radius around the said mine and the total lease area of all the mines including this mine is 23.5 ha. PP has reported that the pit formed after mining shall be developed into a water body.

After deliberations committee decided to visit the site in view of following:

- A group of 11 mines with total lease area of 23.5 ha are proposed / operating within 500 meter radius, as a result the area expected to be under cumulative impact when all the crushers are operational. Hence, there is a need of a common EMP for the region based on the nearby land-use.
- Based on the present scenario of the region and the nearby sensitive receptors decision in the matter shall be taken after the site visit.

The visit was conducted by the sub-committee comprising Shri K.P. Nyati, Member (SEAC) and Shri Manohar K. Joshi, Member (SEAC). The report was placed & discussed before the committee in this meeting. The detailed visit report is enclosed as Annexure-1. Based on the submissions of the PP and the recommendations of the visiting team the case was recommended for grant of prior EC subject to the following special conditions:

1. Garland drain and catch pit should be provided all around the mining area to trap the surface run-off.
2. Water sprinklers shall be provided on the accumulated crusher dust to avoid fugitive emissions.

3. Three meters tall wind-breaking walls to be constructed on both sides of the crusher.
4. Safety measures should be provided (such as fencing etc) around the mined out pits.
5. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
6. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
7. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
8. Transportation of material shall be done in covered vehicles.
