• Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence PP was asked to submit comments of concerned Forest Officer on this issue.

## Discussion on the cases referred by SEIAA:

Following cases referred back by the SEIAA were discussed in the State Expert Appraisal Committee (SEAC) meeting dated 25<sup>th</sup> March, 2015.

**1. Case No. 908/2012** - Shri Jagdish Basantani, 72, Shanti Nagar Colony, Berasia Road, Bhopal(MP) 462001- Environment Clearance for approval of 04.00 Hectares Stone/Boulder Quarry at Vill.- Titoria, Teh.-Ashta, Dist.- Sehore (M.P.)

This is a case of mining of stone boulders from a lease area of 4.00 Ha. The application was filed for production capacity of 1,00,000 cubic meter per year. The project was recommended by the SEAC in the 128<sup>th</sup> Meeting dated 26<sup>th</sup> April 2013 for production capacity of 25000 m<sup>3</sup>/Year and restriction on the average depth to 7.00m at the end of 10 years. EC issued vide letter no. 1757-58/SEIAA/14 dated 07-11-14 for production capacity of 2700 m<sup>3</sup> / Year. SEIAA forwarded the revised mining plan submitted by the for the production capacity of 70560 cum/year to reappraise the production capacity of the project. The matter was placed before the committee for appraisal of the Mining Plan and necessary comments w.r.t. production capacity. After discussions it was observed by the committee that the case has already been recommended for the production capacity of 25000 m<sup>3</sup> / Year with depth restriction of 7.0 meters in absence of Mining Plan. The revised mining plan submitted by the PP for targeted production capacity of 70560 m<sup>3</sup> / Year was scrutinized in the meeting which reveals following shortcomings:

The tools and machinery proposed in the mining scheme does not seem to be adequate for huge production of 70560 m3 / Year. A mandatory buffer zone of 7.5 meters has not been left all around the periphery of the mining site. Mineral evacuation plan including road network, man-power and infra-structure requirement etc. has not been furnished in the Mining Plan.

Based on the above observation committee is of the view that proposed production as per mining plan but not exceeding 70560 m3 / Year may be considered after ensuring compliance of all the provisions of EIA Notification and subject to submission of following information:

- > Details of the tools and machinery proposed for mining operations.
- > Provision of mandatory buffer zone of 7.5 meters all around the periphery of the mining site.
- Mineral evacuation plan including road network, man-power and infra-structure requirement.
- Activity-wise Environment Management Scheme with appropriate budgetary provisions for execution of the same on an Affidavit.

Case was recommended in the 135<sup>th</sup> SEAC Meeting dt. 04/06/13. The compliance of the conditions of EC was presented by the PP before the SEAC. The validation of the EC compliance received from MoEF was forwarded by SEIAA for examination. The same was placed before the committee in this meeting. The scrutiny of the compliance report reveals that the most of the conditions of existing EC are being compiled and /or partly complied by the PP. <u>After discussion on the matter committee decided to recommend for prior</u> EC subject to the following additional conditions:

- 1. Blast vibration study to be conducted.
- 2. Need based CSR activities have to be taken up through Gram Panchyat.
- 3. Rain water harvesting system to be installed.
- 4. Measures for soil erosion control. Retention walls, slopes, plantation etc. to be completed
- 5. Partly constructed check dams and garland drains to be completed.
- 6. Identification of wasteland (non cultivable land) in 5 Km radius and efforts to convert them into agriculture land.
- 7. Group insurance of the mine workers.
- 8. Top soil to be staked separately for use in plantation and green area development.
- 9. Hydro-geological study shall be conducted and the mitigations / recommendation of the study shall be implemented.
- 10. Env. Management Cell has to be constituted and reported.
- 11. Details of closure plan with budgetary provisions to be submitted.
