The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

**Discussion and decision taken on miscellaneous issues:**

- 1. Case No. – 2396/2015 Shri Brijbhan Singh, Village-Niwari, Tehsil-Khurai, District-Sagar (MP)-470117.** Stone Quarry in an area of 2.80 ha. (12,084 cum/year) at VillageBikorkalan, Tehsil-Malthon, District-Sagar (MP). Application forwarded by SEAC by SEIAA vide letter no 3169 dt. 19-01-15.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Bikorkalan, Tehsil-Malthon, District-Sagar (MP) . The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the DFO.

Presentation & submissions made by the PP were discussed in the meeting. The EMS and other submissions made by the PP were found to be satisfactory and acceptable. The allowable depth as per mining plan is 6 meters. However, scrutiny of the project documents revealed that PP has not furnished the letter from Mining Officer certifying the leases within 500 meters radius around the site. Thus PP was asked to submit the letter from Mining Officer certifying the leases within 500 meters radius around the site.

- 2. Case No. – 2397/15 Shri Suresh Singh S/o Shri Khuman Singh Sosodiya, Village-Dhablaghosee, Tehsil-Shujalpur, District-Shajapur (MP) Sand Quarry** in an area of 5.751 ha. (10,000 cum/year) at VillageDhablaghosee, Tehsil-Shujalpur, District-Shajapur (MP) Applications forwarded by SEIAA to SEAC by vide letter no. 3171/SEIAA/15 dated: 19/01/2015.

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at VillageDhablaghosee, Tehsil-Shujalpur, District-Shajapur (MP) in 5.751 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 294 dated 05/03/2015, that no mine is operating / proposed within 1000 meter radius around the said.

Based on the presentation and the submissions made by the PP committee has decided to recommend the case subject to the following special conditions:

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. It was observed during the visit to Alirajpur by the sub-committee that the banks of the tributaries have been eroded due to floods hence as special condition PP shall use the rejects and soil for plantation on these eroded banks to prevent further damages of the banks.
4. Abstraction of sand shall be as per the approved Mining Scheme but not exceeding 10,000 m<sup>3</sup> in a year and the depth of mining shall be restricted to 3m or water level, whichever is less.
5. Mining shall be carried only between 1st November to 31st May i.e. during non-monsoon period.
6. Transportation of sand shall not be carried out through forest area.
7. The mining activity shall be done manually.
8. Heavy vehicles shall not be allowed on the banks for loading of sand.
9. The sand shall be transported by small trolleys up to the main transport vehicle.
10. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
11. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone of 1 Km on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
12. No in stream mining shall be allowed.
13. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
14. Established water conveyance channels should not be relocated, straightened, or modified.
15. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
16. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
17. PP shall take Socio-economic activities in the area through the Gram Panchayat.
18. EC will be valid for mine lease period subject to a ceiling of 5 years.

**3. Case No. – 2398/2015 Ms. Pratibha Singh, M/s Dilip Buildcon Ltd., Chuna Bhatti, Bhopal (MP)-462003 3175 dt. 19-01-15 Stone Quarry in an area of 4.00 ha. (2,25,000 cum/year) at Village- Ghatahri, Tehsil- Ghatahri, District-Chhatarpur (MP).**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village- Ghatahri, Tehsil- Ghatahri, District- Chhatarpur (MP) . The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the DFO.

Presentation & submissions made by the PP were discussed in the meeting. However, scrutiny of the project documents revealed that PP has not furnished the letter from Mining Officer certifying the leases within 500 meters radius around the site and khasra panchshala. Thus PP was asked to submit following:-

1. Letter from Mining Officer certifying the leases within 500 meters radius around the site.
2. Khasra panchshala.

**4. Case No. – 2399/2015 Shri Gokul Singh Mewara S/o Shri Doulat Singh Mewara, Bagoda, Tehsil-Mo. Barodia, Shajapur (MP) Sand Quarry in an area of 6.780 ha. (8,000 cum/year) at VillageTiganjpur-1, Tehsil-Gulana, District-Shajapur (MP). Applications forwarded by SEIAA to SEAC by vide letter no. 3173/SEIAA/15 dated: 19/01/2015.**

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at VillageTiganjpur-1, Tehsil-Gulana, District-Shajapur (MP) in 6.780 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 237 dated 26/02/2015, that two mine are operating / proposed within 1000 meter radius around the said area with total area is off 17.080 ha.

Based on the presentation and the submissions made by the PP committee has decided to recommend the case subject to the following special conditions:

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. It was observed during the visit to Alirajpur by the sub-committee that the banks of the tributaries have been eroded due to floods hence as special condition PP shall use the rejects and soil for plantation on these eroded banks to prevent further damages of the banks.
4. Abstraction of sand shall be as per the approved Mining Scheme but not exceeding 8,000 m<sup>3</sup> in a year and the depth of mining shall be restricted to 3m or water level, whichever is less.
5. Mining shall be carried only between 1st November to 31st May i.e. during non-monsoon period.
6. Transportation of sand shall not be carried out through forest area.
7. The mining activity shall be done manually.
8. Heavy vehicles shall not be allowed on the banks for loading of sand.
9. The sand shall be transported by small trolleys up to the main transport vehicle.
10. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
11. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone of 1 Km on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
12. No in stream mining shall be allowed.

13. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
14. Established water conveyance channels should not be relocated, straightened, or modified.
15. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.

(10,000 cum/year) at Village Paharirawat, Tehsil-Indargarh, District-Datia (MP). Applications forwarded by SEAC by SEIAA vide letter no. 3177/SEIAA/15 dated: 19/01/2015.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village Paharirawat, Tehsil-Indargarh, District-Datia (MP) in 1.40 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 38 dated 22/09/2014, that one mine is operating / proposed within 500 meter radius around the said mine with total area of 2.40 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.
6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
7. Curtaining of site shall be done using appropriate media.
8. Production of stone boulder shall be as per the mining plan not exceeding 10,000 m<sup>3</sup>/Year and maximum average depth of pits shall not exceed 6 meters.
9. The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
10. Transportation shall not be carried out through forest area.
11. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.

12. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
13. **The validity of the EC shall be** as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

**6. Case No. – 2401/2015 Shri Ankit Bairagi S/o Shri Kailash Bairagi, Village-Ummedpura, Tehsil-Javad, District-Neemuch (MP)- 458330** Stone Quarry in an area of 2.00 ha. (8,550 cum/year) at Village Aankali, Tehsil-Manasa, District-Neemuch (MP). Application forwarded by SEAC by SEIAA vide letter no. 3179/SEIAA/15 dated: 19/01/2015.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 1311/2 at Village Aankali, Tehsil-Manasa, District-Neemuch (MP) in an area of 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan. Submissions made by the PP were discussed in the meeting. The EMS submitted by the PP was found to be satisfactory and acceptable. However, scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO's certificate of 250 meters is also not submitted by the PP. Thus PP was asked to submit the letter from:- Concerned DFO's with comments on presence of scheduled animals in the area and also certificate reporting distance of project site from the forest boundary for further necessary decision in the matter.

**7. Case No. – 2402/15 Shri Ritesh Tuteja S/o Shri Ranveer Singh Tuteja, Village-Bid, Tehsil-Punasa, District-Khandwa (MP)-477116** Stone Quarry in an area of 1.20 ha. (20,000 cum/year) at VillageSivaria, Tehsil-Punasa, District-Khandwa (MP). Applications forwarded by SEAC by SEIAA vide letter no. 3181/SEIAA/15 dated: 19/01/2015.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at VillageSivaria, Tehsil-Punasa, District-Khandwa (MP) in 1.20 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 13833 dated 07/01/2014, that no mine is operating / proposed within 500 meter radius around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA

4. Transportation of material shall be done in covered vehicles.
5. Necessary consents shall be obtained from MPPCB and the air pollution control measures for crusher have to be installed as per the recommendation of MPPCB.
6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
7. Curtaining of site shall be done using appropriate media.
8. Production of stone boulder shall be as per the mining plan not exceeding 20,000 m<sup>3</sup>/Year and maximum average depth of pits shall not exceed 6 meters.
9. The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
10. Transportation shall not be carried out through forest area.
11. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.

The proposed site is located at Village- Pathara, Tehsil-Jatara, District-Tikamgarh (MP). The project requires prior EC before commencement of any activity at site. PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the DFO.

Presentation & submissions made by the PP were discussed in the meeting. However, scrutiny of the project documents revealed that PP has not furnished the letter from Mining Officer certifying the leases within 500 meters radius around the site and khasra panchshala. Thus PP was asked to submit the letter from:-

1. Mining Officer certifying the leases within 500 meters radius around the site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. N.A. dated 17/10/2014, that no mine is operating / proposed within 500

meter radius around the said mine. PP has reported that the pit formed after mining shall be developed into a water body.

Presentation & Submissions made by the PP were discussed in the meeting. The EMS submitted and presented by the PP was found to be satisfactory and acceptable. However, scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence, PP was asked to:-

1. Obtain comments of concerned DFO on the presence of scheduled animals and submit the same to SEAC.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Bandhi, Tehsil-Seoni, District-Seoni (MP) in 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. N.A. dated 22/12/2014, that 04 more mines are operating / proposed within 500 meter radius around the said mine and the total lease area is 12.312 ha. PP has reported that the pit formed after mining shall be developed into a water body.

Presentation & Submissions made by the PP were discussed in the meeting. The EMS submitted by the PP was found to be satisfactory and acceptable. Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence, PP was asked to:-

1. Obtain comments of concerned DFO on the presence of scheduled animals and submit the same to SEAC.
2. Letter from Mining Officer certifying the leases within 500 meters radius around the site.
3. Written commitment from PP to construct a protection wall for nearby water body.

**11. Case No. – 2407/2015** Shri Monu Yadav S/o Shri Rajendra Yadav, Town & Post-Shahganj, Teh-Budhni, Sehore (MP)-466445 Basalt Stone Quarry in an area of 1.460 ha. (14,250 cum/year) at Village-Panari, Tehsil-Budhni, District-Sehore (MP). Application forwarded by SEAC by SEIAA vide letter no. 3194/SEIAA/15 dated: 21/01/2015.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Panari, Tehsil-Budhni, District-Sehore (MP) in 1.460 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 8077 dated 19/12/2014, that one more mine is operating / proposed within

500 meter radius around the said mine and the total lease area is 2.953 ha. PP has reported that the pit formed after mining shall be developed into a water body.

Presentation & Submissions made by the PP were discussed in the meeting. The EMS and other submissions made by the PP were found to be satisfactory and acceptable. Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. Hence, PP was asked to:-

1. Obtain comments of concerned DFO on the presence of scheduled animals and submit the same to SEAC.

**12. Case No. – 2409/2015 Smt. Parvati Bai Borasi W/o Shri Shriram Borasi, Railway Colony, Ghaspura, Khandwa (MP)-450001 - Stone Quarry in an area of 1.60 ha. (15,000 cum/year) at Village Veerapur Kundeshwar, Tehsil-Khandwa, District-Khandwa (MP)**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village Veerapur Kundeshwar, Tehsil-Khandwa, District-Khandwa (MP) for Lease Area- 1.60 ha. The project requires prior EC before commencement of any activity at site.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

**13. Case No. – 859/2012 Shri Sanjeet Singh Keer, Keer Farms, Opp, Tapti Mills Road, Lalbagh Burhanpur Dist. Burhanpur, (M.P.) Rec. 21/01/15 Lease Area- 1.54 ha. Jainabad Metal stone Quarry Production (50,000 cubic meter per year) at Khasra No.- 234, 221/1, 233/2,3 Village Jainabad, Tehsil- Burhanpur, Distt.- Burhanpur (M.P.) (Called for the 114th, 117th, 119th & 124th dt. 13/03/13. No response from PP recd.) . Applications forwarded to SEAC by SEIAA vide letter no. 3187/SEIAA/15 dated: 19/01/2015 with mining plan.**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village Jainabad, Tehsil- Burhanpur, Distt.- Burhanpur (M.P.). The project requires prior EC before commencement of any activity at site. PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the Tehsildar & DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 32 dated 02/01/2015, that one mine is operating / proposed within 500 meter radius around the said mine and the total lease area is 3.54 ha.

Presentation & submissions made by the PP were discussed in the meeting. The maximum production capacity to be considered should be as per mining plan i.e. 30,000 cubic meters per year. The EMS and other submissions made by the PP were found to be satisfactory and acceptable. However, the PP has not furnished the details of expenditures to be incurred for the monitoring and other relevant environmental activities and thus was asked to furnish:-

1. The details of expenditures to be incurred for the monitoring and other relevant environmental activities in Environmental Management Plan.

**14. Case No. – 1144/2013 Shri Ramanjeet Singh Keer, Keer Mansion, Lalbagh Road, Burhanpur, (M.P)** Metal Stone Quarry at Khasra No- 110/1, 110/2, Village Jaisingpura, Dist- Burhanpur (M.P.)
