

The 189th meeting of the State Expert Appraisal Committee (SEAC) was held on 5th May, 2015 under the Chairmanship of Dr. R. B. Lal. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. **Case No.- - 2423/2015 Shri Vishal Kumar, 99, APR Colony, Bilhari, Jabalpur (M.P.)**
Brick Earth Quarry Lease Area – 2.60 ha., Capacity-2,000 cum/year, at Vill.-Mangeli, Th.--Jabalpur, Distt.-Jabalpur (M.P.)

This is a case of mining of soil for brick manufacturing. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *at Vill.-Mangeli, Th.--Jabalpur, Distt.-Jabalpur* in 2.60 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1729 dated 17/09/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine. PP has reported that maximum maximum production of bricks at site using the excavated soil shall be 10000 bricks per day.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended **for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:**

1. Green belt with local species of trees shall be developed all around the lease area.
2. Implementation of Fly-ash notification shall be ensured.
3. Approach road shall be periodically maintained by the lease owner / operators.
4. The production shall be as per the approved mining plan not exceeding 2000 m³ / Year and the maximum depth of the pits shall not exceed 3 meters.

2. **Case No. - 2427/2015 Shri Pawan Agrawal, Babriya Road, Barapatthar, Seoni –(M.P.)**
Murum Quarry Lease Area - 1.70 ha., Capacity-59,685 cum/year) at Vill.-Palari, Th.--Seoni, Distt.-Seoni (M.P.)

This is a case of murrum excavation. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Palari, Th.--Seoni, Distt.-Seoni (M.P.)* in 1.70 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 2387 dated 04/10/2013 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. The production shall be as per the approved mining plan not exceeding 59685 m³ / Year and the maximum depth of the pits shall not exceed 6 meters.
3. **Case No. - 2434/2015 Shri Ramlal Bhuria, Vill.-Nimrani, Th.--Kasrawad, Khargone (M.P.)- 451659 Stone Quarry Lease Area - 1.00 ha., Capacity-5,388 cum/year) at Nimrani, Th.--Kasrawad, Dist-Khargone (M.P.)**

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Nimrani, Th.--Kasrawad, Dist-Khargone (M.P.) in 1.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 1136 dated 10/12/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine. It was observed that although the Mining Plan has been approved for Murrum as well as for stone mining but mining of only stone boulder is proposed by the PP. Tehsildar has reported a school within 500 meters from the project boundary, however PP has denied the same during the presentation. After deliberations committee asked the PP to submit exact distance of the nearest school and habitation from the project boundary duly certified from the Tehsildar.

4. **Case No. - 2435/15 Smt. Mahadevi Yadav W/o Shri Atwal Singh Yadav, Vill.-Laxmanpura, Datia (M.P.)-475661 Stone Quarry Lease Area - 4.00 ha., Capacity-45,000 cum/year) at Vill.-Tatarpur, Th.--Bhandar, Dist-Datia (M.P.)**

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

5. **Case No. - 2436/15 Shri Ramanjeet Singh Keer S/o Shri Satindar Singh Keer, Lalbaag Road, Burhanpur (M.P.)-450331 Stone Quarry Lease Area - 2.030 ha., Capacity-19,380 cum/year) at Vill.-Bada Jainabad, Th.--Nepanagar, Dist-Burhanpur (M.P.)**

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.-Bada Jainabad, Th.--Nepanagar, Dist-Burhanpur (M.P.) in 2.030 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 34 dated 02/01/2015 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. The production shall be as per the approved mining plan not exceeding 19380 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

6. Case No.- - 2438/2015 Shri Vinod Yadav, Neem Dauda House, Kampu, Gwalior (M.P.)-474003 Flag Stone Quarry Lease Area - 4.983 ha., Capacity-9,000 cum/year) at Vill.-Jakhauda, Th.-Chatigaon, Dist-Gwalior (M.P.)

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.-Bada Jainabad, Th.--Nepanagar, Dist-Burhanpur (M.P.) in 2.030 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 2694 dated 07/11/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Scrutiny of the Mining Plan reveals the presence of scheduled animals near the site. DFO has not commented on the issue. Hence PP was asked to obtain a clarification on this issue from concerned forest officer and submit the same at the earliest.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Kolmuhi, Th.--Kundam, Dist-Jabalpur (M.P.)* in 2.590 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 2405 dated 23/12/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended **for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:**

1. The production shall be as per the approved mining plan not exceeding 20000 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

9. Case No. - 2441/15 Smt. Meera Shivhare W/o Shri Mangilal Shivhare, Vill.-Raipura, Th.- & Distt.-Sheopur (M.P.)-476337 Soil Quarry Lease Area - 1.379 ha., Capacity-3,931 cum/year) at Vill.-Raipura, Th.--Sheopur, Dist-Sheopur (M.P.)

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Raipura, Th.--Sheopur, Dist-Sheopur (M.P.)* in 1.379 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 6851 dated 25/09/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Scrutiny of the Mining Plan reveal discrepancy in the topography of the area presented in the meeting and that mentioned in the Mining Plan. Hence PP was asked to submit the factual data duly approved by the Mining Department.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 2380 dated 17/11/2012 has reported that 10 more mines are operating / proposed within 500 meters around the said mine and the total lease area is 10 Ha.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Crusher shall not be allowed in the lease area.
2. The production shall be as per the approved mining plan not exceeding 8000 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

12. Case No. - 2462/2015 Shri Jaspal Singh S/o Shri Bherulal Anjana, Gram-Karju, Teh-Daloda, Distt.-Mandsaur (M.P.) -458339 Basalt Stone Quarry Lease Area- 2.00 ha., at Vill.-Katlaar,Th.-Daloda, Distt-Mandsaur (M.P.) Capacity -11,400 Cum/Year.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Katlaar,Th.-Daloda, Distt-Mandsaur (M.P.)* in 2.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

14. This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No.-Part of 155 at Vill.-Sali, Th.-- Gandhwani,Distt-Dhar(M.P.)* in 2.00 ha. The project requires prior EC before commencement of any activity at site. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 10308 dated 09/12/2014 has reported that no mine is operating / proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Crusher shall not be allowed in the lease area.
2. The production shall be as per the approved mining plan not exceeding 18773 m³ / Year of stone and 4332 m³ / Year of Murram and the maximum depth of the pits shall be as per the approved mining plan.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 895 dated 29/12/2014 has reported 02 more mines operating / proposed within 500 meters around the said mine and the total lease area is 3.40 Ha.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. A barrier zone of 7.5 meters shall be left all around the lease area.
4. The production shall be as per the approved mining plan not exceeding 12150 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

16. Case No.- 2495/2015 Shri Kamran Khan S/o Shri Iqbal Hussain, Town-Dharampuri, Dhar (M.P.) -454449 Basalt Stone Quarry Lease Area - 4.00 ha., Capacity- 28,500cum/year at Vill.- Nimola, Th.--Dharampuri, Dist-Dhar (M.P.)

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No.-779/2, Vill.- Padhariya, Th.- & Distt-Sagar (M.P.)* in 1.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and the Range Officer. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 609 dated 10/04/2015 has reported that no mine is operating / proposed within 500 meters around the said mine.

Scrutiny of the documents reveals that the information pertaining to forest department has been given by the Range Officer, PP was asked to submit the same after due verification from the concerned DFO.

17. Case No.- 2498/2015 Shri Ranjeet Singh Rathore, Vill.-Sarangi, Th.--Petlawad, Jhabua (M.P.) -458226 Sand Quarry Lease Area - 4.00 ha., Capacity- 17,527cum/year at Vill.-Garwara, Th.--Petlawad, Dist-Jhabua(M.P.)

This is a case of mining of sand. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located on river Mahi, at *Khasra No.-01 Vill.-Garwara, Th.--Petlawad, Dist-Jhabua(M.P.)* in 4.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 383 dated 27/10/2014 that no mine is operating / proposed within 1000 meter radius around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining

- department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
 3. Plantation shall be carried out on the banks for stabilization of the banks.
 4. Abstraction of sand shall be as per the approved Mining Scheme but not exceeding 17527 m³ in a year and the depth of mining shall be restricted to 3m or water level, whichever is less.
 5. Mining shall be carried only between 1st October to 31st May i.e. during non-monsoon period.
 6. Transportation of sand shall not be carried out through forest area.
 7. The mining activity shall be done manually.
 8. Heavy vehicles shall not be allowed on the banks for loading of sand.
 9. The sand shall be transported by small trolleys up to the main transport vehicle.
 10. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
 11. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone of 1 Km on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
 12. No in stream mining shall be allowed.
 13. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
 14. Established water conveyance channels should not be relocated, straightened, or modified.
 15. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
 16. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
 17. PP shall take Socio-economic activities in the region through the Gram Panchayat.
 18. EC will be valid for mine lease period subject to a ceiling of 5 years.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Babracha, Th.--Kasrawad, Dist-Khargone (M.P.)* in 1.70 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide

letter no. 1208 dated 01/01/2015 has reported that there is no mine operating / proposed within 500 meters around the said mine. After deliberations PP was asked to submit response on following issues:

- Scrutiny of the Mining Plan reveals the presence of scheduled animals near the site. DFO has not commented on the issue. Hence PP was asked to obtain a clarification on this issue from concerned forest officer and submit the same at the earliest.
- EMP cost appears on lower side hence to be enhanced and submitted activity-wise budget for EMP.

- EMP cost appears on lower side hence to be enhanced and submitted activity-wise budget for EMP.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. nil dated 16/12/2014 has reported that no mine is operating / proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. The production shall be as per the approved mining plan not exceeding 22655 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Kheda, Th.--Dhar,Dist-Dhar (M.P.)* in 4.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 10352 dated 18/12/2014 has reported that 07 more mines are operating / proposed within 500 meters around the said mine and the total lease area is 23 Ha.

The site has been visited by a sub-committee of SEAC and following were the observations:

- Water body ó No water body was observed within 1 Km area around the project site.
- Nearest Habitation ó The nearest habitation is village ó Kheda at about 1 Km from the project boundary.
- Forest ó The area is devoid of forest

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. The production shall be as per the approved mining plan not exceeding 31373 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Lakhanpura, Th.-- Dabra, Dist-Gwalior (M.P.)* in 2.320 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 17 dated 23/09/2014 has reported that 04 more mines are operating / proposed within 500 meters around the said mine and the total lease area is 13.26 Ha. The site is reported to be elevated (maximum height is about 20 meters).

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Crusher shall not be allowed in the lease area.
2. Roads proposed to be used for evacuation shall be developed and maintained by the mine operator
3. In view of elevation the production shall be as per the approved mining plan not exceeding 80000 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

23. Case No.- 2518/2015 Smt. Anuradha Singh W/o Shri Ravindra Singh Yadav, 240/4, A Civil Line-11, Jhansi (UP)-284001 Stone Quarry Lease Area -1.60 ha., Capacity- 18,000 cum/year at Vill.-Salon-A, Th.--Bhander, Dist-Datia (M.P.)

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.- Jamunia Viran, Th.-- Goharganj, Dist-Raisen (M.P.) in 2.024 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 54 dated 20/01/2015 has reported that no mine is operating / proposed within 500 meters around the said mine. It is reported by the DFO that the site is within 10 Km from the notified PA the Ratapani Abhyaran hence PP is required to obtain comments from the Chief Wild Life Warden of M.P. in prescribed format of MoEF & CC and furnish the same within 01 month for further necessary action in the matter.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.-Ghughari, Th.--Ghughari, Dist-Mandla (M.P.) in 1.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Concerned Mining Officer vide letter no. 28 dated 08/01/2015 has reported that no mine is operating / proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Roads proposed to be used for evacuation shall be developed and maintained by the mine operator
2. The production shall be as per the approved mining plan not exceeding 3929 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

26. Case No.- 2522/2015 Shri Jasvinder Pal Singh S/o Shri Inder Singh, Sukhnam Villa, City Centre, Gwalior (M.P.) -475001 Thanra Stone Quarry Lease Area - 1.67 ha., . Capacity- 42,459 cum/year at Vill.-Thanra, Th.--Karera, Dist-Shivpuri (M.P.)

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Vill.-Thanra, Th.--Karera, Dist-Shivpuri (M.P.)* in 1.67 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Concerned Mining Officer vide letter no. 93 dated 31/01/2015 has reported that no mine is operating / proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Roads proposed to be used for evacuation shall be developed and maintained by the mine operator
2. The production shall be as per the approved mining plan not exceeding 42459 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.
