

The 190th meeting of the State Expert Appraisal Committee (SEAC) was held on 6th May, 2015 under the Chairmanship of Dr. R. B. Lal. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. **Case No.- 2523/2015** Shri Ashok Soni S/o Shri Ramchandra Soni, Prop., M/s Jai Ambe Construction, Kanad, Th.- & Distt.- Agar Malwa (M.P.) Stone / Boulder Quarry Lease Area - 3.500 ha., Capacity- 28,500 cum/year at Vill.-Agar, Th.--Agar Malwa, Dist- Agar Malwa (M.P.)

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.-Agar, Th.--Agar Malwa, Dist- Agar Malwa (M.P.) in 3.500 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 467 dated 08/09/2014 has reported that there are 02 more mines operating / proposed within 500 meters around the said mine and total lease area is 4.93 Ha.

Scrutiny of the Mining Plan reveals the presence of scheduled animals near the site. DFO has not commented on the issue. Hence PP was asked to obtain a clarification on this issue from concerned forest officer and submit the same at the earliest.

This is a case of mining of stone. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Vill.-Kui, Th.--Pushprajgarh, Dist-Anuppur (M.P.) in 1.133 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed which shall be developed into a water body. Concerned Mining Officer vide letter no. 272 dated 07/03/2014 has reported that there is no mine operating or proposed within 500 meters around the said mine. Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. CSR budget as proposed shall be Rs 50000 per year and cost of EMP shall be Rs 60000 / Year.
 2. Appropriate evacuation plan shall be observed such that the village roads are not damaged and transportation of material does not disturb the habitants of the region. The approach road shall be periodically maintained by the lease owner / operators.
 3. The production shall be as per the approved mining plan not exceeding 7501 m³ / Year and the average depth of the pits shall not exceed 6 meters and the maximum depth of the pits shall be as per the approved mining plan.

This is a case of mining of sand. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located on river Kshiprai, at Vill.-Pipliyabheem, Th.--Mahidpur, Dist-Ujjain (M.P.) in 6.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP was asked to submit a copy of letter from the concerned Mining Officer certifying the total no. of mines operating within 1000 meters from periphery of the proposed mine and their total lease area.

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra no.- 07,Vill.-Khargone, Th.--Khargone, Dist-Khargone (M.P.)* in 1.384 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Concerned Mining Officer vide letter no. 1227 dated 13/01/2015 has reported that there is 01 more mine operating / proposed within 500 meters around the said mine and total lease area is 3.384 Ha.

Scrutiny of the Mining Plan reveals the presence of scheduled animals near the site. DFO has not commented on the issue. Hence PP was asked to obtain a clarification on this issue from concerned forest officer and submit the same at the earliest.

This is a case of mining of stone. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra no.-219/2,Vill.-Karoundi, Th.--Bandhavgarh, Dist-Umaria(M.P.)* in 1.133 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 174 dated 19/01/2015 has reported that there is no mine operating or proposed within 500 meters around the said mine.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. Retention-wall to be constructed on the boundary towards the nallah.
2. The production shall be as per the approved mining plan not exceeding 8700 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.

8. Case No.- 2542/2015 Shri Atul Goldal S/o Shri Kuldeep Goldal, 12, Metro Plaza, Bittal Market, Bhopal (M.P.)-462011 River Sand Mine Lease Area - 5.00 ha., Capacity- 1,42,500 cum/year at Khasra no.- 167, Vill.-Rohaniya, Th.--Sohagpur, Dist-Shahdol (M.P.)

This is a case of mining of sand. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located on river Mahi, at *Khasra no.- 167, Vill.-Rohaniya, Th.--Sohagpur, Dist-Shahdol (M.P.)* in 5.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 232 dated 02/03/2015 that one more mine is operating / proposed within 1000 meter radius around the said mine and the total lease area is 10 Ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. Plantation shall be carried out on the banks for stabilization of the banks.
4. Abstraction of sand shall be as per the approved Mining Scheme but not exceeding 142500 m³ in a year and the depth of mining shall be restricted to 3m or water level, whichever is less.
5. Mining shall be carried only between 1st October to 31st May i.e. during non-monsoon period.
6. Transportation of sand shall not be carried out through forest area.
7. The mining activity shall be done manually.
8. Heavy vehicles shall not be allowed on the banks for loading of sand.
9. The sand shall be transported by small trolleys up to the main transport vehicle.
10. Transport vehicles will be covered with tarpauline to minimize dust/sand particle emissions.

11. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone of 1 Km on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
12. No in stream mining shall be allowed.
13. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
14. Established water conveyance channels should not be relocated, straightened, or modified.
15. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
16. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
17. PP shall take Socio-economic activities in the region through the Gram Panchayat.
18. EC will be valid for mine lease period subject to a ceiling of 5 years.

This is a case of mining of stone. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra no.-125/2,Vill.-Karami, Th.--Mada, Dist-Singrauli (M.P.)* in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed shall be back-filled with the waste and OB. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 160 dated 24/01/2015 has reported that there is 02 more mines are operating/ proposed within 500 meters around the said mine and the total lease area is 4.29 Ha.

Submissions made by the PP were found to be satisfactory and acceptable. Thus, based on the submissions made by the PP the case was recommended for grant of prior EC subject to the standard conditions laid for similar cases with following additional conditions:

1. OB and waste shall be used for land reclamation through back-filling and OB shall not be allowed to sale.
2. The production shall be as per the approved mining plan not exceeding 16598 m³ / Year and the maximum depth of the pits shall be as per the approved mining plan.
