

The 194th meeting of the State Expert Appraisal Committee (SEAC) was held on 31st May, 2015 under the Chairmanship of Dr. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

- 1. Case No. - 2419/2015 Shri Ganesh Patidar S/o Shri Madan Lal Patidar, Patidar Niwas, Vill.-Jamli, Th.--Mhow, Indore (M.P.)-453441 Stone Quarry Lease Area - 3.250 ha., Capacity-75,000 cum/year) at Vill.-Jamli, Th.--Mhow, Distt.-Indore (M.P.)**

This is a case of mining of Stone Boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-54, 55, 48/2, 56/1, 48/3, 56/2, 51/2, 48/1, 52, Vill.-Jamli, Th.--Mhow, Distt.-Indore (M.P.) in 3.250 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. It was not clear whether the crusher is proposed or not in the lease area. Concerned Mining Officer vide letter no.-316 dated -26-03-15 has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total lease area is 4.650 ha.

Scrutiny of the case reveals several discrepancies in the Mining Plan; the location of site, roads, mined out area etc do not match the geographical details when observed through Google image. It was concluded by the committee that the project can not be appraised on the basis of the information furnished by the PP in the Mining Plan it was therefore decided to refer the case back to SEIAA for rejection.

This is a case of mining of Stone. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-814/2, Vill.-Bhilwaria, Th.--Shajapur, Distt.-Shajapur in 1.40 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. PP has reported that the dipressions formed after mining shall be leveled and the area shall be used for storing the green / burnt bricks. The application was forwarded by SEIAA for scoping so as to determine TOR to carry out EIA / EMP for the project.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP.
