

The 213th meeting of the State Expert Appraisal Committee (SEAC) was held on 8th August, 2015 under the Chairmanship of Shri K.P. Nyati for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

In view of the Directions passed by the Hon, able NGT in the Review Application No. 18 of 2015 dated 24/07/2015, followed by the directions of SEIAA, the meetings of State Expert Appraisal Committee were scheduled from 7th to 11th August 2015 exclusively for the sand mining projects of M.P. State Mining Corporation. Initial scrutiny of the applications revealed that most of these applications are incomplete in respect of mandatory documents. The same was intimated to the concerned OICs by SEIAA as well as SEAC. After fixing the dates for SEAC meetings the project proponents were requested to furnish the requisite documents during meeting.

In meeting it was informed by the representatives of the Mining Corporation that mandatory documents required for appraisal of various projects is available only for a very few projects and procurement of necessary documents / certificates for most of the projects shall still require some time. Committee decided to appraise those projects where needed information was available, hence the 05 days meetings were re-scheduled only for two days. Accordingly, the 212th meeting was conducted on 07/08/2015 and the 213th meeting on 08/08/2015.

State Mining Corporation Ltd., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (M.P.)-461001 Divlakhedi River Sand Mine Lease Area - 12.145 Ha., Capacity - , Capacity - 1,10,000 cum/year, at Vill.- Divlakhedi, Teh.-Hoshangabad, District- Hoshangabad (M.P.)

The project pertains to sand mining. It was observed that the project is part of a big cluster. Mining Officer vide letter no. 2638 dated 03/07/2015 has reported that there are 05 more mines operating / proposed within 1000 meters from the periphery of the project boundary. The cumulative lease area of these mines is 96.21 Ha. Beside this a lease area of 116.760 Ha is adjoining to this cluster which is yet not allocated for sand mining to the contractors. Thus committee suggested the PP to apply for EC incorporating all the proposed projects however, applications for each project shall be made separately. It was decided by the committee to return the case to SEIAA.

The mining Plan and the EMP for each of the projects in the cluster should address the points suggested by the committee in other sand mining projects.

Mining Officer vide letter no. 654 dated 01/05/2015 has reported that there are 05 more mine operating or proposed within 1000 meters from the periphery of the project boundary. The case was deferred on request of PP, as the Mining Plan has to be revised. PP shall submit fresh application along with all the essential information and supporting documents. It was decided by the committee to return the case to SEIAA.

The project along with the project mentioned as case no. 3354 are located on the downstream of Indira Sagar Dam and these site always remain in water due to backwaters of the dam. Mining activities may not be feasible at these sites. Based on the above facts the cases were recommended for rejection.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
5. Curtaining of site shall be done using appropriate media.
6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
7. Transportation shall not be carried out through forest area.
8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
10. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

Annexure- 'B'

Standard conditions applicable for the sand Mine Quarries

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. Plantation shall be carried out on the banks for stabilization of the banks.
4. The mining activity shall be done manually.
5. Heavy vehicles shall not be allowed on the banks for loading of sand.
6. The sand shall be transported by small trolleys up to the main transport vehicle.
7. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
9. No Mining shall be carried out during Monsoon season.
10. The depth of mining shall be restricted to 3m or water level, whichever is less.
11. No in-stream mining shall be allowed.
12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
13. Established water conveyance channels should not be relocated, straightened, or modified.
14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
16. PP shall take Socio-economic activities in the region through the Gram Panchayat
17. EC will be valid for mine lease period subject to a ceiling of 5 years.
