

The 215<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC) was held on 21<sup>st</sup> August, 2015 under the Chairmanship of Dr R.B. The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

- 1. Case No. – 2682/2015 Shri Ramakant Dangi S/o Shri Kailash Narayan Dangi, Village-Salon-A, Tehsil-Bhander, District-Datia (M.P.)** Bharroli Stone Quarry Lease Area-2.00 ha. Capacity - 30,000 cum/year, at Village-Bharroli, Tehsil-Bhander, District-Datia (M.P.)

This is a case of Bharroli Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.153, at Village-Bharroli, Tehsil-Bhander, District-Datia (M.P.) **2.00 ha**. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-445, dated: 31/12/14, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine, and Total area -3.00 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of stone boulder shall be as per the approved mining plan not exceeding 30000 cum / Year.

This is a case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-2206/1/2, Village-Datia Gird, Tehsil-Datia, District-Datia (MP) **4.00 ha**. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-41, dated: 20/2/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine, and Total area -7.00 ha.

PP wished to withdraw the case in order to submit a revised application. Committee accepted the request of PP and decided to return the case to SEIAA for delisting the same.

This is a case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at at Khasra No.-80/3, Village-Pachara, Tehsil-Datia (Baroni), District-Datia (MP) **2.00 ha**. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-80, dated: 20/3/15, has reported that there is 16 more mines operating or proposed within 500 meters around the said mine, and Total area -**40.850** ha including the proposed mine. The mine is located in a cluster of 16 mines with cumulative lease area of 40.850 Ha hence PP was asked to carry out a comprehensive EIA for the region and prepare a common EMP for the cluster as well as separate EMP for each of the mine. Accordingly standard TOR prescribed by the MoEF & CC was approved for the project to carry out EIA / EMP.

This is a case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-80/3, Village-Pachara, Tehsil-Datia, District-Datia (MP) 1.070 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 79, dated: 20/3/15, has reported that there are 17 more mines operating or proposed within 500 meters around the said mine and Total area-**42.780** ha including the proposed mine.

The mine is located in a cluster of 18 mines with cumulative lease area of 42.780 Ha hence PP was asked to carry out a comprehensive EIA for the region and prepare a common EMP for the cluster as well as separate EMP for each of the mine. Accordingly standard TOR prescribed by the MoEF & CC was approved for the project to carry out EIA / EMP.

This is a case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located, at Khasra No. ó 50, Mawai Ghat, Gaurihar, Chhatarpur (MP)- - 3.383 **ha**. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-715, dated-26/6/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

This is not the case of river sand mining. Sand deposited in agriculture field during floods shall be evacuated. The estimated sand deposit is 57600 m<sup>3</sup>. Temporary permit for 06 months has been issued for sand evacuation.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

- One time sand evacuation of 57600 m<sup>3</sup> shall carried out.
- No mining below the ground level shall be allowed.
- Appropriate measures shall be taken up to avoid air pollution from loading, transportation and other allied activities.
- EC shall be valid only for two years as temporary permit has been issued for two years only.

This is a case of Badodiya River Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 6 136, Village-Badodiya, Tehsil-Jaora, District-Ratlam 6.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 449, dated: 20/3/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

1. Production of sand shall be as per the approved mining plan not exceeding 3000 cum / Year.

This is a case of Basalt Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located, at Khasra No.- 112/1, 117, Village-Bandol, Tehsil-Seoni, District-Seoni (MP) 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar

and DFO. Concerned Mining Officer vide letter no-644, dated-27/3/15 , has reported that there is 05 more mines operating or proposed within 500 meters around the said mine and Total Area-10.50ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no-1519, dated-15/11/15 , has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of stone boulder shall be as per the approved mining plan not exceeding 5700 cum / Year.
2. River Son is reported to be at 300 meters from the project site hence appropriate dense tree plantation and barricading shall be carried out towards the lease area boundary facing river.

This is a case of Nayapura River Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at River Son at Khasra No.- 1, Village-Nayapura, Tehsil-Jaora, District-Ratlam (MP) 6.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 450, dated: 20/3/15 , has reported that there is no more mines operating or proposed within 1000 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -B

1. Production of sand shall be as per the approved mining plan not exceeding 3000 cum / Year.

This is a case of Gondi Shankar River Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at River Chambal, Khasra No.- 701, Village-Gondi Shankar, Tehsil-Jaora, District-Ratlam (MP) 10.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 451, dated: 20/3/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

1. Production of sand shall be as per the approved mining plan not exceeding 5000 cum / Year.
2. The site is on the downstream of the dam at about 400 meters, thus the sand excavation shall be carried only when the downstream is dry.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 454, dated: 20/3/15, has reported that there are 01 more mines operating or proposed within 1000 meters around the said mine and Total area-**21.780** ha.

The sand quarry is reported to be at river a tributary of river Chambal. However, name of water body from where the sand mining is proposed is not reflected from the Mining Plan, PFR or EMP. Hence PP was asked to submit authenticated information in this context. The case shall be considered only after receipt of requisite information.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer has reported that there is no more mines operating or proposed within 500 meters around the said mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

Accordingly the case may be returned to SEIAA.

Concerned Mining Officer vide letter no.-85, dated: 15/1/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

Scrutiny of the project and the presentation made by the PP reveals that the size and shape of the lease area do not support environmentally sustainable mining hence committee decided to recommend rejection of the project. Accordingly the case may be returned to SEIAA for further necessary action.

**25. Case No. – 3105/2015** Smt. Sangeeta Tiwari W/o Shri Chandrashekhar Tiwari, Near Seoni Railway Station, Seoni (M.P.)-480661 Metal Stone Quarry Lease Area - 2.00 Capacity - 11,400 cum/year, at Village-Gangerua, Tehsil-Seoni, District-Seoni (M.P.)

This is a case of Metal Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located, at Khasra No. 342, at Village-Gangerua, Tehsil-Seoni, District-Seoni (M.P.)2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2926, dated: 29/12/14, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

Scrutiny of the Mining Plan revealed that the provision of 7.5 meter buffer zone has not been made in the plan. Hence PP was asked submit revised mining plan with requisite provision.
