

**STATE EXPERT APPRAISAL COMMITTEE  
MINUTES OF 216<sup>th</sup> MEETING**

**22/08/2015**

The 216th meeting of the State Expert Appraisal Committee (SEAC) was held on 22ed August, 2015 under the Chairmanship of Dr. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

- 1. Case No. – 3120/2015 Mr. Sanjeev Agrawal, Mr. Sanjeev Agrawal, CMD, M/s Ayush Enterprises, Sagar Plaza, 250, Zone-2, M.P. Nagar, Bhopal (MP)-462016 Prior Environment Clearance for approval of proposed Construction of Group Housing Project "Sagar Eden Garden" at Village-Bawadiya Kalan, Tehsil-Huzur, District-Bhopal (MP) (Incomplete Form-1 submitted)**

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is case of Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 312, 313/2 at Village-Sawajpani, Tehsil-Pandhurna, District-Chhindwara (M.P.) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 2880 dated: 8/12/2014, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

Scrutiny and the presentation made by the PP revealed that it is an existing mine which has already been excavated but this fact has not been depicted on the concerned surface map attached with the mine plan. Further all co-ordinates of mining lease area are not provided in mine plan to verify its location.

In view of above lacking, the appraisal is not possible in the present from of mine plan. Thus above case is returned to SEIAA and PP may be asked to get the mine plan revised addressing all the components of MM Rules, 1996.

This is case of Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 158/3 at Village-Ashapura, Tehsil-Mhow, District-Indore (M.P.) 1.623 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 75 dated: 19/1/2015, has reported that there is 06 more mines operating or proposed within 500 meters around the said mine and total area 12.256 Ha. including area of this mine.

Scrutiny and the presentation made by the PP revealed that it is an existing mine reported to be in operation since last five years and has already been excavated but this fact has not been depicted on the concerned surface map attached with the mine plan. Further all co-ordinates of mining lease area are not provided in mine plan to verify its location.

In view of above lacking, the appraisal is not possible in the present from of mine plan. Thus above case is returned to SEIAA and PP may be asked to get the mine plan revised addressing all the components of MM Rules, 1996.

This is case of Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 289/1/1, 289/1/2 at Village-Badgonda, Tehsil-Mhow, District-Indore (M.P.) 1.700 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 101 dated: 28/1/2015, has reported that there is 08 more mines operating or proposed within 500 meters around the said mine and total area 6.756 Ha including area this mine.

Scrutiny and the presentation made by the PP revealed that it is an existing mine which has already been excavated since last five years but this fact has not been depicted on the concerned surface map attached with the mine plan. Further Scrutiny of the documents revealed that the co-ordinates of the lease area have not been given in the Mining Plan. Thus it was not possible to ascertain the exact location

In view of above lacking, the appraisal is not possible in the present from of mine plan. Thus above case is returned to SEIAA and PP may be asked to get the mine plan revised addressing all the components of MM Rules, 1996.

2. 7.5 meter safety buffer zone is not left in surface map/conceptual plan.
3. Land use area after mining is more than the allotted area.

In view of above lacking, the appraisal is not possible in the present form of mine plan. Thus above case is returned to SEIAA and PP may be asked to get the mine plan revised addressing all the components of MM Rules.
